Recommendation:

Staff recommends **DENIAL**, as the proposed use is not consistent with the residential nature of the surrounding properties.

However is the Commission chooses to approve this request, staff recommends the following conditions:

1. A minimum of one parking space per resident and staff member shall be provided on-site and maintained on the property for the duration of the use. All parking shall meet all applicable UDC standards.
2. No variances or development exceptions are granted as part of this request that are not explicitly granted by Board approval. The development shall be compliant with the Unified Development Code of Hall County.
3. All conditions of zoning shall be made a part of any plats or construction plans created for the property.
