#### Purpose of Request:

Approve the FY 2026 award of the Criminal Justice Coordinating Council's (CJCC) Residential Substance Abuse Treatment (RSAT) Program Grant for the Correctional Institute's treatment program in the amount of \$37,333.00, and appoint the Grants Manager as the Program Designee and authorize the Chairman to execute all related application and award documents. An in-kind match of 25% will be required.

#### History:

This grant through CJCC has been renewed for the last eight (8) years and is an important part of the REACT re-entry program.

CJCC handles any grant application for the County. The County just has the opportunity to accept the award for the RSAT Program from funds that are made available.

#### Facts and Issues:

The goal of the RSAT program is to break the cycle of drugs and violence by reducing the demand for, use, and trafficking of illegal drugs. RSAT enhances the capabilities of states and units of local governments to provide residential substance use disorder treatment for incarcerated individuals, and prepares individuals for their reintegration into the communities from which they came by incorporating reentry planning activities into treatment programs.
