Purpose of Request: Approve the ratification of the application, award, and any further supplemental funding for the Criminal Justice Coordinating Council's (CJCC) FY 2027 Juvenile Justice Incentive Grant for Hall County Juvenile Court for \$557,845.00, and appoint the Grants Manager as the Program Designee and authorize the Chairman to execute all related application and award documents. History: Hall County has received Juvenile Justice Grant funding from CJCC since 2014.

Facts and Issues: This funding will be used for Multi-Systemic Therapy (MST) and Family Functional Therapy (FFT) services to youth and families in Hall County. Families that identify a need for family counseling will be referred to MST for services by the Court. In the event a youth is exhibiting a need for individual counseling, he/she will be referred to FFT. All of the services will be conducted through a contractor and will be monitored.
