Despite having a well-established and effective Accountability Court program in Hall County, there is a critical gap in the capacity to deliver veteran-specific, trauma-informed treatment at the level required for this high-need population.

This BJA funding will close this gap by adding dedicated clinical capacity and specialized training that the jurisdiction cannot finance on its own, ensuring that these veterans receive the treatment needed to improve outcomes and reduce recidivism.

With this new grant application request, Treatment Services is requesting a new full-time counselor position be funded.
