Approve the renewal of the annual contract for RFQ/P# 43-004 Sewer System Operations Service for Public Works & Utilities to ClearWater Solutions, LLC of Auburn, AL. The estimated annual cost is \$1,250,868.00.

History:

ClearWater Solutions, LLC is the current contract holder and is a vendor in good standing with the County.

Facts and Issues:

This is year five (5) of a five (5) year contract. As part of the contract, Clearwater will perform a service to rate the condition and inventory of the County's existing sewer lines over the five-year contract period.

This includes the cost for Repairs and Maintenance and Chemicals needed to operate the plant and the approx 25+ county maintained liftstations.

Previously FY 2026 total approval for Clearwater is \$1,229,959 and this contract renewal represents a 1.7% increase.
