Purpose of Request:

Approve the renewal of the annual contract for IFB #010-46 Uniform Supply for the Sheriff's Office to Uniforms Unlimited of Athens, GA, Strongpoint, LLC of Gainesville, GA, Federal Eastern International, LLC of Jacksonville, FL, Smyrna Police Distributors of Smyrna, GA, and T & T Uniforms, Inc. of Austell, GA. The estimated annual cost is \$268,202.00.

History:

All vendors are in good standing with the County and have serviced the County well over many years.

Facts and Issues:

Options:

This is year two (2) of a possible five (5) year contract.

Federal Eastern requested a twelve percent (12%) increase on one item which has been reviewed and approved by the Sheriff's Department.

T & T has requested a three percent (3%) increase for FY2027. These prices were also reviewed and approved by the Sheriff's Department.

Smyrna Police Distributors has requested price increases on many of their offered items ranging from two percent (2%) to twenty-six (26%), which averages twenty percent (20%) increase. The largest increase will be for the BLAUER uniform items which are the preferred uniforms for the Sheriff's Department. Only a few distributors are permitted to sell these items per the manufacturer. Even with the higher percentage of increase they are still the low-cost provider for these uniforms. The Sheriff's Department has reviewed and approved of these cost increases as well. All spreadsheets for price increases are included for further information.

Strongpoint and Uniforms Unlimited will hold their pricing for FY 2027.
