#### Purpose of Request:

#### History:

This initiative was brought forward and approved by the Hall County Parks & Leisure Services Advisory Board. Proposal was approved, 5-0, at the Board's May 18 meeting.

Parks staff has conducted due diligence regarding operational updates and costs, and supports approval.

#### Facts and Issues:

Estimated revenue loss attributable to passes and memberships for under-18 users is \$15,000 annually.

Parks staff are seeking sponsorships to offset the loss.
