Purpose of Request:

GDOT has requested Hall County execution of a traffic signal permit application to install a a Pedestrian Hybrid Beacon on Thompson Bridge Rd. (SR 60) in front fo the Fieldale Poultry Plant near the intersection of Thompson Bridge Rd. (SR 60) and Hubert Stevens Rd.

This project will not utilize any Hall County Funds for the installation; however, Hall County will be responsible for the monthly power cost estimated at \$100/month.

History:

GDOT and its consultant, Kimley-Horn and Associates, completed a Pedestrian Crossing Study to identify and evaluate pedestrian crossing tratments to improve safety for vulnerable road users. Based on study results, a pedestrian hybrid beacon was recommended as the preferred pedestrian crossing treatment at this location (study attached).

GDOT would be responsible for the installation, costs of this project, and ongoing maintenance. Hall County will be responsible for the monthly power cost estimated at \$100/month.
