SCAAP is a federal reimbursement program administered by the Bureau of Justice Assistance (BJA) within the Office of Justice Programs (OJP) of the U.S. Department of Justice (DOJ). The program provides reimbursement to state and local correctional agencies for a portion of the costs associated with incarcerating certain undocumented criminal aliens during the reporting period of July 1, 2023- June 30, 2024.
