To the Hall County Board of Commissioners,

My name is Elijah Adams and I am writing to respectfully oppose the proposed variance for a 2 lot subdivision and reduced road frontage at 5771 F. Gilmer Road.

I live at 5780 F Gilmer Rd, which sits across the road from the proposed variance. Me and my family have lived on this property for over 30 years and I plan to raise a family of my own here in the future. We have lived here so long because of the natural, peaceful and secluded environment that surrounds us. If this proposed subdivision is approved then our small, quiet community will permanently be destroyed and my future family will not get to experience and explore the natural and peaceful outdoors like I had the pleasure to do.

One major concern that I have is our natural water supply. All the current homes on F. Gilmer road are supplied with natural well water. As is we are already having problems with our wells running dry and being filled with sediment. I fear that adding another well to this proposed property will only make the issue worse not just for me but for all the other residents in the area.

I am also concerned about the increased traffic and noise that this new lot could bring to the area. Our road is already suffering from increased traffic, speeding and noise pollution from people cutting through to the connected highways and I fear adding a new lot and driveway will only make these issues worse. Increased traffic can pose as a safety hazard and create more noise which negatively affects our ability to sleep and enjoy our current quiet surroundings.

Additionally, I am concerned about the damage this could cause to my property and the road due to erosion/runoff. Since F. Gilmer Rd is a dirt road it already has erosion issue every time it rains and I fear that cutting a new driveway across from mine will cause this to get even worse which will negatively impact my property and its value.

Lastly, all other properties on F. Gilmer Rd are zoned as single family lots with just 1 home. These zoning restrictions are in place for a reason and I fear that allowing one person to alter these restrictions will lead to others trying to do the same and further worsen the issue previously mentioned.

After living here for over 30 years, I care deeply and am trying desperately to help preserve the beauty, peace and character of my community and protect the standards that have kept it this way for so many years. For the concerns that I have stated, I am respectfully asking the Hall County Board of Commissioners to deny the requested variance.
