Approve the ratification for the emergency procurement of roadway repairs for a section of Falcon Crest Drive for Public Works & Utilities to E.R. Snell Contractor, Inc. of Snellville, GA, in the amount of \$869,340.00.

Facts and Issues:

Options:

On July 24, 2026, Hall County experienced a 200-year flood event that washed out a section of 4240 Falcon Crest Drive in Flowery Branch, cutting off road access to approximately 50 homes.

Public Works contacted the Demand Services contractors under the Onâ€‘Call Public Works program; however, none were able to respond immediately, and one indicated the work was beyond its capacity. In accordance with the emergency procurement provisions of the Hall County Purchasing Ordinance, the Financial Services Director authorized the Director of Public Works to secure an alternative contractor. E.R. Snell was contacted and was able to mobilize and begin work immediately.

A more permanent solution to include paving and striping of the roadway is ongoing and will be presented to the Board of Commissioners for approval.

The funding source for this emergency repair will come from a combination of SPLOST VIII and the Capital Projects Fund.
