Purpose of Request:

Approve the purchase of Axon Justice Premier Plus Software for the District Attorney's Office from Axon Enterprises, Inc. of Scottsdale, AZ. The estimated total cost is \$789,305.00 through an eight (8) year agreement.

History:

Axon is currently being utilized by the Hall County Sheriff's Office as a cloud based evidence repository.

Facts and Issues:

Options:

This purchase is exempt from formal bidding per Code Section 3.10.030 E - Software for computer systems. Additionally, Axon participates in Georgia Statewide contract #99999-001-SPD0000220-0008.

This prosecution package allows instant access to evidence records from the Sheriff's office decreasing delays in case preparation.

Decrease man hours for each investigator, paralegal and prosecutor. Currently the department is spending an average of four (4) hours to download, review, and prepare information for discovery. This program will greatly reduce that time.

The system provides the departments with tools for court presentations, video redaction, audit trails, and instantaneous video translation with transcripts each of which is vital for the department.
