The Georgia Transportation Infrastructure Bank (GTIB) is a grant and low-interest loan program administered by the State Road and Tollway Authority (SRTA). Since its inception, GTIB has provided \$272 million in loans and grants to highly competitive transportation projects that have enhanced mobility and driven economic development in local communities throughout Georgia.

The project proposes a gateway pedestrian bridge over Mundy Mill Road (SR 53).
