#### Purpose of Request:

Approval and authorization for the Chairman to execute a resolution to amend Chapter 4.10 of the Official Code of Ordinances of Hall County, GA with regard to animal services and adopting revisions to the Animal Services Fee Schedule, subject to review and approval by the County Attorney.

#### History:

Hall County Animal Services periodically reviews its Animal Services Ordinance and associated fee schedule to ensure they remain consistent with current operations, community needs, and service delivery practices.

The proposed revisions update Chapter 4.10 of the Hall County Code of Ordinances relating to Animal Services and revise the associated Animal Services Fee Schedule. The amendments are intended to address identified operational and service needs and incorporate input received from County staff and citizens. Approval of the resolution will replace the existing Chapter 4.10 and Animal Services Fee Schedule with the revised versions presented as Exhibits.

The estimated financial impact for these changes is approximately \$ 24K for FY 2027.
