Allan Vigil Ford Lincoln Inc are suppliers for the state contract for vehicles. They are in good standing within the County.

Facts and Issues:

The current Ford F-350 at the Sewer Division is a 2013 with 105,000 miles. It is inadequate for hauling an excavator or skid steer loader on the trailer.
