Purpose of Request:

Approve the annual renewal of the agreement between North Georgia Works!, Inc. and Hall County regarding temporary labor and other work services for various County departments, subject to review and approval by the County Attorney. The estimated annual cost is \$186,560.00.

History:

Hall County Government previously contracted with North Georgia Works! in FY2025 to provide third party temporary labor. The program was successful and beneficial for both Hall County Government and North Georgia Works! North Georgia Works! is in good standing with Hall County Government.

Agreement executed in 2025 shall be for one year from the Effective Date and shall be automatically renewed for successive one-year terms unless changed in a written communication signed by both Parties.

Facts and Issues:

Options:

North Georgia Works! Inc. is a 501(c) (3) corporation whose mission is to provide and implement a cost effective, comprehensive program to help unsheltered people achieve self sufficiency and life skills specifically through work training.

This agreement allows for an hourly fee of \$16.00 per hour and each contracted staff may work up to 40 hours per week. This agreement will provide support to the Public Works (Road Maintenance) and Parks and Leisure Services Departments.
