History:

On June 2, 2026, GDOT provided a funding assistance commitment letter utilizing LMIG funding for \$100,000.00 towards the SR 13 and Hog Mountain Rd. drainage improvements project.

Facts and Issues:

This MOA outlines the funding commitments for the project to include \$100,000.00 from GDOT (LIMG), \$20,000.00 from City of Flowery Branch, \$100,000.00 from Hall County, and the project balance (approximately \$121,606.50 plus any change orders) from the Falcons organization.
