This EDA investment funds the construction of a road infrastructure to serve a new heavy equipment research and development facility and the Georgia Ports Authority inland port in Hall County. The project will support manufacturing and supply chain efficiencies by improving transport of goods and reducing travel time, distance, and exporting costs. Once completed, the project will bolster job creation, spur private investment, and strengthen resiliency within the regional economy. EDA grants are awarded through a competitive process based upon the application's merit, the applicant's eligibility, and the availability of funds. A match of \$2,000,000.00 is required.
