Purpose of Request:
Approve the award of the Georgia Transportation Infrastructure Bank (GTIB) grant for Hall County Public Works for the White Sulphur Road improvement project in the amount of \$1,000,000.00, and appoint the Grants Manager as the Program Designee and authorize the Chairman to execute all related award documents. A match of \$250,000.00 is required.

History:
Hall County has successfully completed two GTIB grants, Tumbling Creek Extension and Martin and J.M. Turk Road. This will be Hall County's third GTIB grant since 2016.

Facts and Issues:
The Georgia Transportation Infrastructure Bank (GTIB) is a grant and low-interest loan program administered by the State Road and Tollway Authority (SRTA). Since inception, GTIB has provided over \$165 million in grants and loans to highly competitive transportation projects that have enhanced mobility and driven economic development in local communities throughout Georgia. A match of \$250,000.00 is required.
