The venue is for all types of meetings, events or small weddings. It would hold approx 50-100 guests inside the barn, the event could house slightly more if held outside.


The lot is large and would have adequate parking, easily accessible for highway 129. The entire 7.8 acres of the property is fenced and gated so there will be no "spillage"
