| Purpose of Request: To approve the extension of the County's February 11, 1998 Sub-Lease of Sunrise Cove Marina to PS Marinas 3 for an additional six years as allowed by the terms of the Sub-Lease, and approve the transfer of the February 11, 1998 Sub-Lease from PS Marinas 3, a California Limited Partnership, to Sunrise Cove SMI Westrec, L.L.C., a Delaware Limited Liability Company. Chairman to sign all documents necessary to complete the transaction subject to the approval of the County Attorney. | | History: The County currently leases real property on Lake Lanier from the Army Corps of Engineers which includes the Sunrise Cove Marina. On February 11, 1998 the County signed a Sub-Lease of the Marina property to PS Marinas 3, which currently operates the Marina. The current Sub-lease expires on July 31, 2023, and PS Marinas 3 has requested a six-year extension until July 31, 2029 as is its right under the Sub-Lease. In addition, the Sub-Lease requires the County's permission in order to transfer it from one party to another. This item seeks the County's acknowledgement of the six-year extension of the Sub-Lease, and its Consent to the assignment of the Sub-Lease from PS Marinas 3 to Sunrise Cove SMI Westrec, L.L.C. | | | | | |
