Dear Mr. Henson:

On November 15, 2021 the Hall County Planning Commission voted to recommend approval, with conditions for your application of CTX Funding SPE, LLC for a Use Subject to Planning Commission approval on a 10.08± acre tract located on the east side of Cornelia Highway approximately 746 feet from its intersection with Yonah Post Road; a.k.a. 5965 Cornelia Highway; Zoned I-I; Tax Parcel 09005 000009. Proposed Use: variance from Gateway Corridor Overlay District architectural standards. Commission District 3.

Conditions:

- The development shall conform substantially with the proposed narrative and site plan, modified as necessary for compliance with current development standards at time of application.
- 2. Elevations depicting the proposed building shall be submitted to the Planning department for approval of the director during the Development Review process. No building permit shall be issued for the development without the approval of said elevations.
- 3. Applicant shall have a 50 foot planted buffer along the front and eastern property lines.
- Applicant shall either cover or shield a flat metal roof with parapets or a factory-finished metal with standing seams roof is permissible.
- 5. Applicant shall have a brick or masonry water table up to 36 inches above the concrete foundation. The balance of the building shall be finished with a stucco or masonry material above the water table on both sides of the building with the roll up doors and the end facing Highway 365 (eastern, western, and southern lot lines).

The Board of Commissioners will hold a public hearing for final determination of this request at their meeting scheduled for **Thursday**, **January 13, 2022 at 6:00 p.m.** at the Gainesville Civic Center, 830 Green Street NE, Gainesville, Georgia 30501.

Please remember that removal of all Public Notice signs posted on the property is your responsibility and should be removed within five (5) working days following the Board of Commissioners final decision.
