# Narrative:

The purpose of subdividing these three, 1.5 acre lots is to remove these lots from a larger 245.92 acre farm tract that is currently in a conservation use covenant. All three lots front on White Sulphur Road and each lot retains one rental house. Each lot is exactly 1.5 acres and, because of the dwelling on each lot, is taxed at fair market value and not subject to the tax savings afforded by the conservation use covenant. Because of this exemption, removing these lots via quitclaim deed is allowed without breaching the covenant and will allow for remodeling and a better use of the rental houses.
