Purpose of Request: The purpose of this request is to approve the annual contract for the Property & Casualty insurance program for FY2023. This insurance program consists of coverages for property, general liability, automobile, crime, terrorism & sabotage, excess liability, public officials liability, law enforcement, law enforcement off duty, cyber liability, aviation, AD&D, TPA fee, risk management fees, and actuarial. 		Hall County has utilized the brokerage services of Arthur J. Gallagher Risk Management Services, Inc., since 2016.				
Facts and Issues:		Options:				

The total program cost for the FY2023 plan year is \$1,348,604, which is an increase of 18.6%. Some of the lines of business under the Property & Casualty umbrella experienced an increase in premiums due to the claims experience, and these lines include auto liability, general liability, law enforcement, excess liability, and cyber. The TPA fees increased by 45.7% due to claims experiences. This year, the renewal includes a property appraisal option.
