Purpose of Request:

Approve the award of a task order for the construction services to replace culvert pipe at Cagle Mill Road for Public Works and Utilities to E.R. Snell Contractors, Inc. of Snellville, GA in the amount of \$182,545.00.

History:

The County has previously allowed Corrugated Metal Pipes (CMP) under County maintained roads. CMP has a shorter life-span when compared to other pipe materials like Reinforced Concrete Pipe (RCP) and High-Density Polyethylene Pipe (HDPE). The County no longer allows the installation of CMP under Hall County Maintained Roads.

Facts and Issues:

This proposal is for the repair and replacement of the existing drainage culvert pipe located at approximately 4825 Cagle Mill Road. This existing pipe is Corrugated Metal and has rusted out along the bottom. This will install a new pipe and upstream inlet structure to current County Drainage Standards. This task order is part of bid 39-018, Demand Services for On-call Public Works Contractors.
