Application of Efrain Carrillo to rezone from Agricultural Residential-IV (AR-IV) to Residential-I (R-I) on a 27.29± acre tract located on the west side of Coker Road approximately 171 feet from its intersection with Thousand Oaks Drive; a.k.a. 3504 Coker Road; Zoned AR-IV; Tax Parcel 15015 000131. Proposed Use: 18 lot subdivision. Commission District 3. NOTE: Tabled at the May 26, 2022 Voting Meeting until the June 22, 2022 Meeting.

Application of Ridgeline Land Planning, Inc. to rezone from Agricultural Residential-III (AR-III) to Planned Residential Development (PRD) on a 50.75± acre tract located on the east side of Union Church Road approximately 166 feet from its intersection with Steeple Chase Lane; a.k.a. 4670 Union Church Road; Zoned AR-III; Tax Parcel 15043 000001. Proposed Use: 100 unit single family detached subdivision. Commission District 1. NOTE: Tabled at the June 9, 2022 Voting Meeting until the June 22, 2022 Meeting.

#### Conditions:

1. The development shall generally occur as depicted on the site plan and described in the project narrative. Minimum lot standards shall be as follows:

a. Minimum lot width: 50 feet

b. Minimum lot depth: 125 feet

c. Minimum lot area: 6,250 square feet

d. Minimum average lot area: 8,000 square feet

e. Front setback: 20 feet from right of way with minimum of 25 feet from rear of sidewalk to face of garage

f. Side setback: 5 feet, subject to Fire Department approval

g. Rear setback: 20 feet

- 2. There shall be no more than 125 total units in the development, equaling a density of 2.5 units per acre.
- 3. The following statement regarding the potential impacts of agricultural operations in the area shall be made a part of any plat recorded on the property: "Owners, occupants, and users of property shown on this plat are hereby informed of the impacts associated with normal farming practices which may take place on adjacent and nearby property including, but not limited to, noise, odors, dust, the operation of machinery of any kind, the storage and disposal of manure, and the application of fertilizers, herbicides, and pesticides. Therefore, owners, occupants, and users of the property shown on this plat should be prepared to expect the effects of such practices."
- 4. A 6 foot tall wooden privacy fence will be constructed along the northern property line adjacent to parcel #15043 000203 within 60 days of issuance of the land disturbance permit (LDP).
- 5. The northern entrance depicted on the site plan nearest to Steeple Chase Lane shall be removed. The southern entry shall be the only entrance provided and shall include a deceleration lane.

Application of Bark Camp Farm for a Use Subject to County Commission approval on a 30.62± acre tract located on the south side of Hunter Road approximately 1,252 feet from its intersection with Cleveland Highway; a.k.a. 4294 Hunter Road; Zoned AR-IV; Tax Parcel 12023 000010. Proposed Use: farm-style dog daycare, boarding facility and family/community events. Commission District 3.

Commissioner Echols/Commissioner Stowe — approve with the thirteen (13) conditions listed below — unanimous

#### Conditions:

- 1. Development shall be as generally depicted on the proposed plan and narrative as submitted.
- 2. A variance to the 200 foot setback requirement shall be approved for the existing barn so that it may be utilized as shelter for the dogs in inclement weather.
- 3. All outdoor runs utilized for the business shall meet the 200 foot setback requirement or a variance shall be obtained.
- 4. As stated in the applicant's narrative, the following dog breeds are not permitted at their facility: German Shepherds, Pit Bulls, Doberman Pinschers, Rottweilers, and Presa Canaros.
- 5. The proposed use shall be limited to the submitted narrative and site plan, and shall exclude any and all breeding activities.
- 6. There shall be a maximum of 50 dogs for the daycare facility and 20 for overnight boarding.
- 7. Unsupervised outdoor dog activity shall be limited to proposed business hours only, 8:00 am -6:00 pm daily. Office operation for boarding shall be from 8:00 am -6:00 pm, Monday Sunday and Doggy day care shall operate from 8:00 am -6:00 pm, Monday Friday.
- 8. Any change of ownership of the property or substantial change to the proposed conditional use will require a new use permit application to be submitted as this approval is for this applicant only.
- 9. Any site improvements shall be subject to the Hall County Development Review process and any applicable regulations.
- 10. All conditions of zoning shall be made a part of any plat created for property.
- 11. There shall be a right turn only sign placed at the exit of the property.
- 12. There shall only be one event per quarter, for a total of four per year.
- 13. The shuttle service shall not operate on Hunter Road 45 minutes before school starts and 45 minutes after school ends.

Application of Jay Wilhoite for a Use Subject to County Commission approval on a 4.75± acre tract located on the west side of Candler Road approximately 175 feet from its intersection with Roy Parks Road; a.k.a. 2654 Candler Road; Zoned H-B; Tax Parcel 15030 000008. Proposed Use: retail units and self-storage warehouses. Commission District 3.

#### Conditions:

- 1. The development shall conform substantially with the proposed site plan and narrative with approved variances as follows:
- a. RV and boat storage shall be allowed to be gravel surface (§17.420.050.E.3).
- b. There shall be a 30 foot front setback variance (§17.240.040).
- c. Buildings 1-3 closest to Candler Road shall be non-metal three sided and buildings 4-6 shall have non-metal sides only (§17.420.050.H.2).
- 2. All development of the property shall conform with §17.420, Gateway Corridors Overlay District (GCOD) standards with the exception of variances granted.
- 3. All conditions of zoning shall be made a part of any plat of the property.
- 4. All exterior colors and materials shall be approved by the Director of Planning and Development.
- 5. This conditional use approval shall be granted for this applicant only and shall be applicant specific.
- 6. All external lighting shall meet Hall County standards specified in code.
