#### Purpose of Request:

To approve the Resolution to Amend the Code of Ordinances of Hall County with Regard to Solid Waste at the Sanitary Landfill.

#### History:

The Department of Public Works and Utilities requested that the Code be amended so as to restrict the deposit of boats, roofing materials, bulk Styrofoam, pressurized tanks, and mobile homes into the County's landfill because that restriction will increase the useful life of the landfill.

#### Facts and Issues:

The County's Department of Public Works and Utilities wishes to increase the useful life of the County's sanitary landfill by prohibiting the regular deposit of boats, roofing materials, bulk Styrofoam, pressurized tanks, and mobile homes into the landfill. This resolution would accomplish that purpose but would also give the Board of Commissioners the power to allow non-profit corporations or charitable entities to deposit some or all of those materials by obtaining an exception from the Board for a special event that serves community or civic purposes.
