Purpose of Request: Approve the updated application of the Georgia Public Library Service Construction Grant for the Hall County Library to construct the East Hall Library in the amount of \$2,000,000.00 and, if awarded, appoint the Grants Manager as the Program Designee and authorize the Chairman to execute all related application and award documents. Facts and Issues:		Options:			

In order to be competitive, Hall County needs to submit their project to the Board of Regents of the University System of Georgia Public Library Service so that the project can be placed on the potential project list for funding. Matching funding from Hall County does not have to be in place until the project is approved by the Library System for construction. However, if the project is not on the list it will not be considered for funding. Hall County is not required to accept the funds if the County decides to build or not build the library at the time the funds are awarded. Policy confirming this information is included in the grant information. Hall County's estimated cost of the building is \$5,000,000 but does not include the land costs. Costs of the construction could also increase, which is why the maximum amount of funding, \$2M is being sought for the grant amount.
