Digital Intercom System Upgrades:

As we discussed, your existing Analog, Dukane Intercom System has been listed as *End of Life* by the manufacturer and puts your facility at risk. Therefore, it needs to be replaced because servicing and maintaining it will become increasingly difficult. Depending on the failure, your Intercom System could be down for days or even weeks. To keep this from occurring, the obsolete Analog, Dukane Intercom System will be upgraded to a new Harding Digital Intercom system.

This upgrade happens primarily in the headend equipment racks and will only slightly change how your staff uses the intercom system on a day to day basis. At the ten (10) Touchscreen Control Station locations, we will supply a new Intercom Master Station with flush mount mic. This is the only significant change in the field. The new Digital Intercom System will reuse the existing intercoms and paging speakers, so your field devices and cabling does not need to change.

At the headend, the existing analog, Dukane relay cards and talkback amplifiers will be removed and replaced with the Harding Digital Controllers and Expansion Units. The existing intercom stations and paging speakers will be rewired to the new equipment by STANLEY.

Due to the lack of memory on two (2) of your existing PLC processors, these two (2) processor will be required to be replaced with new PLC processors.


