Approve the turnkey project to the sole source vendor, Intelligent Conservation Systems, Inc. This is phase 2 of the project.

#### History:

We presently have outdated showers and fixtures for inmates at the Jail. The new system will allow for better water control and less water usage resulting in water bill savings per vendor. This is Phase 2 of the project.

#### Facts and Issues:

The installation of the new showers and fixtures will allow the officers to have better control of water usage by the inmates and allow for new and better safety features. This system is estimated to have a 40% savings on the water bill for the Jail. This is Phase 2 of the project. This project is projected to cover a 5 year span until completion.
