We have purchased from Clint Brannen in the past and they are a very good vendor and in good standing within the County.

#### Facts and Issues:

Clint Brannen has five (5) 2022 F150 trucks available now. Allan Vigil isn't offering 2022 trucks any longer and the lead time on the 2023 F150 trucks is months. A comparison sheet for a 2023 from Allan Vigil is attached. There is only \$1034 difference in the state contract vs. Clint Brannen and the lead time is the biggest reason Fire Services is asking for approval to purchase from Clint Brannen Motors.
