**A RESOLUTION TO APPOINT THE FIFTH MEMBER OF THE BOARD OF  
ELECTIONS AND REGISTRATION OF HALL COUNTY**

**WHEREAS**, the Local Act of the General Assembly which created the Board of Elections and Registration of Hall County provides that the Board of Commissioners shall appoint the fifth member of the Board of Elections and Registration of Hall County; and

**WHEREAS**, the fifth member of the Board of Elections and Registration of Hall County shall be the Chairperson of the Board; and

**WHEREAS**, Dr. Tom Smiley's present term as the fifth member of the Board of Elections and Registration of Hall County expires on December 31, 2022; and

**WHEREAS**, the Board of Commissioners of Hall County desires to appoint Jack Noa as the fifth member of the Board of Elections and Registration of Hall County for a four-year term commencing on January 1, 2023; and

**WHEREAS**, Jack Noa meets all requirements necessary to become the fifth member of the Board of Elections and Registration of Hall County;

**NOW, THEREFORE**, the Board of Commissioners of Hall County hereby appoints Jack Noa as the fifth member of the Board of Elections and Registration of Hall County for a four-year term beginning on January 1, 2023. Jack Noa shall serve until his successor is appointed and qualified.

**BE IT FURTHER RESOLVED** that the Chairman of the Board of Commissioners of Hall County is hereby authorized to execute and file an affidavit with the Clerk of the Superior Court of Hall County stating the name and residence address of Jack Noa and certifying that Jack Noa has been duly appointed as provided by law. The Chairman of the Board of Commissioners of Hall County is further authorized to execute any and all additional documents necessary to effectuate this appointment.

**BE IT FURTHER RESOLVED** that the Clerk of the Superior Court of Hall County shall record this Certification on the minutes of the Superior Court and shall certify Jack Noa as the fifth member of the Board of Elections and Registration of Hall County to the Secretary of State and provide for the issuance of the appropriate commissions to the members of the Board of Elections and Registration of Hall County as provided by law.
