Good evening, Debra,

As discussed, we had viewed the Scope of Work (A.-E.) as items that would be provided as part of the design effort. Establishing an accurate opinion of probable construction costs is challenging before the design effort has started. There are decisions that need to be made during the design process that will significantly impact the construction cost. A few examples of these include selections for the backup fuel source, which could be gas, diesel, natural gas, or propane. Gas, Diesel, and Propane solutions usually require the installation of a fuel storage tank, where natural gas does not. The proposed location of the generator and the transfer switch with respect to the existing electrical panels will impact the length of electrical cables, which could also have a significant impact to the cost. also need to know if the building has a single phase or three phase power supply. We understand the County's desire to have a target budget for the project, but in our opinion, it is premature to offer a construction cost at this point in the process. We do, however, feel comfortable providing an estimate early in the process. This could occur after making our site visits, meeting with County personnel, and completing a load analysis. As discussed, here is a breakdown of our fee, which we hope will be useful in the decision process.




