Dear Ms. Crumley:

Precision Planning, Inc. (PPI) is pleased to offer Hall County (Client) this proposal for professional design services related to renovations planned at the Hall County Health Department. The scope of services below is based upon your request and will be an additional authorization related to PPI's contract for Hall County space programming and master planning.

Project Understanding

PPI understands that the Client plans to renovate the interior of the existing Hall County Health Department in its entirety (approximately 36,000 SF) to improve efficiency and expand the functionality of the building. The scope will also include a new drive-up canopy at the main entrance. The exterior façade of the Health Department building and the District Building will be renovated to match a proposed new building and create a "campus" feel. Civil engineering of the project site is by others. Design services are proposed as outlined below.

Project Scope of Services

I. Schematic Design

- A. PPI will attend a kick-off meeting with the Client to confirm goals and objectives for the project.
- B. PPI will utilize a previously prepared CAD As-Built Floor Plan for design purposes.
- C. PPI will prepare a Schematic Floor Plan for submittal to the Client. One (1) revision is included.
- D. PPI will prepare a Schematic level Opinion of Probable Cost (OPC) for submittal to the Client.

II. Construction Documents

- A. After approval of the Schematic Floor Plan, PPI will prepare Construction Documents (drawings and specifications) suitable for permitting, procurement, and construction of the project. 

H. Reimbursable expenses including mileage, photographic enlargements, reductions and reproduction, blueprinting, and courier services shall be billed at a rate of actual cost ~~times 1.1~~. When overnight stay is required, it shall be billed as actual subsistence cost ~~times 1.1~~.
NOTE: No back-up data or copies of bills will be provided for reimbursable expenses invoiced under this agreement. Should back-up data be requested, it will be provided for an administrative fee of \$100.00 per monthly invoice requiring verification, plus \$1.00 per copy of back-up data provided.

I. In the event additional services beyond the scope of work listed above are required by Owner/Client, Precision Planning, Inc. shall perform these services for an amount equal to normal hourly charges on work actually performed upon receipt of an approved Change Order signed by both parties. Precision Planning, Inc. shall submit monthly invoices for services outlined in this agreement. Payment is due upon receipt of invoice. Finance charges of one and one-half percent (1.5%) will be added to any unpaid balance at the end of ~~thirty~~ (30) forty-five (45) days (APR 18%).

J. The Owner/Client or Precision Planning, Inc. may terminate this Agreement without penalty upon giving the other party ten (10) calendar days' notice in writing. In the event either party terminates for convenience, the Owner/Client shall pay Precision Planning, Inc. within ~~seven~~ (7) fifteen (15) calendar days of receipt of Precision Planning, Inc.'s invoices for all services rendered and all reimbursable costs up to the date of termination. In addition, the Owner/Client shall pay Precision Planning, Inc. for all expenses reasonably incurred by Precision Planning, Inc. in connection with the orderly termination of this Agreement, including but not limited to associated overhead costs and all other expenses directly resulting from the termination. In the event government regulations are amended or changed in any way, or if the services outlined in this proposal have not been authorized within thirty (30) days of the date of this proposal, fees quoted are subject to renegotiation.

K. Services required by unexpected events which are outside Precision Planning, Inc.'s reasonable control including, but not limited to, services resulting from extended schedules shall be compensated as additional services.
