Purpose of Request:

Approve the change order in the amount of \$440,550.00 for Precision Planning, Inc. to provide architectural services for renovations and upgrades to the to Hall County Health Department.

History:

Since 2019, Precision Planning has been working on space plan issues for the Hall County Health Department. While PPI has completed conceptual drawings for the building under that existing contract, Hall County now needs architectural and construction drawings in order to move the renovation forward and provide those plans to a contractor.

Facts and Issues:

In the wake of the COVID-19 pandemic, Hall County received funding through the American Rescue Plan Act, a federal program that assists with community development and public health initiatives in order to support communities from the negative impacts of COVID-19. The renovation to the Health Department is expected to include various improvements to the facility, such as a drive-through clinic, vaccination center, etc. to help public health officials deal with future health crises.
