Purpose of Request:

Approval and authorization for the Chairman to execute a Settlement Agreement and Release concerning Oasis Consulting Services, LLC and Oasis Construction Services, Inc. whereby Oasis will pay Hall County the sum of \$952,393.65, subject to review and approval by the Law Department.

History:

In January 2020, a storm water diversion berm in phase two, cell two of the Hall County landfill failed causing Hall County to incur substantial damages. Hall County subsequently brought suit against Oasis to recover certain damages occasioned by the negligent design of the berm.

Facts and Issues:

The County retained an independent engineer and construction company to redesign and rebuild the berm. The redesigned berm has functioned properly at all times since the reconstruction of the berm was completed.

Options:

This settlement agreement and release has been approved by the Board of Commissioners, and this agenda item merely formalizes the resolution of this matter.
