Executive Summary:

ER Snell Contractor, Snellville, GA

Purpose of Request:

To ratify the issuance of an emergency purchase order for the repair of a corrugated metal pipe culvert underneath Claude Parks Road. This pipe has failed causing the roadway base to wash out thus creating a situation where the roadway pavement is in imminent danger of collapsing. Eighty-five (85) addresses are located on Claude Parks Road. The roadway is currently closed to traffic.

Facts and Issues:

We are using bid #39-018, Demand Services On-Call Construction Contractors where we have two (2) vendors on call. ER Snell responded to this need. Simpson Trucking did not respond. The metal corrugated culverts will be replaced with concrete box culverts and restore the roadway.

History:

As these metal corrugated pipes are aging, we are having failures around the County that cause road closures.

Additional Information/Comments:

The funding for this road infrastructure repair / improvement is from the remaining line in SPLOST VII in culvert replacement, and the remainder is coming from SPLOST VIII in the culvert replacement line item. After analyzing the cash flow for SPLOST VIII, this increase to the budget can be supported with existing dollars. This recommended adjustment will increase the overall budget for SPLOST VII and SPLOST VIII to get the correct funding in place for this repair.
