### Purpose of Request:

Approve the award of IFB #028-43 Baler for Resource Recovery Department to Sierra International Machinery, LLC, Bakersfield, CA, in the amount of \$995,130.00.

### History:

The current baler is eight (8) years old. Since year two (2) of the purchase, there have been many expensive repairs. No parts manual is available and this makes identifying the parts needed for order and repair difficult. Additionally, the current machine isn't capable of the output of material that we need to produce.

### Facts and Issues:

The difference in cost of the two (2) received cost proposals results from the fact that International Baler doesn't have the prepress addition in the bid that Sierra International Machinery, LLC offers. The prepress allows the baler to run smoothly without major wearing of the floor liners. This is a savings of at least \$210,000 within the first 10 years of purchase. There will be many more savings and benefits by choosing Sierra International Machinery, LLC.
