Purpose of Request: Approve the ratification of the application of the Accountability Court Funding FY 2023 Enhancement and Innovation Grant for Treatment Services to provide additional substance use, mental health and ancillary services to incarcerated participants in the amount of \$51,502.00, and if awarded, appoint the Grants Manager as the Program Designee and authorize the Chairman to execute all related application and award documents. A cash match of \$7,023.00 is required and, if awarded, one new position to position control will be added.		History: This will be Hall County Treatment Services Department's third year applying for the additional funding.			

Options:

Facts and Issues:

Treatment Services is seeking grant funding through the Enhancement and Innovation Grant to fund a full-time counselor position in order to expand our services and enroll eligible participants at a faster rate. This request includes one new position in position control upon grant award. The accountability courts of the Northeastern Judicial Circuit (Hall County specific) will collaborate with the Hall County Sheriff's Department and Hall County Jail to provide additional substance use/mental health and ancillary services to incarcerated participants. This grant award will help us expand weekly psychiatric services, pay for required health screening/testing needed for enrollment in residential treatment programs, and hire a part-time Human Services Coordinator to directly assist referred individuals in executing a comprehensive discharge plan. The Human Services Coordinator will provide much needed assistance to individuals accepted to an accountability court program but are in need of linkage to ancillary services such as stable housing, psychiatric or medical services, food banks, employment assistance, obtaining proper identification.
