#### Purpose of Request:

The Georgia DOT has requested Hall County's approval of a traffic signal application for Friendship Road at North Bogan Road. This traffic signal will include modifications to nearby intersection of Jones Drive intersection which will allow right and left turns in from Friendship but right turns out only. This project will not utilize any Hall County Funds for the installation but Hall County will be responsible for the monthly utility costs for the traffic signal. Commission District 1

#### History:

This is an existing unsignalized intersection in Hall County. The property north of Friendship Road at this location is in the City of Buford and is proposed to be developed into warehouse/industrial uses with the access aligning with Bogan Road. To accommodate the traffic impact and increase the safety of the intersection, GDOT is requiring the developer to install a traffic signal at Bogan Road and modify the nearby Jones Drive intersection into an RCUT (Restricted Crossing U-Turn) intersection.

#### Facts and Issues:

#### Options:

The developer will fund the Friendship Road @ Bogan Road traffic signal installation and modifications to Friendship Road @ Jones Drive intersection. If any modifications are necessary for Bogan Road and Jones Drive (widening, striping, etc.), the developer will also fund that. The traffic signal will be operated and maintained by GDOT. However, Hall County will be responsible for the monthly utility costs. Friendship Elementary School is close to the intersection. GDOT met with school officials who supported the traffic signal installation.
