Purpose of Request:

Approve the award of the design of the Mulberry back pumping sewer project to Civil Engineering Consultants Inc. of Marietta, GA, in the amount of \$495,000.00.

History:

A Preliminary Engineering Report for the Mulberry Regional facilities was prepared and submitted November 2015 by Tetra Tech, Inc. Currently, the wastewater flows entering the Mulberry Creek Pump Station (PS) are discharged to the Crystal Farms Lift Station to be re-pumped to the City of Gainesville for treatment. The wastewater flow discharged from the Reunion PS is treated at the Spout Springs Water Reclamation Facility (SSWRF). The 2015 Tetra Tech report provided recommendations to redirect the Mulberry Creek PS flows to the Spout Springs WRF. An update and re-evaluation of the Preliminary Engineering Report was performed in 2021.

Facts and Issues:

The Mulberry Back-pumping project is a County's Capitol Improvements Project and is accounted for in the 2020 Sewer Master Plan. The award is for professional design services to prepare plans and documents needed to execute the project.
