Enclosed you will find a Letter of Intent for Hall County to obtain digital orthophotography and LiDAR as part of the Georgia Mountains Regional Commission's (GMRC) regional project. Within the Letter of Intent, Hall County's total project costs for participation are detailed there. These costs are calculated based on the enclosed map/area of interest. By approaching this project regionally, we have saved our project participants approximately 40% of the cost of conducting the same kind of project individually.

During the September GMRC Council and Executive Committee meetings, Quantum Spatial was approved as the vendor for this project. The flight will occur during the prime leaf off season from December 2022 through January 2023, with the delivery of final products to the county by September 30, 2023.

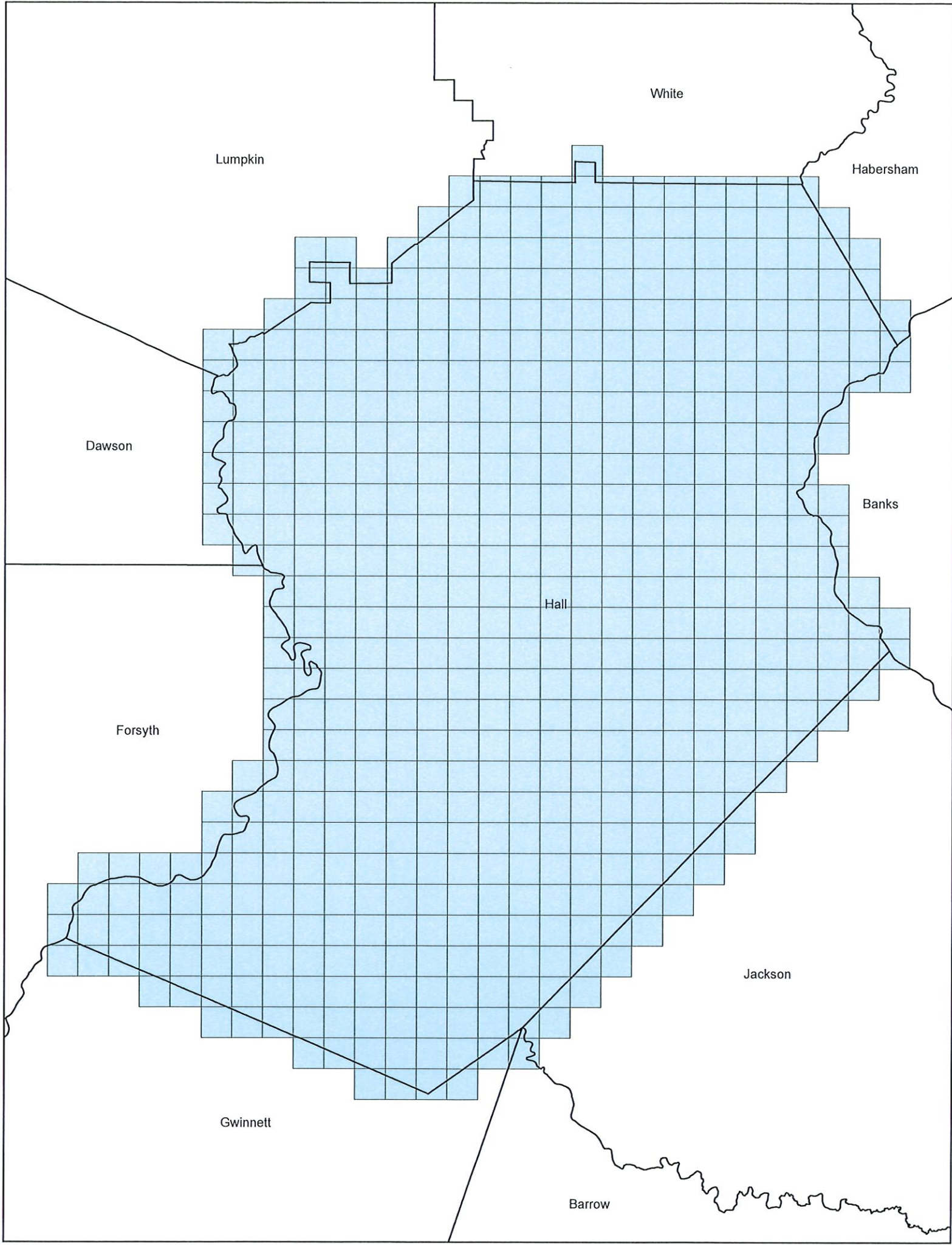
