33 Application of Dhaval Patel to amend conditions of a Planned Commercial Development (PCD) on a 2.68± acre tract located on the west side of McEver Road at its intersection with Pemmican Run; a. k. a. 1050 McEver Road; Zoned PCD & V-C; Tax Parcel 08005 000044. Proposed use: auto rentals and outdoor storage. Commission District 2.

Conditions:

1. No tractor trailer parking shall be allowed on site.

2. There shall be a total of eight (8) Budget Rental trucks a maximum of ten (10) Avis Rental cars.

3. Shall install a 20 foot buffer of fast growing trees to be approved by the county staff along Pemmican Run to the Georgia Power easement to the rear of the property, also on the right hand lot line from the 40 foot setback line to the beginning of the Georgia Power Easement and install a privacy fence (minimum of eight feet tall) on the left lot line from the center line of the Georgia Power easement to the northernmost.

4. Additional landscape improvements shall be made along McEver Road with landscape plan subject to approval by Planning and Development Director. 34 Application of Rochester and Associates, LLC to rezone from Agricultural Residential-III (AR-III), Residential-I (R-I), and Vacation Cottage (V-C) to Planned Residential Development (PRD) on a 60.39± acre tract located on the north side of Price Road approximately 628 feet from its intersection with Summit Chase; a. k. a. 3824, 3830, 3842, 0, & 0 Price Road; Zoned AR-III, R-I, & V-C; Tax Parcels 10100 000006-000007, 000103, 000108, & 000159. Proposed use: 202-unit residential subdivision. Commission District 2.

## Conditions:

1. The development shall generally occur as depicted on the site plan and described in the project narrative, modified for compliance with zoning conditions and Hall County regulations.

2. The proposed residential development shall conform to §17.180.060 Planned Residential Development (PRD) standards, with the exception of the following:

- a. Lot area calculations, to meet the minimum requirements for townhouses, shall be set at 2000 SF per unit.
- b. Existing, undisturbed buffers, that meet the screening requirements, shall satisfy the overall 50' requirement without additional planting
- c. A secondary, emergency entrance shall be allowed to connect to a nonpublic road located on adjacent property. Construction of the secondary entrance shall be required prior to issuance of the 151st Certificate of Occupancy.
- d. Open space shall be calculated as any site areas not utilized for right-ofways, lots or stormwater management facilities and shall be no less than 30% of the gross parcel size.

3. The proposed residential development shall confirm to §16.60, with the exception of the requirement for cul-de-sacs at dead end streets. Street terminations of less than 150' from the closest intersection shall be allowed, as described in the International Fire Code, Section 503.2.5.

4. The maximum density for the development shall not exceed 3.5 units per acre.

- 5. The following standards shall apply to the development:
  - a. Setbacks:
    - i. Front: 25 Feet from center line of road

- ii. Side: 5 feet
- iii. Rear: 20 feet
- *b.* All site plans shall indicate that the distance from the rear of the sidewalk to the garage meets or exceeds 22 feet.
- c. Open Space: minimum of 30%.
- d. The Open Space and lot configuration shall not be redesigned to meet §17.430.110.E and §17.430.110.F, including the requirement that "F. The open space shall be directly accessible to the largest practicable number of lots within the subdivision. Non-adjoining lots shall be provided with safe, convenient access to the open space." The redesigned lot layout shall be approved by the Planning Director prior to submission of the application for a Preliminary Plat/ LDP application.
- e. Buffers: A minimum 50 foot planted buffer shall be established along the perimeter of all property boundaries adjacent to residential and/or non-residential zoning districts to ensure that the planned residential development is appropriately screened. The planted buffers shall conform to the requirements as described in section 17.260.020 titled Vegetation Buffers and Vision Clearance. Undisturbed areas of the buffer will not require additional planting.
- f. Architectural standards: All facades of all residences, shall be finished with brick, stone, stucco, wood siding, wood shakes, or fiber cement type siding. The front facades shall incorporate changes in building material, texture, and/or color. Vinyl siding on all residential and nonresidential buildings shall be prohibited.

6. A homeowners association is required to maintain the common ownership elements of the development.

7. The proposed Stormwater BMP (pond) shall be on a separate "utility" lot that is not a part of the open space.

8. The lots shall be designed so that all state waters and required buffers (50') do not encroach on individual lots. Required impervious setbacks may encroach on individual lots.

9. The following statement regarding the potential impacts of agricultural operations in the area shall be made a part of any plat recorded on the property: "Owners, occupants, and users of property shown on this plat are hereby informed of the impacts associated with normal farming practices which may take place on adjacent and nearby property including, but not limited to, noise, odors, dust, the operation of machinery of any kind, the storage and disposal of manure, and the application of fertilizers, herbicides, and pesticides. Therefore, owners, occupants, and users of the property shown on this plat should be prepared to expect the effects of such practices."

10. All conditions of zoning shall be made part of any plats created for the property.

11. Up to ten (10) model homes shall be built of varying product type.

12. The existing family home to the rear of the property shall be limited to a single family home or a clubhouse for the proposed developments only.

13. All private streets shall comply with Hall County standards.

14. No more than one hundred fifty (150) occupancy permits shall be granted without a second entrance to the development or other life safety improvements to the development that meet state requirements.

35 Application of Rochester and Associates, LLC to rezone from Agricultural Residential-III (AR-III) and Agricultural Residential-IV (AR-IV) to Planned Industrial Development (PID) on a 24.66± acre tract located on the west side of Athens Highway at its intersection with Barrett Road; a. k. a. 2562, 2564, 2592, & 2596 Athens Highway; Zoned AR-III & AR-IV; Tax Parcels 15023A000035 (pt.), 000035A - 000035B, & 000036. Proposed use: vehicle salvage. Commission District 3.

### Conditions:

1. The conditions of the March 2, 2012 approval shall continue to apply to the expanded PID:

- a. The development is approved according to the specific layout shown in the submitted plans, and the terms outlined in the narrative submitted.
- *b.* The hours of operation are limited from 8:00 a.m. until 6:00 p.m. Monday through Saturday.
- c. No residential structures or uses are permitted in the PID zoned portion of this property. PID zoning is only approved for the areas specifically identified on the site plan submitted and the area maps provided by the county.
- *d.* No additional structures shall be added to the property after September 6, 2022.
- e. Vinyl siding and chain link fencing are prohibited.
- f. Final roadway design and placement are subject to approval by the Hall County Engineering Department and/or the Georgia Department of Transportation.
- g. Any access improvements required by either the Georgia Department of Transportation and/or the Hall County Engineering Department for this project shall be the financial responsibility of the applicant/developer.
- h. A roadway with public road way status shall be constructed with all appropriate standards. No sidewalks are required. This road shall provide road frontage to all existing land locked residential properties along it and shall provide adequate turn around at the terminus. Final roadway design is subject to review and approval by Hall County staff.
- i. The roadway shall be approved and constructed prior to any Certificate of

Occupancy being issued for the business facility.

- *j.* A 50 foot buffer shall be established around the entire property with cars that are now in the existing 50 foot buffer to be removed and a registered Georgia Land surveyor or engineer shall permanently stake the 50 foot buffer to assure that no cars are placed in the future and the buffer shall be re-established to current Hall County standards for a non-disturbed buffer. The 50' buffer may be reduced to a 25' buffer by installing a privacy fence along the buffer line.
- k. Two of the existing poultry houses shall be removed.
- *I.* The property owner shall be required to combine all lots to not more than two (2) lots, any existing lots of record shall remain and new lots created shall meet Hall County standards.
- *m.* Plats shall be recorded for all lots developed off the public access.
- n. Vehicles may only be stored in the designated area of the site as shown on the submitted site plan. No vehicles may be stacked at any time on site, except when being loaded onto a transport carrier.
- o. Both the sales of parts and the dismantling of vehicles are permitted during normal business hours.
- *p.* Any vehicle repairs/modifications shall be conducted in a fully enclosed structure.
- q. Any outdoor lighting on the premises shall be of a non-spill type.
- *r.* The vehicle parking areas around buildings shall be paved with either asphalt or concrete.
- s. All conditions of zoning shall be made a part of any plat created for the property.

2. The existing signage for the business shall be removed from the right-of-way of Athens Highway and the applicant shall work with the Hall County Planning Department to permit replacement signage in accordance with §17.420.060, Signs.

*3.* The applicant shall submit a full set of civil plan for review through the Development Review process to ensure the property is in compliance with all applicable standards of the Official Code of Hall County and the listed conditions of zoning. Permit must be applied for no later than December 31st, 2022.

4. No cars shall be parked within 300 feet of GA 129 right of way.

5. The property owner shall plant an evergreen landscape buffer along the Gateway Corridor Limits. The buffer shall be in accordance with the Hall County Buffer Ordinance and approved by the Planning Director prior to installation. The buffer must be installed prior to issuance of a Land Disturbance Permit for the work on the site.

6. A 100 foot buffer shall be established along the northern property line adjoining parcels 15023 C000011 and 15023 000009. The buffer shall be enhanced with evergreen plantings as directed by the Planning Director. This buffer may be reduced to a 75 foot buffer by installing a privacy fence along the buffer line. Existing driveways within the buffer shall be grandfathered.

7. Failure to abide by conditions of zoning may result in a board hearing to revoke the business license.

8. The existing signage for the business shall be removed from the right-of-way of Athens Highway and the applicant shall work with the Hall County Planning Department to permit replacement signage in accordance with County code.

9. The applicant shall submit a full civil plan for review through the development review process to ensure property is in compliance with all applicable standards of the Official Code of Hall County.

10. No cars shall be parked within 300 feet of the GA 129 right-of-way.
