

### **Purpose of Request:**

To approve the transfer of the 1255 Vine Street property to the Hospital Authority of Hall County and the City of Gainesville via Quit Claim Deed and approve the assignment and assumption of the existing lease on the same property to the Hospital Authority, and authorize the Chairman to execute all documents necessary to effectuate both transactions, subject to the review and approval of the County Attorney.

### History:

WJLICA

On December 20, 2004 the State of Georgia deeded the 4.1 acre property located at 1255 Vine Street, Gainesville, Ga. to the County. On March 6, 2018 the County entered into a long term lease of the property to North Georgia Works, Inc. On November 9, 2022 the County approved a Resolution declaring the property unserviceable pursuant to Hall County Code Section 3.10.180. On the same date, the County approved and executed a Real Estate Transfer Agreement, whereby it agreed to transfer the property to the Hospital Authority via deed, provided that the Hospital Authority agrees to assume all of the County's obligations as landlord under the existing lease with North Georgia Works, Inc.

# IMPROVED REAL ESTATE TRANSFER AGREEMENT FOR PROPERTY LOCATED

### AT 1255 VINE STREET, GAINESVILLE, GEORGIA

This Agreement is made and entered into this <u>4</u> day of <u>NOMPAPP</u>, 2022 by and between Hall County, Georgia with the address of 2875 Browns Bridge Road, Gainesville, Georgia 30504 (hereinafter the "County"), and the Hospital Authority of Hall County and the City of Gainesville, with the address of 743 Spring Street, Gainesville, Georgia 30501 (hereinafter the "Hospital Authority").

WHEREAS, the County currently owns in fee simple certain improved real property known as 1255 Vine Street, Gainesville, Georgia 30501 ("the Property"); and

WHEREAS, the County has determined that the Property is unserviceable pursuant to Hall County Code Section 3.10.180; and

WHEREAS, the County desires to transfer the Property to the Hospital Authority, and

WHEREAS, the County desires that the current lessee of the Property, North Georgia Works, Inc., be allowed to continue to lease the Property for the remaining term of the lease thereon, a copy of which is attached hereto as Exhibit A; and

WHEREAS, the County's ordinances specifically permit a transfer of the Property to the Hospital Authority pursuant to Hall County Code Section 3.10.180 (A)(2)(d); and

WHEREAS, Georgia law specifically permits a transfer of the Property to the Hospital Authority pursuant to O.C.G.A. Section 36-9-3 (a)(3)(A); and

WHEREAS, the Hospital Authority is a public body corporate and politic which owns the facilities and real estate that comprise the Northeast Georgia Medical Center, Gainesville campus, in Gainesville, Georgia; and

WHEREAS, the Hospital Authority is charged with providing for the public health needs of the community; and

WHEREAS, the Hospital Authority is willing to accept the transfer of the Property; and

WHEREAS, the Hospital Authority is willing to continue the current lease of the Property to the current lessee for the remaining term of its lease thereon; and

WHEREAS, the parties believe that the transfer of the Property and the transfer of the Property's existing lease from the County to the Hospital Authority would promote the health, safety, and general welfare of the citizens of Hall County, Georgia.

NOW THEREFORE, the parties hereto enter into this Improved Real Estate Transfer Agreement for the Property according to the following terms.

### <u>AGREEMENT</u>

### 1. Hall County's Responsibilities

For and in consideration of the valuable promises made herein by the Hospital Authority, the County agrees to deed to the Hospital Authority via quitclaim deed all of its rights and interest in the Property and improvements thereon which is described as 1255 Vine Street, Gainesville, Georgia 30501 and which is more particularly described in Exhibit B hereto, within ninety (90) days of the date that this Agreement is fully approved and executed by all parties hereto. The County further agrees to pass all resolutions necessary to effect the transfer of the property to the Hospital Authority.

### 2. Hospital Authority's Responsibilities

For and in consideration of the valuable promises made herein by the County, the Hospital Authority agrees to accept the transfer of the Property and improvements thereon and agrees to fully honor and continue the current existing lease on the property to the current lessee for the

ł

remaining term of the existing lease. The Hospital Authority further agrees that following the fee simple transfer of the Property and improvements thereon from the County, the County shall have no further obligation relating to the Property or improvements thereon (including any obligations relating to the existing lease), or relating to the Property's lessee. The quitclaim deed of the Property shall be filed with the Hall County Clerk of Court's real estate records.

### 3. Continuing Responsibilities

Following the transfer of the property to the Hospital Authority, the Hospital Authority shall thereafter assume all costs, utilities, leases, debts, liabilities, repairs, duties, legal responsibilities, and obligations relating to the Property and improvements thereon (including all obligations relating to the existing lease), and the parties agree that the County shall have no further duty or obligation relating to the Property or improvements thereon. Following the transfer of the Property to the Hospital Authority, the Hospital Authority shall act as landlord for the Property as to the current lessee for the remaining term of the existing lease on the Property, and the County shall no longer have any duties or responsibilities to act as landlord for the Property or improvements thereon. The Hospital Authority further agrees to use the Property solely to further the purposes of the Authority as described in its charter documents, including providing for the health care needs of the surrounding community.

### 4. Severability

If any paragraph, sub-paragraph, sentence, clause, phrase, or portion of this Agreement is declared invalid or unconstitutional by any Court of competent jurisdiction or if the provisions of any part of this Agreement as applied to any particular situation or set of circumstances shall be declared invalid or unconstitutional, such invalidity shall not be construed to affect the remaining portions of this Agreement not so held to be invalid or the application of this Agreement to other circumstances not so held to be invalid.

### 5. Venue

The parties agree that this Agreement shall be interpreted, construed, and enforced in accordance with the laws of the State of Georgia. To the extent that any party brings suit to enforce the terms of this Agreement, including suit in equity, the parties agree and consent to file any such suit in the Superior Court of Hall County, Georgia.

### 6. Modification

This Agreement may not be modified, amended, or added to except in writing fully executed by all the parties hereto. This Agreement constitutes the sole and entire agreement and understanding between the parties as to the subject matter hereof, and no verbal promises have been made by any party in relation hereto.

### 7. Third Parties

This Agreement shall be binding upon and is for the benefit of the parties hereto and their respective successors in interest and assigns only and is not intended to benefit any other third party or to give rise to any duty or causes of action for any other third party.

### 8. Immunities

No provision of this Agreement is intended to nor shall it be construed to in any way waive any immunities, protections, or defenses provided to any party hereto by the laws of the State of Georgia or by federal law.

## 9. Authorization

The parties hereto specifically represent and certify that they have the power and authority under law to enter into this Agreement, and that the signatories below are authorized to sign this Agreement on behalf of each party hereto.

## 10. Remedies

In the event that any party to this Agreement breaches this Agreement, the non-breaching party or parties shall provide written notice to the breaching party which describes the breach of this Agreement. The party whose breach is alleged shall have 30 days from the date of receipt of the written notice to cure the breach or to otherwise negotiate a resolution of the breach. If the breach has not been cured and the parties hereto have not resolved the issue described in the notice letter by 30 days after receipt of the notice letter, the party or parties authoring the letter shall be entitled to seek any and all remedies allowed by Georgia law, including damages, equitable relief, declaratory relief, and/or specific performance.

#### 11. Notice

Any and all notice required hereunder shall comply with the requirements of this paragraph. Each such notice shall be in writing and shall be sent either by email, personal delivery, or mailed by registered or certified mail, return receipt requested, with postage prepaid to the appropriate party. 

3. Tenant agrees to pay to Landlord, by payments to Hall County, Landlord, who negotiated this Lease, at the office of Landlord, an annual rantal in the amount of \$1.00 which shall be paid promptly on the first day of each year in advance during the term of this Lease.

Rent shall be paid in advance on the first day of each year and shall not be considered past due by Landlord if received prior to the Tenth (10th) day of the year in which it becomes due. Any rent or outstanding balance received after the Tenth (10<sup>th</sup>) day of each year will be subject to a Fifteen Percent (15%) late fee.

## SECURITY DEPOSIT

4. No security deposit shall be required.

#### UTILITY BILLS

5. Tenant shall pay the total monthly utility bills, including, but not limited to gas, electricity, fuel, light, and heat bills for the Premises.

#### **USE OF PREMISES**

6. Premises shall be used for Transitional Housing for Workforce Development purposes and no other. Premises shall not be used for any lilegal purposes, nor in any manner to create any nuisance or trespass, nor in any manner to vitlate the insurance or increase the rate of insurance on premises.

## ABANDONMENT OF THE PREMISES

7. Tenant agrees not to abandon or vacate the Premises during the period of this Lease and agrees to use the Premises for the purposes herein until the expiration hereof.

#### REPAIRS BY LANDLORD

8. Landlord shall not be responsible for any repairs to the Premises. Landlord gives to Tenant exclusive control of the Premises and shall be under no obligations to inspect said Premises.

#### **REPAIRS BY TENANT**

9. Tenant accepts the Premises in their present condition and as sulted for the uses intended by Tenant. Tenant shall, throughout the initial term of this Lease, and any extension or renewal thereof, at its expense, maintain the Premises in good order and repair. Tenant agrees to keep in good repair the roof, including gutters and downspouts foundations and exterior walls of the Premises, and underground utility and sewer pipes outside the exterior walls of the building. Heating and air conditioning equipment (including, but not limited to replacement of parts, compressors, air handling units and heating units), and other improvements located thereon shall be the responsibility of Tenant. Tenant further agrees to care for the grounds around the building, including the parking lot and drive, the mowing of grass, paving, care of shrubs and general landscaping. Tenant agrees to return the Premises to Landlord at the expiration, or prior to termination, of this Lease in as good condition and repair as when first received, natural wear and tear, damage by storm, fire, lightning, earthquake or other casualty alone excepted.

## DESTRUCTION OF OR DAMAGE TO PREMISES

10, If the Premises are totally destroyed by storm, fire, lightning, earthquake or other casually, this Lease shall terminate as of the date of such destruction, and rental shall be accounted for as between Landlord and Tenant as of that date. If the Premises are damaged but not wholly destroyed by any such casualties, rental shall abate in such proportion as use of the Premises has been destroyed, and Landlord shall restore Premises to substantially the same condition as before damage as speedily as is practicable, whereupon full rental shall recommence. If damage cannot be repaired within sixty (60) days, Tenant shall have the option of terminating this Lease.

#### INDEMNITY

11. Tenant agrees to and hereby does, indemnify and save Landlord harmless against all claims for damages to persons or property by reason of Tenant's use or occupancy of Premises, and all expenses incurred by Landlord because thereof, including attorneys fees and court costs except those arising out of Landlord's (or lis agents, employees, or contractors) gross negligence or willful misconduct.

Tenant shall, at all times during the Lease term and at its own expense, keep in full force and effect comprehensive general liability insurance with "personal injury" coverage, with minimum limits of \$1,000,000.00 on account of bodily injuries to, or death of, one or more than one person as the result of any one accident or occurrence and \$500,000.00 on account of damage to property. Such policy shall name the Landlord as additional insured. Landlord shall not be obligated to insure any personal property of Tenant upon or within the Leased Premises, any fixtures installed or paid for by Tenant upon or within the Leased Premises, or any improvements which Tenant may construct on the Leased Premises. Tenant shall have no right in or claim to the proceeds of any policy of insurance maintained by Landlord. Tenant at all times during the term of this Lease shall, at its own expense, keep in full force and effect such Insurance on its property against fire and such other risks as Tenant deems appropriate, using "blanket" insurance coverage if it so desires.

## **GOVERNMENTAL ORDERS**

12. Tenant agrees, at his own expense, promptly to comply with all requirements of any legally constituted public authority made necessary solely by reason of Tenant's specific use the Premises. Landlord agrees promptly to comply with any such requirements if not made necessary by reason of Tenant's specific use. It is mutually agreed, however, between Landlord and Tenant, that if in order to comply with such requirements, the cost to Landlord or Tenant, as the case may be, shall exceed a sum equal to \$10,000.00, then the Landlord or Tenant who is obligated to comply with such requirements may terminate this Lease by giving written notice of termination to the other party, by registered mail, which termination shall become effective sixty (60) days after receipt of such notice, and which notice shall eliminate necessity of compliance with such requirement by party giving such notice unless party receiving such notice of termination shall, before termination becomes effective, pay to party giving notice all cost of compliance in excess of one year's rent, or secure payment of said sum in manner satisfactory to party giving notice.

#### CONDEMNATION

13. If any portion of the Premises, or such portion of the building or property as will make the Premises unusable for the purposes herein leased, condemned by any legally constituted authority or any public use or purpose, then in either of said events the term hereby granted shall cease from the date when possession thereof is taken by public authorities, and rental shall be accounted for as between Landlord and Tenant as of said date. Such termination, however, shall be without prejudice to the rights of either Landlord or Tenant to recover compensation and damage caused by condemnation from the condemner. It is further understood and agreed that neither the Tenant nor Landlord shall have any rights in any award made to the other by any condemnation authority notwithstanding the termination of the Lease as herein provided.

## ASSIGNMENT AND SUBLETTING

14. Tenant may sublease portions of the Premises to others provided such sublessee's operation is a part of the general operation of Tenant and is under the supervision and control of Tenant, creates no burden on Landlord with compliance of building codes as it relates to mulii-tenant occupancy and provided such operation is within the purposes for which the Premises shall be used. Except as provided in the preceding sentence, or with Landlord's written consent (which will not be unreasonably withheld, conditioned or delayed), Tenant shall not, without the prior written consent of Landlord endorsed hereon, assign this Lease or any interest hereunder, or sublet the Premises or any part thereof, or permit the use of the Premises by any party other than Tenant. Consent to any assignment or sublease shall not impair this provision, and all later assignments or subleases shall be made likewise only on the prior written consent of Landlord. Assignee of Tenant, at option of Landlord, shall become directly liable to Landlord for all obligations of Tenant hereunder, but no sublease or assignment by Tenant shall relieve Tenant of any llability hereunder.

## REMOVAL OF FIXTURES

15. Tenant may (if not in default hereunder) prior to the expiration of this Lease, or any extension or renewal thereof, remove all fixtures and equipment which he has placed in the Premises, provided Tenant repairs all damage to the Premises caused by such removal.

## EVENTS OF DEFAULT

16. The happening of any one or more of the following events (hereinafter any one of which may be referred to as an "Event of Default") during the term of this Lease, or any renewal or extension thereof, shall constitute a breach of this Lease on the part of the Tenant; (1) Tenant fails to pay the rental within ten (10) days of written notice; (2) Tenant abandons or vacates the Premises; (3) Tenant fails to comply with or abide by and perform any other obligation imposed upon Tenant under this Lease, and Tenant fails to take reasonable effort to cure such failure within thirty (30) days of Landlord's written notice; (4) Tenant is adjudicated bankrupt; (5) a permanent receiver is appointed for Tenant's property and such receiver is not removed within sixty (60) days after written notice from Landlord to Tenant to obtain such removal; (6) Tenant, either voluntarily or involuntarily, takes advantage of any debtor relief proceedings under any present or future law, whereby the rent or any part thereof is, or is proposed to be reduced or payment thereof deferred; (7) Tenant makes an assignment for benefit of creditors; or (8) Tenant's effects are levied upon or attached under process against Tenant, which is not satisfied or dissolved within thirty (30) days after written notice from Landlord to Tenant to obtain satisfaction thereof.

## **REMEDIES UPON DEFAULT**

17. Upon the occurrence of any Event of Default, Landlord may pursue any one or more of the following remedies, separately or concurrently, without any notice (except as specifically provided hereinafter) and without prejudice to any other remedy herein provided or provided by law: (a) If the Event of Default involves nonpayment of rental, and Tenant falls to cure such default within ten (10) days after receipt of written notice thereof from Landlord, or in the Event of Default involves a default in performing any of the terms or provisions of this Lease other than the payment of rental, and Tenant falls to cure, or fails to commence a cure, such default within thirty (30) days after the receipt at written notice of default from Landlord. Landlord may terminate this Lease by giving written notice to Tenant and, upon such termination shall be entitled to recover from the Tenant damages in an amount equal to all rental which is then due and which would otherwise have become due throughout the remaining term of this lease, or any renewal or extension thereof (as if this Lease had not been terminated); or (b) if the Event of Default Involved any matter other than those set forth in Item (a) of this Paragraph 17 the Landlord may terminate this Lease by giving written notice to Tenant and upon such termination, shall be entitled to recover from Tenant damages in an amount equal to all rent which is then due and which would otherwise have become due throughout the remaining term of this Lease or any renewal or extension thereof (as if this Lease had not been terminated): or (c) upon any Event of Default Landlord may give to Tenant written nolice of such default and advise Tenant that unless such default is cured within ten (10) days after receipt of such notice, the entire amount of the rental for the remainder of the term of this Lease or any renewal or extension thereof, shall immediately become due and payable upon the expiration of the ten day period, and thereafter, unless all the terms and provisions of this Lease are fully complied with by the Tenant within said ten-day period, the entire amount of said rental shall thereupon become immediately due and payable without further notice to Tenant; or (d) upon any Event of Default. Landlord, as Tenant's agent, without terminating this Lease may enter upon and rent the Premises, in whole or in part, at the best price obtainable by reasonable effort without advertisement and by private negotiations and for any term Landlord deems proper, with Tenant being liable to Landlord for the deficiency, if any, between Tenant's rent hereunder and the price obtained by Landlord on reletting: provided, however, that Landlord shall not be considered to be under any duly by reason of this provision to take any action to litigate damages by reason of Tenant's default.

#### EXTERIOR SIGNS

18. Any and all signs placed on the Premises by Tenant shall be maintained in compliance with rules and regulations governing such signs, and the Tenant shall be responsible to Landlord for any said signs and agrees upon removal of said signs to repair all damage incidents to such removal.

#### ENTRY FOR CARDING. ETC.

19. Landlord may card the Premises "For Rent" or "For Sale" sixty (60) days before the termination of this Lease. Landlord may enter the Premises at reasonable hours to exhibit same to prospective purchasers or tenants and to make repairs required of Landlord under the terms hereof, or to make repairs to Landlord's adjoining property, if any.

## EFFECT OF TERMINATION OF LEASE

20. No termination of this Lease prior to the normal ending thereof, by tapse of time or otherwise, shall affect Landlord's right to collect rent for the period prior to termination thereof.

#### NO ESTATE IN LAND

21. This Lease shall create the relationship of Landlord and Tenant between the parties hereto; no estate shall pass out of Landlord. Tenant has only a usufruct not subject to levy and sale, and not assignable by Tenant except by Landlord's consent.

#### HOLDING OVER

22. If Tenant remains in possession of the Premises after expiration of the term hereof, with Landlord's acquiescence and without any express agreement of partles, Tenant shall be a tenant-at-will at the rental rate which is in effect at end of Lease and there shall be no renewal of this Lease by operation of law. If Tenant remains in possession of the Premises after expiration of the term hereof without Landlords acquiescence, then Tenant shall be a tenant-at-sufferance and, commencing on the date following the date of such expiration, the annual rental payable under Paragraph 3 hereof shall, for each year, or fraction thereof, during which Tenant so remains in possession, be 150% the annual rental otherwise payable under Paragraph 3 hereof. This under either case, Tenant shall be required to vacate the building within thirty (30) days by written notice to Landlord.

## ATTORNEY'S FEE AND HOMESTEAD

23. If any rent or other sum owing under this Lease is collected by or through an attorney at law, Tenant agrees to pay fifteen percent (15%) thereof as attorney's fees. Tenant waives all homestead rights and exemptions, which he may have under any law as against any obligation owing under this Lease. Tenant hereby assigns to Landlord his homestead exemption.

## **RIGHTS CUMULATIVE**

24. All rights, powers and privileges conferred hereunder upon parties hereto shall be cumulative and not restrictive of those given by law.

#### SERVICE OF NOTICE

25. Tenant hereby appoints as his agent to receive service at all dispossessory or distrait proceedings and notices hereunder, and all notices required under this Lease, the person in charge of the Premises at the time, or occupying the Premises; and if no person is in charge of, or occupying the Premises, then such service or notice may be made by attaching the same on the main entrance to the Premises. A copy of all notices under this Lease shall also be sent to Tenant's last known address, if different from Premises.

#### WAIVER OF RIGHTS

28. No failure of Landlord to exercise any power given Landlord hereunder, or to assist upon strict compliance by Tenant of his obligations hereunder, and no custom or practice of the parties at variance with the terms hereof shall constitute a waiver at Landlord's rights to demand exact compliance with the terms hereof.

Box 1435, Gainesville, GA 30503, who is authorized to acknowledge the receipt of same.

The Lendlord, for and in consideration of the rents, covenants, agreements and stipulations hereinafter mentioned, provided for and contained, to be paid, kept and performed by the Tenant, has leased and rented, and by these presents leases and rents, unto the said Tenant, and said Tenant hereby leases and takes upon the terms and conditions which hereinafter appear, the following described property (hereinafter called "Premises"), to wit:

#### TERM

2. The Tenant shall have and hold the Premises for a term of One (1) Year, beginning on the 7th day of March, 2018 and ending on the 6th day of March, 2019, at midnight, unless sconer terminated as hereinafter provided.

#### RENTAL

3. Tenant agrees to pay to Landlord, by payments to Hall County, Landlord, who negotlated this Lease, at the office of Landlord, an annual rental in the amount of \$1.00 which shall be paid promptly on the first day of each year in advance during the term of this Lease.

Rent shall be paid in advance on the first day of each year and shall not be considered past due by Landlord If received prior to the Tenth (10th) day of the year in which it becomes due. Any rent or outstanding balance received after the Tenth (10<sup>th</sup>) day of each year will be subject to a Fifteen Percent (15%) late fee.

#### SECURITY DEPOSIT

4. No security deposit shall be required.

#### UTILITY BILLS

5. Tenant shall pay the total monthly utility bills, including, but not limited to gas, electricity, fuel, light, and heat bills for the Premises.

#### USE OF PREMISES

6. Premises shall be used for Transitional Housing for Workforce Davelopment purposes and no other. Premises shall not be used for any lilegal purposes, nor in any manner to create any nuisance or trespass, nor in any manner to vitlate the insurance or increase the rate of insurance on premises.

#### ABANDONMENT OF THE PREMISES

7. Tenant agrees not to abandon or vacate the Premises during the period of this Lease and agrees to use the Premises for the purposes herein until the expiration hereof.

#### REPAIRS BY LANDLORD

8. Landlord shall not be responsible for any repairs to the Premises. Landlord gives to Tenant exclusive control of the Premises and shall be under no obligations to inspect said Premises.

#### **REPAIRS BY TENANT**

9. Tenant accepts the Premises in their present condition and as suited for the uses intended by Tenant. Tenant shall, throughout the initial term of this Lease, and any extension or renewal thereof, at its expense, maintain the Premises in good order and repair. Tenant agrees to keep in good repair the roof, including gutters and downspouts foundations and exterior walls of the Premises, and underground utility and sower pipes outside the exterior walls of the building. Heating and air conditioning equipment (including, but not limited to replacement of parts, compressors, air handling units and heating units), and other improvements located thereon shall be the responsibility of Tenant. Tenant further agrees to care for the grounds around the building, including the parking lot and drive, the mowing of grass, paving, care of shrubs and general landscaping. Tenant agrees to return the Premises to Landlord at the expiration, or prior to termination, of this Lease in as good condition and repair as when first received, natural wear and tear, demage by storm, fire, lightning, earthquake or other casualty alone excepted.

## DESTRUCTION OF OR DAMAGE TO PREMISES

10. If the Premises are totally destroyed by storm, fire, lightning, earthquake or other casually, this Lease shall terminate as of the date of such destruction, and rental shall be accounted for as between Landlord and Tenant as of that date. If the Premises are damaged but not wholly destroyed by any such casualties, rental shall abate in such proportion as use of the Premises has been destroyed, and Landlord shall restore Premises to substantially the same condition as before damage as speedily as is practicable, whereupon full rental shall recommence. If damage cannot be repaired within sixty (60) days, Tenant shall have the option of terminating this Lease.

#### INDEMNITY

11. Tenant agrees to and hereby does, indemnify and save Landlord harmless against all claims for damages to persons or property by reason of Tenant's use or occupancy of Premises, and all expenses incurred by Landlord because thereof, including attorneys fees and court costs except those arising out of Landlord's (or its agents, employees, or contractors) gross negligence or willful misconduct.

Tenant shall, at all times during the Lease term and at its own expense, keep in full force and effect comprehensive general liability insurance with "personal injury" coverage, with minimum limits of \$1,000,000.00 on account of bodlly injuries to, or death of, one or more than one person as the result of any one accident or occurrence and \$500,000.00 on account of damage to property. Such policy shall name the Landlord as additional insured. Landlord shall not be obligated to insure any personal property of Tenant upon or within the Leased Premises, any fixtures installed or paid for by Tenant upon or within the Leased Premises, or any Improvements which Tenant may construct on the Leased Premises. Tenant shall have no right in or claim to the proceeds of any policy of insurance maintained by Landlord. Tenant at all times during the term of this Lease shall, at its own expense, keep in full force and effect such insurance on its property against fire and such other risks as Tenant deems appropriate, using "blanket" Insurance coverage if it so desires.

#### **GOVERNMENTAL ORDERS**

12. Tenant agrees, at his own expense, promptly to comply with all requirements of any legally constituted public authority made necessary solely by reason of Tenant's specific use the Premises. Landlord agrees promptly to comply with any such requirements if not made necessary by reason of Tenant's specific use. It is mutually agreed, however, between Landlord and Tenant, that if in order to comply with such requirements, the cost to Landlord or Tenant, as the case may be, shall exceed a sum equal to \$10,000.00, then the Landlord or Tenant who is obligated to comply with such requirements may terminate this Lease by giving written notice of termination to the other party, by registered mall, which termination shall become effective sixty (60) days after receipt of such notice, and which notice shall eliminate necessity of compliance with such requirement by party giving such notice unless party receiving such notice of termination shall, before termination becomes effective, pay to party giving notice all cost of compliance in excess of one year's rent, or secure payment of said sum in manner satisfactory to party giving notice.

#### CONDEMNATION

13. If any portion of the Premises, or such portion of the building or property as will make the Premises unusable for the purposes herein leased, condemned by any legally constituted authority or any public use or purpose, then in either of said events the term hereby granted shall cease from the date when possession thereof is taken by public authorities, and rental shall be accounted for as between Landlord and Tenant as of said date. Such termination, however, shall be without prejudice to the rights of either Landlord or Tenant to recover compensation and damage caused by condemnation from the condemner. It is further understood and agreed that neither the Tenant nor Landlord shall have any rights in any award made to the other by any condemnation authority notwithstanding the termination of the Lease as herein provided.

## ASSIGNMENT AND SUBLETTING

14. Tenant may sublease portions of the Premises to others provided such sublessee's operation is a part of the general operation of Tenant and is under the supervision and control of Tenant, creates no burden on Landlord with compliance of building codes as it relates to multi-tenant occupancy and provided such operation is within the purposes for which the Premises shall be used. Except as provided in the preceding sentence, or with Landlord's written consent (which will not be unreasonably withheld, conditioned or delayed), Tenant shall not, without the prior written consent of Landlord endorsed hereon, assign this Lease or any interest hereunder, or sublet the Premises or any part thereof, or permit the use of the Premises by any party other than Tenant. Consent to any assignment or sublease shall not impair this provision, and all later assignments or subleases shall be made likewise only on the prior written consent of Landlord. Assignee of Tenant, at option of Landlord, shall become directly liable to Landlord for all obligations of Tenant hereunder, but no sublease or assignment by Tenant shall relieve Tenant of any liability hereunder.

#### REMOVAL OF FIXTURES

15. Tenant may (if not in default hereunder) prior to the expiration of this Lease, or any extension or renewal thereof, remove all fixtures and equipment which he has placed in the Premises, provided Tenant repairs all damage to the Premises caused by such removal.

#### EVENTS OF DEFAULT

18. The happening of any one or more of the following events (hereinafter any one of which may be referred to as an "Event of Default") during the term of this Lease, or any renewal or extension thereof, shall constitute a breach of this Lease on the part of the Tenant; (1) Tenant fails to pay the rental within ten (10) days of written notice; (2) Tenant abandons or vacates the Premises; (3) Tenant fails to comply with or abide by and perform any other obligation imposed upon Tenant under this Lease, and Tenant fails to take reasonable effort to cure such failure within thirty (30) days of Landlord's written notice; (4) Tenant is adjudicated bankrupt; (5) a permanent receiver is appointed for Tenant's property and such receiver is not removed within sixty (60) days after written notice from Landlord to Tenant to obtain such removal; (6) Tenant, either voluntarily or Involuntarily, takes advantage of any debtor relief proceedings under any present or future law, whereby the rent or any part thereof is, or is proposed to be reduced or payment thereof deferred; (7) Tenant makes an assignment for benefit of creditors; or (8) Tenant's effects are levied upon or attached under process against Tenant, which is not satisfied or dissolved within thirty (30) days after written notice from Landlord to Tenant to obtain satisfaction thereof.

#### **REMEDIES UPON DEFAULT**

17. Upon the occurrence of any Event of Default, Landlord may pursue any one or more of the following remedies, separately or concurrently, without any notice (except as specifically provided hereinafter) and without prejudice to any other remedy herein provided or provided by law: (a) if the Event of Default involves nonpayment of rental, and Tenant fails to cure such default within ten (10) days after receipt of written notice thereof from Landlord, or in the Event of Default involves a default in performing any of the terms or provisions of this Lease other than the payment of rental, and Tenant falls to cure, or falls to commence a cure, such default within thirty (30) days after the receipt at written notice of default from Landlord. Landlord may terminate this Lease by giving written notice to Tenant and, upon such termination shall be entitled to recover from the Tenant damages in an amount equal to all rental which is then due and which would otherwise have become due throughout the remaining term of this lease, or any renewal or extension thereof (as if this Lease had not been terminated); or (b) if the Event of Default Involved any matter other than those set forth in Item (a) of this Paragraph 17 the Landlord may terminate this Lease by giving written notice to Tenant and upon such termination, shall be entitled to recover from Tenant damages in an amount equal to all rent which is then due and which would otherwise have become due throughout the remaining term of this Lease or any renewal or extension thereof (as if this Lease had not been terminated): or (c) upon any Event of Default Landlord may give to Tenant written nolice of such default and advise Tenant that unless such default is cured within ten (10) days after receipt of such notice, the entire amount of the rental for the remainder of the term of this Lease or any renewal or extension thereof, shall immediately become due and payable upon the expiration of the ten day period, and thereafter, unless all the terms and provisions of this Lease are fully complied with by the Tenant within said ten-day period, the entire amount of said rental shall thereupon become immediately due and payable without further notice to Tenant; or (d) upon any Event of Default. Landlord, as Tenant's agent, without terminating this Lease may enter upon and rent the Premises, in whole or in part, at the best price obtainable by reasonable effort without advertisement and by private negotiations and for any term Landlord deems proper, with Tenant being liable to Landlord for the deficiency, if any, between Tenant's rent hereunder and the price obtained by Landlord on reletting: provided, however, that Landlord shall not be considered to be under any duty by reason of this provision to take any action to litigate damages by reason of Tenant's default.

#### EXTERIOR SIGNS

18. Any and all signs placed on the Premises by Tenant shall be maintained in compliance with rules and regulations governing such signs, and the Tenant shall be responsible to Landlord for any said signs and agrees upon removal of said signs to repair all damage incidents to such removal.

#### ENTRY FOR CARDING, ETC.

19. Landlord may card the Premises "For Rent" or "For Sale" sixty (60) days before the termination of this Lease. Landlord may enter the Premises at reasonable hours to exhibit some to prospective purchasers or tenants and to make repairs required of Landlord under the terms hereof, or to make repairs to Landlord's adjoining property, if any.

#### EFFECT OF TERMINATION OF LEASE

20. No termination of this Lease prior to the normal ending thereof, by lapse of time or otherwise, shall affect Landlord's right to collect rent for the period prior to termination thereof.

#### NO ESTATE IN LAND

21. This Lease shall create the relationship of Landlord and Tenant between the parties hereto; no estate shall pass out of Landlord. Tenant has only a usufruct not subject to levy and sale, and not assignable by Tenant except by Landlord's consent.

#### HOLDING OVER

22. If Tenant remains in possession of the Premises after expiration of the term hereof, with Landlord's acquiescence and without any express agreement of partles, Tenant shall be a tenant-at-will at the rental rate which is in effect at end of Lease and there shall be no renewal of this Lease by operation of law. If Tenant remains in possession of the Premises after expiration of the term hereof without Landlords acquiescence, then Tenant shall be a tenant-at-sufferance and, commencing on the date following the date of such expiration, the annual rental payable under Paragraph 3 hereof shall, for each year, or fraction thereof, during which Tenant so remains in possession, be 150% the annual rental otherwise payable under Paragraph 3 hereof. This under either case, Tenant shall be required to vacate the building within thirty (30) days by written notice to Landlord.

#### ATTORNEY'S FEE AND HOMESTEAD

23. If any rent or other sum owing under this Lease is collected by or through an attorney at law, Tenant agrees to pay fifteen percent (15%) thereof as attorney's fees. Tenant walves all homestead rights and exemptions, which he may have under any law as against any obligation owing under this Lease. Tenant hereby assigns to Landlord his homestead exemption.

#### **RIGHTS CUMULATIVE**

24. All rights, powers and privileges conferred hereunder upon parties hereto shall be cumulative and not restrictive of those given by law.

#### SERVICE OF NOTICE

25. Tenant hereby appoints as his agent to receive service at all dispossessory or distrait proceedings and notices hereunder, and all notices required under this Lease, the person in charge of the Premises at the time, or accupying the Premises; and if no person is in charge of, or occupying the Premises, then such service or notice may be made by attaching the same on the main entrance to the Premises. A copy of all notices under this Lease shall also be sent to Tenant's last known address, if different from Premises.

#### WAIVER OF RIGHTS

28. No failure of Landlord to exercise any power given Landlord hereunder, or to assist upon strict compliance by Tenant of his obligations hereunder, and no custom or practice of the parties at variance with the terms hereof shall constitute a waiver at Landlord's rights to demand exact compliance with the terms hereof.



# <u>A RESOLUTION TO AMEND THE CODE OF ORDINANCES OF HALL COUNTY</u> <u>WITH REGARD TO THE INTERNATIONAL FIRE CODE</u>

WHEREAS, pursuant to Hall County Code Section 15.10.020 Hall County has adopted certain minimum standard codes, including the International Fire Code and the International Building Code, and pursuant to said Code Section, Hall County automatically adopts all amendments and revisions to said codes as they are enacted by the State of Georgia; and

**WHEREAS,** Hall County has enacted certain Code provisions relating to the International Fire Code and state minimum fire safety standards, including appeal and variance provisions; and

WHEREAS, O.C.G.A § 25-2-12 (a) (7) controls the power of Hall County to consider appeals and variances in matters relating to state minimum fire safety standards; and

WHEREAS, Hall County wishes to bring the provisions of its Code relating to appeals and variances of the state minimum fire safety standards into conformity with O.C.G.A. § 25-2-12 (a) (7) so as to provide the County's citizens and taxpayers with notice of the limitations on the County's power as it relates to such minimum fire safety standards; and

WHEREAS, the County's Board of Commissioners believes that changes to its Code of Ordinances relating to appeals and variances as to the state minimum fire safety standards as described herein are in the best interests of residents and businesses of Hall County, Georgia, and would promote the public health, safety, and general welfare of such residents and businesses.

**NOW, THEREFORE,** the Board of Commissioners does hereby amend The Official Code of Hall County, Georgia as follows:

Section 15.10.110 (International Fire Code, amendments.) of the Hall County Code is hereby amended deleting subsection (B) in its entirety, and by substituting in place thereof the following:

B. Appeals.

1. Pursuant to O.C.G.A. § 25-2-12 (a) (7), Hall County has no authority to grant a waiver or variance which would excuse any building, structure, or proposed plans for buildings or structures from compliance with the state minimum fire safety standards as adopted in the rules and regulations promulgated by the State of Georgia. Accordingly, no such waiver or variance shall be granted by Hall County.

2. A party that has been adversely affected by a decision of the County's fire code official may appeal the decision of the fire code official only when a mistake of fact has led to the determination made by the fire code official and the party appealing seeks to correct that mistake of fact. Appeals for any other reason, including appeals relating to the interpretation of the state minimum fire safety standards, are prohibited and will be immediately returned to the applicant. An applicant may file an appeal alleging a mistake of fact by submitting the appeal in writing with a full description of the alleged mistaken fact(s), together with any and all documents relating to the appeal, to the County Clerk within 30 days of the fire code determination or decision complained of.

3. The appeal shall be heard by a Hearing Officer following notice to the appellant and to the fire code official at issue. To the extent possible, the procedure for such appeals shall follow the Hearing Officer procedure utilized in Title 5 of this Code relating to suspensions or revocations of alcoholic beverage licenses. Pursuant to said procedure, the Hearing Officer shall issue a recommendation to the Board of Commissioners as to whether the fire code officer's determination is based upon a mistake of fact(s), and if so, shall identify said mistake and recommend a correction of said mistaken fact(s). The Board of Commissioners shall either approve or deny the recommendation of the Hearing Officer without public hearing based upon the recommendation and supporting documents submitted to the Board by the Hearing Officer. If the Board decides that a mistake of fact has led to the determination by the fire code official, then the Board shall identify said fact (if not already identified by the Hearing Officer's recommendation), and the fire code official shall apply all the provisions of the fire code, including the state minimum fire safety standards, to the corrected fact(s).

2.

The remaining provisions of Section 15.10.110 of the Hall County Code of Ordinances shall remain as they were, unchanged by this amendment.

- "Documentation" means any online or written documentation related to the use or functionality of the Tyler Software that we provide or otherwise make available to you, including instructions, user guides, manuals and other training or self-help documentation.
- "Effective Date" means the date by which both your and our authorized representatives have signed the Agreement.
- **"Force Majeure"** means an event beyond the reasonable control of you or us, including, without limitation, governmental action, war, riot or civil commotion, fire, natural disaster, or any other cause that could not with reasonable diligence be foreseen or prevented by you or us.
- "Investment Summary" means the agreed upon cost proposal for the products and services attached as Exhibit A.
- "Invoicing and Payment Policy" means the invoicing and payment policy. A copy of our current



Invoicing and Payment Policy is attached as Exhibit B.

- "SaaS Fees" means the fees for the SaaS Services identified in the Investment Summary.
- "SaaS Services" means software as a service consisting of system administration, system management, and system monitoring activities that Tyler performs for the Tyler Software, and includes the right to access and use the Tyler Software, receive maintenance and support on the Tyler Software, including Downtime resolution under the terms of the SLA, and Data storage and archiving. SaaS Services do not include support of an operating system or hardware, support outside of our normal business hours, or training, consulting or other professional services.

- "we", "us", "our" and similar terms mean Tyler.
- "you" and similar terms mean Client.

#### SECTION B - SAAS SERVICES

- 1. <u>Rights Granted</u>. We grant to you the non-exclusive, non-assignable limited right to use the SaaS Services solely for your internal business purposes for the number of Defined Users only. The Tyler Software will be made available to you according to the terms of the SLA. You acknowledge that we have no delivery obligations and we will not ship copies of the Tyler Software as part of the SaaS Services. You may use the SaaS Services to access updates and enhancements to the Tyler Software, as further described in Section C(9). The foregoing notwithstanding, to the extent we have sold you perpetual licenses for Tyler Software, if and listed in the Investment Summary, for which you are receiving SaaS Services, your rights to use such Tyler Software are perpetual, subject to the terms and conditions of this Agreement including, without limitation, Section B(4). We will make any such software available to you for download.
- 2. SaaS Fees. You agree to pay us the SaaS Fees. Those amounts are payable in accordance with our



Invoicing and Payment Policy. The SaaS Fees are based on the number of Defined Users and amount of Data Storage Capacity. You may add additional users or additional data storage capacity on the terms set forth in Section H(1). In the event you regularly and/or meaningfully exceed the Defined Users or Data Storage Capacity, we reserve the right to charge you additional fees commensurate with the overage(s).

- 3. Ownership.
  - 3.1 We retain all ownership and intellectual property rights to the SaaS Services, the Tyler Software, and anything developed by us under this Agreement. You do not acquire under this Agreement any license to use the Tyler Software in excess of the scope and/or duration of the SaaS Services.
  - 3.2 The Documentation is licensed to you and may be used and copied by your employees for internal, non-commercial reference purposes only.
  - 3.3 You retain all ownership and intellectual property rights to the Data. You expressly recognize that except to the extent necessary to carry out our obligations contained in this Agreement, we do not create or endorse any Data used in connection with the SaaS Services.
- 4. <u>Restrictions</u>. You may not: (a) make the Tyler Software or Documentation resulting from the SaaS Services available in any manner to any third party for use in the third party's business operations; (b) modify, make derivative works of, disassemble, reverse compile, or reverse engineer any part of the SaaS Services; (c) access or use the SaaS Services in order to build or support, and/or assist a third party in building or supporting, products or services competitive to us; or (d) license, sell, rent, lease, transfer, assign, distribute, display, host, outsource, disclose, permit timesharing or service bureau use, or otherwise commercially exploit or make the SaaS Services, Tyler Software, or Documentation available to any third party other than as expressly permitted by this Agreement.

#### 6. SaaS Services.

For purposes of this subsection, RPO represents the maximum tolerable period during which your Data may be lost, measured in relation to a disaster we declare, said declaration will not be unreasonably withheld.
- 6.4 In the event we declare a disaster, our Recovery Time Objective ("RTO") is twenty-four (24) hours. For purposes of this subsection, RTO represents the amount of time, after we declare a disaster, within which your access to the Tyler Software must be restored.
- 6.5 We conduct annual penetration testing of either the production network and/or web application to be performed. We will maintain industry standard intrusion detection and prevention systems to monitor malicious activity in the network and to log and block any such activity. We will provide you with a written or electronic record of the actions taken by us in the event that any unauthorized access to your database(s) is detected as a result of our security protocols. We will undertake an additional security audit, on terms and timing to be mutually agreed to by the parties, at your written request. You may not attempt to bypass or subvert security restrictions in the SaaS Services or environments related to the Tyler Software. Unauthorized attempts to access files, passwords or other confidential information, and unauthorized vulnerability and penetration test scanning of our network and systems (hosted or otherwise) is prohibited without the prior written approval of our IT Security Officer.
- 6.6 We test our disaster recovery plan on an annual basis. Our standard test is not client-specific. Should you request a client-specific disaster recovery test, we will work with you to schedule and execute such a test on a mutually agreeable schedule. At your written request, we will provide test results to you within a commercially reasonable timeframe after receipt of the request.
- 6.7 We will be responsible for importing back-up and verifying that you can log-in. You will be responsible for running reports and testing critical processes to verify the returned Data.
- 6.8 We provide secure Data transmission paths between each of your workstations and our servers.
- 6.9 Tyler data centers are accessible only by authorized personnel with a unique key entry. All other visitors to Tyler data centers must be signed in and accompanied by authorized personnel. Entry attempts to the data center are regularly audited by internal staff and external auditors to ensure no unauthorized access.
- 6.10 Where applicable with respect to our applications that take or process card payment data, we are responsible for the security of cardholder data that we possess, including functions relating to storing, processing, and transmitting of the cardholder data and affirm that, as of the Effective Date, we comply with applicable requirements to be considered PCI DSS compliant and have performed the necessary steps to validate compliance with the PCI DSS. We agree to



supply the current status of our PCI DSS compliance program in the form of an official Attestation of Compliance, which can be found at https://www.tylertech.com/about-us/compliance, and in the event of any change in our status, will comply with applicable notice requirements.

# SECTION C-PROFESSIONAL SERVICES

- 1. <u>Professional Services</u>. We will provide you the various implementation-related services itemized in the Investment Summary and described in the Statement of Work.
- 2. <u>Professional Services Fees</u>. You agree to pay us the professional services fees in the amounts set forth in the Investment Summary. Those amounts are based on the scope of the project as of the Effective Date and are payable in accordance with our Invoicing and Payment Policy. We will bill you the actual fees incurred based on the in-scope services provided to you, up to the maximum amounts set forth in the Investment Summary. Any discrepancies in the total values set forth in the Investment Summary.
- 3. <u>Additional Services</u>. The Investment Summary contains, and the Statement of Work describes, the scope of services and related costs (including programming and/or interface estimates) required for the project based on our understanding of the specifications you supplied. If additional work is required, or if you use or request additional services, we will provide you with an addendum or change order, as applicable, outlining the costs for the additional work. The price quotes in the addendum or change order will be valid for thirty (30) days from the date of the quote.
- 4. <u>Cancellation</u>. If travel is required, we will make all reasonable efforts to schedule travel for our personnel, including arranging travel reservations, at least two (2) weeks in advance of commitments. Therefore, if you cancel services less than two (2) weeks in advance (other than for Force Majeure or breach by us), you will be liable for all (a) non-refundable expenses incurred by us on your behalf, and (b) daily fees associated with cancelled professional services if we are unable to reassign our personnel. We will make all reasonable efforts to reassign personnel in the event you cancel within two (2) weeks of scheduled commitments.
- 5. <u>Services Warranty</u>. We will perform the services in a professional, workmanlike manner, consistent with industry standards. In the event we provide services that do not conform to this warranty, we will re-perform such services at no additional cost to you.
- 6. <u>Site Access and Requirements</u>. At no cost to us, you agree to provide us with full and free access to your personnel, facilities, and equipment as may be reasonably necessary for us to provide implementation services, subject to any reasonable security protocols or other written policies provided to us as of the Effective Date, and thereafter as mutually agreed to by you and us.
- 7. <u>Background Checks</u>. For at least the past twelve (12) years, all of our employees have undergone criminal background checks prior to hire. All employees sign our confidentiality agreement and security policies.
- 8. <u>Client Assistance</u>. You acknowledge that the implementation of the Tyler Software is a cooperative process requiring the time and resources of your personnel. You agree to use all reasonable efforts to cooperate with and assist us as may be reasonably required to meet the agreed upon project

deadlines and other milestones for implementation. This cooperation includes at least working with us to schedule the implementation-related services outlined in this Agreement. We will not be liable for failure to meet any deadlines and milestones when such failure is due to Force Majeure or to the failure by your personnel to provide such cooperation and assistance (either through action or omission).

- 9. <u>Maintenance and Support</u>. For so long as you timely pay your SaaS Fees according to the Invoicing and Payment Policy, then in addition to the terms set forth in the SLA and the Support Call Process, we will:
  - 9.1 perform our maintenance and support obligations in a professional, good, and workmanlike manner, consistent with industry standards, to resolve Defects in the Tyler Software (subject to any applicable release life cycle policy);
  - 9.2 provide support during our established support hours;
  - 9.3 maintain personnel that are sufficiently trained to be familiar with the Tyler Software and Third Party Software, if any, in order to provide maintenance and support services;
  - 9.4 make available to you all releases to the Tyler Software (including updates and enhancements) that we make generally available without additional charge to customers who have a maintenance and support agreement in effect; and
  - 9.5 provide non-Defect resolution support of prior releases of the Tyler Software in accordance with any applicable release life cycle policy.

We will use all reasonable efforts to perform support services remotely. Currently, we use a third-party secure unattended connectivity tool called Bomgar, as well as GotoAssist by Citrix. Therefore, you agree to maintain a high-speed internet connection capable of connecting us to your PCs and server(s). You agree to provide us with a login account and local administrative privileges as we may reasonably require to perform remote services. We will, at our option, use the secure connection to assist with proper diagnosis and resolution, subject to any reasonably applicable security protocols. If we cannot resolve a support issue remotely, we may be required to provide onsite services. In such event, we will be responsible for our travel expenses, unless it is determined that the reason onsite support was required was a reason outside our control. Either way, you agree to provide us with full and free access to the Tyler Software, working space, adequate facilities within a reasonable distance from the equipment, and use of machines, attachments, features, or other equipment reasonably necessary for us to provide the maintenance and support services, all at no charge to us. We strongly recommend that you also maintain your VPN for backup connectivity purposes.

For the avoidance of doubt, SaaS Fees do not include the following services: (a) onsite support (unless Tyler cannot remotely correct a Defect in the Tyler Software, as set forth above); (b) application design; (c) other consulting services; or (d) support outside our normal business hours as listed in our thencurrent Support Call Process. Requested services such as those outlined in this section will be billed to you on a time and materials basis at our then current rates. You must request those services with at least one (1) weeks' advance notice.



# SECTION D - THIRD PARTY PRODUCTS

- 1. <u>Third Party Hardware</u>. We will sell, deliver, and install onsite the Third Party Hardware, if you have purchased any, for the price set forth in the Investment Summary. Those amounts are payable in accordance with our Invoicing and Payment Policy.
- <u>Third Party Software</u>. As part of the SaaS Services, you will receive access to the Third Party Software and related documentation for internal business purposes only. Your rights to the Third Party Software will be governed by the Third Party Terms.
- 3. Third Party Products Warranties.
  - 3.1 We are authorized by each Developer to grant access to the Third Party Software.
  - 3.2 The Third Party Hardware will be new and unused, and upon payment in full, you will receive free and clear title to the Third Party Hardware.
  - 3.3 You acknowledge that we are not the manufacturer of the Third Party Products. We do not warrant or guarantee the performance of the Third Party Products. However, we grant and pass through to you any warranty that we may receive from the Developer or supplier of the Third Party Products.
- <u>Third Party Services</u>. If you have purchased Third Party Services, those services will be provided independent of Tyler by such third-party at the rates set forth in the Investment Summary and in accordance with our Invoicing and Payment Policy.

# SECTION E - INVOICING AND PAYMENT; INVOICE DISPUTES

- 1. <u>Invoicing and Payment</u>. We will invoice you the SaaS Fees and fees for other professional services in the Investment Summary per our Invoicing and Payment Policy, subject to Section E(2).
- 2. <u>Invoice Disputes</u>. If you believe any delivered software or service does not conform to the warranties in this Agreement, you will provide us with written notice within thirty (30) days of your receipt of the applicable invoice. The written notice must contain reasonable detail of the issues you contend are in dispute so that we can confirm the issue and respond to your notice with either a justification of the invoice, an adjustment to the invoice, or a proposal addressing the issues presented in your notice. We will work with you as may be necessary to develop an action plan that outlines reasonable steps to be taken by each of us to resolve any issues presented in your notice. You may withhold payment of the amount(s) actually in dispute, and only those amounts, until we complete the action items outlined in the plan. If we are unable to complete the action items outlined in the invoice. We reserve the right to suspend delivery of all SaaS Services, including maintenance and support services, if you fail to pay an invoice not disputed as described above within fifteen (15) days of notice of our intent to do so.



# SECTION F - TERM AND TERMINATION

- <u>Term</u>. The initial term of this Agreement is five (5) years, comprising a first one (1) year term plus four (4) additional one (1) year renewal terms, (collectively, the "Initial Term"), from the first day of the first month following the Effective Date, unless earlier terminated as set forth below. For the avoidance of doubt, the parties agree that this Agreement shall terminate absolutely and without further obligation on the part of the Client at the end of each year of the Initial Term and every subsequent renewal term thereafter. Upon expiration of the Initial Term, this Agreement will renew automatically for additional one (1) year renewal terms at our then-current SaaS Fees unless terminated in writing by either party at least sixty (60) days prior to the end of the then-current renewal term. Your right to access or use the Tyler Software and the SaaS Services will terminate at the end of this Agreement.
- Termination. This Agreement may be terminated as set forth below. In the event of termination, you will pay us for all undisputed fees and expenses related to the software, products, and/or services you have received, or we have incurred or delivered, prior to the effective date of termination. Disputed fees and expenses in all terminations other than your termination for cause must have been submitted as invoice disputes in accordance with Section E(2).
  - 2.1 Failure to Pay SaaS Fees. You acknowledge that continued access to the SaaS Services is contingent upon your timely payment of SaaS Fees. If you fail to timely pay the SaaS Fees, we may discontinue the SaaS Services and deny your access to the Tyler Software. We may also terminate this Agreement if you don't cure such failure to pay within forty-five (45) days of receiving written notice of our intent to terminate.
  - 2.2 For Cause. If you believe we have materially breached this Agreement, you will invoke the Dispute Resolution clause set forth in Section H(3). You may terminate this Agreement for cause in the event we do not cure, or create a mutually agreeable action plan to address, a material breach of this Agreement within the thirty (30) day window set forth in Section H(3).
  - 2.3 <u>Force Majeure</u>. Either party has the right to terminate this Agreement if a Force Majeure event suspends performance of the SaaS Services for a period of forty-five (45) days or more.
  - 2.4 <u>Lack of Appropriations</u>. If you should not appropriate or otherwise make available funds sufficient to utilize the SaaS Services, you may unilaterally terminate this Agreement upon thirty (30) days written notice to us. You will not be entitled to a refund or offset of previously paid, but unused SaaS Fees. You agree not to use termination for lack of appropriations as a substitute for termination for convenience.
  - 2.5 <u>Fees for Termination without Cause during Initial Term</u>. If you terminate this Agreement during the Initial Term for any reason other than cause, Force Majeure, or lack of appropriations, or if we terminate this Agreement during the Initial Term for your failure to pay SaaS Fees, you shall pay us the following early termination fees:
    - a. if you terminate during the first year of the Initial Term, 100% of the SaaS Fees through the date of termination plus 25% of the SaaS Fees then due for the remainder of the Initial Term;



- b. if you terminate during the second year of the Initial Term, 100% of the SaaS Fees through the date of termination plus 15% of the SaaS Fees then due for the remainder of the Initial Term; and
- c. if you terminate after the second year of the Initial Term, 100% of the SaaS Fees through the date of termination plus 10% of the SaaS Fees then due for the remainder of the Initial Term.

#### SECTION G - INDEMNIFICATION, LIMITATION OF LIABILITY AND INSURANCE

- 1. Intellectual Property Infringement Indemnification.
  - 1.1 We will defend you against any third party claim(s) that the Tyler Software or Documentation infringes that third party's patent, copyright, or trademark, or misappropriates its trade secrets, and will pay the amount of any resulting adverse final judgment (or settlement to which we consent). You must notify us promptly in writing of the claim and give us sole control over its defense or settlement. You agree to provide us with reasonable assistance, cooperation, and information in defending the claim at our expense.
  - 1.2 Our obligations under this Section G(1) will not apply to the extent the claim or adverse final judgment is based on your use of the Tyler Software in contradiction of this Agreement, including with non-licensed third parties, or your willful infringement.
  - 1.3 If we receive information concerning an infringement or misappropriation claim related to the Tyler Software, we may, at our expense and without obligation to do so, either: (a) procure for you the right to continue its use; (b) modify it to make it non-infringing; or (c) replace it with a functional equivalent, in which case you will stop running the allegedly infringing Tyler Software immediately. Alternatively, we may decide to litigate the claim to judgment, in which case you may continue to use the Tyler Software consistent with the terms of this Agreement.
  - 1.4 If an infringement or misappropriation claim is fully litigated and your use of the Tyler Software is enjoined by a court of competent jurisdiction, in addition to paying any adverse final judgment (or settlement to which we consent), we will, at our option, either: (a) procure the right to continue its use; (b) modify it to make it non-infringing; or (c) replace it with a functional equivalent. This section provides your exclusive remedy for third party copyright, patent, or trademark infringement and trade secret misappropriation claims.

# 2. General Indemnification.

2.1 We will indemnify and hold harmless you and your agents, officials, and employees from and against any and all third-party claims, losses, liabilities, damages, costs, and expenses (including reasonable attorney's fees and costs) for (a) personal injury or property damage to the extent caused by our negligence or willful misconduct; or (b) our violation of PCI-DSS requirements or a law applicable to our performance under this Agreement. You must notify us promptly in writing of the claim and give us sole control over its defense or settlement. You agree to provide us with reasonable assistance, cooperation, and information in defending the claim at our expense.



- 2.2 To the extent permitted by applicable law, you will indemnify and hold harmless us and our agents, officials, and employees from and against any and all third-party claims, losses, liabilities, damages, costs, and expenses (including reasonable attorney's fees and costs) for personal injury or property damage to the extent caused by your negligence or willful misconduct; or (b) your violation of a law applicable to your performance under this Agreement. We will notify you promptly in writing of the claim and will give you sole control over its defense or settlement. We agree to provide you with reasonable assistance, cooperation, and information in defending the claim at your expense.
- 3. <u>DISCLAIMER</u>. EXCEPT FOR THE EXPRESS WARRANTIES PROVIDED IN THIS AGREEMENT AND TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, WE HEREBY DISCLAIM ALL OTHER WARRANTIES AND CONDITIONS, WHETHER EXPRESS, IMPLIED, OR STATUTORY, INCLUDING, BUT NOT LIMITED TO, ANY IMPLIED WARRANTIES, DUTIES, OR CONDITIONS OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.
- 4. <u>LIMITATION OF LIABILITY</u>. EXCEPT AS OTHERWISE EXPRESSLY SET FORTH IN THIS AGREEMENT, OUR LIABILITY FOR DAMAGES ARISING OUT OF THIS AGREEMENT, WHETHER BASED ON A THEORY OF CONTRACT OR TORT, INCLUDING NEGLIGENCE AND STRICT LIABILITY, SHALL BE LIMITED TO YOUR ACTUAL DIRECT DAMAGES, NOT TO EXCEED (A) DURING THE INITIAL TERM, AS SET FORTH IN SECTION F(1), TOTAL FEES PAID AS OF THE TIME OF THE CLAIM; OR (B) DURING ANY RENEWAL TERM, THE THEN-CURRENT ANNUAL SAAS FEES PAYABLE IN THAT RENEWAL TERM. THE PARTIES ACKNOWLEDGE AND AGREE THAT THE PRICES SET FORTH IN THIS AGREEMENT ARE SET IN RELIANCE UPON THIS LIMITATION OF LIABILITY AND TO THE MAXIMUM EXTENT ALLOWED UNDER APPLICABLE LAW, THE EXCLUSION OF CERTAIN DAMAGES, AND EACH SHALL APPLY REGARDLESS OF THE FAILURE OF AN ESSENTIAL PURPOSE OF ANY REMEDY. THE FOREGOING LIMITATION OF LIABILITY SHALL NOT APPLY TO CLAIMS THAT ARE SUBJECT TO SECTIONS G(1) AND G(2).
- 5. <u>EXCLUSION OF CERTAIN DAMAGES</u>. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT SHALL WE BE LIABLE FOR ANY SPECIAL, INCIDENTAL, PUNITIVE, INDIRECT, OR CONSEQUENTIAL DAMAGES WHATSOEVER, EVEN IF WE HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.
- 6. <u>Insurance</u>. During the course of performing services under this Agreement, we agree to maintain the following levels of insurance: (a) Commercial General Liability of at least \$1,000,000; (b) Automobile Liability of at least \$1,000,000; (c) Professional Liability of at least \$1,000,000; (d) Workers Compensation complying with applicable statutory requirements; and (e) Excess/Umbrella Liability of at least \$5,000,000. We will add you as an additional insured to our Commercial General Liability and Automobile Liability policies, which will automatically add you as an additional insured to our Excess/Umbrella Liability policy as well. We will provide you with copies of certificates of insurance upon your written request.

# SECTION H - GENERAL TERMS AND CONDITIONS

 <u>Additional Products and Services</u>. You may purchase additional products and services at the rates set forth in the Investment Summary for twelve (12) months from the Effective Date by executing a mutually agreed addendum. If no rate is provided in the Investment Summary, or those twelve (12) months have expired, you may purchase additional products and services at our then-current list price, also by executing a mutually agreed addendum. The terms of this Agreement will control any



such additional purchase(s), unless otherwise specifically provided in the addendum.

- 2. <u>Optional Items</u>. Pricing for any listed optional products and services in the Investment Summary will be valid for twelve (12) months from the Effective Date.
- 3. <u>Dispute Resolution</u>. You agree to provide us with written notice within thirty (30) days of becoming aware of a dispute. You agree to cooperate with us in trying to reasonably resolve all disputes, including, if requested by either party, appointing a senior representative to meet and engage in good faith negotiations with our appointed senior representative. Senior representatives will convene within thirty (30) days of the written dispute notice, unless otherwise agreed. All meetings and discussions between senior representatives will be deemed confidential settlement discussions not subject to disclosure under Federal Rule of Evidence 408 or any similar applicable state rule. If we fail to resolve the dispute, then the parties shall participate in non-binding mediation in an effort to resolve the dispute. If the dispute remains unresolved after mediation, then either of us may assert our respective rights and remedies in a court of competent jurisdiction. Nothing in this section shall prevent you or us from seeking necessary injunctive relief during the dispute resolution procedures.
- 4. <u>Taxes</u>. The fees in the Investment Summary do not include any taxes, including, without limitation, sales, use, or excise tax. If you are a tax-exempt entity, you agree to provide us with a tax-exempt certificate. Otherwise, we will pay all applicable taxes to the proper authorities and you will reimburse us for such taxes. We will post, where appropriate, all notices related to nondiscrimination as may be required by applicable law.
- <u>E-Verify</u>. We have complied, and will comply, with the E-Verify procedures administered by the U.S. Citizenship and Immigration Services Verification Division for all of our employees assigned to your project.
- 7. <u>Subcontractors</u>. We will not subcontract any services under this Agreement without your prior written consent, not to be unreasonably withheld.
- 8. <u>Binding Effect; No Assignment</u>. This Agreement shall be binding on, and shall be for the benefit of, either your or our successor(s) or permitted assign(s). Neither party may assign this Agreement without the prior written consent of the other party; provided, however, your consent is not required for an assignment by us as a result of a corporate reorganization, merger, acquisition, or purchase of substantially all of our assets.
- 9. Force Majeure. Except for your payment obligations, neither party will be liable for delays in



performing its obligations under this Agreement to the extent that the delay is caused by Force Majeure; provided, however, that within ten (10) business days of the Force Majeure event, the party whose performance is delayed provides the other party with written notice explaining the cause and extent thereof, as well as a request for a reasonable time extension equal to the estimated duration of the Force Majeure event.

- 10. <u>No Intended Third Party Beneficiaries</u>. This Agreement is entered into solely for the benefit of you and us. No third party will be deemed a beneficiary of this Agreement, and no third party will have the right to make any claim or assert any right under this Agreement. This provision does not affect the rights of third parties under any Third Party Terms.
- 11. Entire Agreement; Amendment. This Agreement represents the entire agreement between you and us with respect to the subject matter hereof, and supersedes any prior agreements, understandings, and representations, whether written, oral, expressed, implied, or statutory. Purchase orders submitted by you, if any, are for your internal administrative purposes only, and the terms and conditions contained in those purchase orders will have no force or effect. This Agreement may only be modified by a written amendment signed by an authorized representative of each party.
- Severability. If any term or provision of this Agreement is held invalid or unenforceable, the remainder of this Agreement will be considered valid and enforceable to the fullest extent permitted by law.
- 13. <u>No Waiver</u>. In the event that the terms and conditions of this Agreement are not strictly enforced by either party, such non-enforcement will not act as or be deemed to act as a waiver or modification of this Agreement, nor will such non-enforcement prevent such party from enforcing each and every term of this Agreement thereafter.
- 14. Independent Contractor. We are an independent contractor for all purposes under this Agreement.
- 15. <u>Notices</u>. All notices or communications required or permitted as a part of this Agreement, such as notice of an alleged material breach for a termination for cause or a dispute that must be submitted to dispute resolution, must be in writing and will be deemed delivered upon the earlier of the following: (a) actual receipt by the receiving party; (b) upon receipt by sender of a certified mail, return receipt signed by an employee or agent of the receiving party; (c) upon receipt by sender of proof of email delivery; or (d) if not actually received, five (5) days after deposit with the United States Postal Service authorized mail center with proper postage (certified mail, return receipt requested) affixed and addressed to the other party at the address set forth on the signature page hereto or such other address as the party may have designated by proper notice. The consequences for the failure to receive a notice due to improper notification by the intended receiving party of a change in address will be borne by the intended receiving party.
- 16. <u>Client Lists</u>. You agree that we may identify you by name in client lists, marketing presentations, and promotional materials.
- 17. <u>Confidentiality</u>. Both parties recognize that their respective employees and agents, in the course of performance of this Agreement, may be exposed to confidential information and that disclosure of such information could violate rights to private individuals and entities, including the parties. Confidential information is nonpublic information that a reasonable person would believe to be

The evaluation committee for Bid #43-020 chose Planning Communities, LLC. after evaluating each proposal presented. The proposed price is well within the budget for this project as well.

#### History:

GHMPO is seeking a consultant to develop a Zero Emission Vehicle Transition Plan for Hall Area Transit. Hall Area transit currently serves all of Hall County, including all municipalities. Hall Area Transit currently operates a Microtransit on-demand service called WeGo. Hall Area Transit (HAT) is a part of the Gainesville/Hall County Community Services department in Gainesville, Georgia, and provides transit services in the City of Gainesville as well as throughout Hall County, Georgia. Historical data of each transit service operated by HAT before introducing the agency's WeGo micro-transit service, according to the transit agency's National Transit Database (NTD) 2020 agency profile. HAT's service area covers 361 square miles and is capped at 199,999 people by NTD.

#### Facts and Issues:

**Options:** 

WeGo is available on-demand with 15-minute wait times in Gainesville and up to 45-minute wait times in Hall County, operating weekdays from 6 am to 6 pm. One-way trips up to five miles in length cost \$2.00 and trips longer than five miles cost \$2.00 plus \$0.50 for each mile over five miles. Fares are paid with credit, debit, or prepaid cards stored in the Via app or using a pre-purchased voucher.

WeGo is a service operated in partnership with Via Transportation, Inc. Via supplies the necessary technology (user-facing app, website, call center, and back-office data portal for KCM), and the City of Gainesville drivers operate a fleet of 17 ADA-accessible city-owned vehicles (shown in Figure 2). HAT acts as the service administrator and provides funding for the service.

Additionally, the selection of a hybrid service model (a contract for use of Via's technology with city drivers and vehicles) was strategically designed to act as a failsafe—if the new service model was not well-accepted it could easily be transitioned to another service without the need to hire drivers or purchase vehicles.

#### ARTICLE #106 - CONTRACT AMENDMENTS AND MODIFICATION:

This Contract can only be modified, amended, or added to in writing and fully executed by both parties hereto. This Contract document constitutes the sole and entire Contract and understanding between the parties as to the subject matter hereof, and no verbal promises have been made by either party in relation hereto.

# ARTICLE # 107 - REMEDIES AND CONTRACT PERFORMANCE:

In the event that either party to this Contract breaches this Contract, including by failure to meet the timetables set forth herein, the non-breaching party shall provide written notice to the breaching party which describes the breach of this Contract. The party whose breach is alleged shall have thirty (30) days from the date of receipt of the written notice to cure the breach or to otherwise negotiate a resolution of the breach.

If the breach has not been cured and the parties hereto have not resolved the issue described in the notice letter by thirty (30) days after receipt of the notice letter, the party authoring the letter shall be entitled to seek any and all remedies allowed by Georgia law, including damages, equitable relief, declaratory relief, specific performance, and/or seeking relief as to any bonds issued hereon. Additional provisions are;

A. Delay or Impossibility of Performance. Any failure or delay must be beyond the control of and without the fault or negligence of the Contractor. If the Services to be provided to the County are interrupted by a Force Majeure Event, as defined below, the County will be entitled to an equitable adjustment to the fees and other payments due to the Contractor under this Contract. If delay results from a subcontractor's negligent conduct or failure to perform, the Contractor shall not be excused from compliance with the terms and obligations of the Contract.

Epidemics and pandemics are not considered Force Majeure events by the County.

Neither party shall be held liable or responsible to the other party nor be deemed to have defaulted under or breached this Agreement for failure or delay in fulfilling or performing any obligation under this Agreement when such failure or delay is caused by or results from causes beyond the reasonable control of the affected party, including but not limited to fire, floods, embargoes, war, acts of war, insurrections, riots, strikes, lockouts or other labor disturbances, or acts of God; provided, however, that the party so affected shall use reasonable commercial efforts to avoid or remove such causes of nonperformance, and shall continue performance hereunder with reasonable dispatch whenever such causes are removed. Either party shall provide the other party with prompt written notice of any delay or failure to perform that occurs by reason of Force Majeure.

**Definition:** The term 'force majeure' as defined in Black's Law Dictionary, is 'an event or effect that can be neither anticipated nor controlled. It is a contractual provision allocating the risk of loss if performance becomes impossible or impracticable, especially as a result of an event that the parties could not have anticipated or controlled."

- **B. Obligations beyond Contract Term**. The Contract shall remain in full force and effect to the end of the specified term or until terminated or canceled pursuant to the Contract.
- **C.** Transition Cooperation with the County and Cooperation with other Contractors. Contractor agrees that upon termination of this Contract for any reason, it shall provide sufficient efforts and reasonable cooperation and assistance to the County to ensure an orderly and efficient transition to the County or an alternative Contractor. Further, in the event that the County has entered into or enters into contracts with other Contractors related to the Services, Contractor agrees to cooperate fully with such other Contractors. Contractor shall not engage in any act that will interfere with the performance of work by any other Contractor.

#### **ARTICLE # 108 - TERMINATION:**

Either party may terminate this Contract by providing thirty (30) days written notice to the other party at any time. Should either party terminate this Contract prior to the date of automatic termination pursuant to section 4 above, Contractor shall provide the County with all deliverables up to the date of termination (30 days after the notice is provided), and the County shall pay the Contractor for all work properly performed in compliance with the terms of the Contract up to the date of termination.

- A. **Termination for Convenience**. Following thirty (30) days written notice, either party may terminate the Contract in whole or in part for any reason without the payment of any penalty or incurring any further obligation to the Contractor.
- B. **Termination for Cause**. The occurrence of any one or more of the following events shall constitute cause for the County to declare the Contractor in default of its obligations under the Contract:
  - 1. The Contractor fails to deliver or has delivered nonconforming Services or fails to perform, to the County's satisfaction, any material requirement of the Contract or is in violation of a material provision of the Contract, including, but without limitation, the express warranties made by the Contractor.
  - 2. The County determines that satisfactory performance of the Contract is substantially endangered or that a default is likely to occur.
  - 3. The Contractor fails to make substantial and timely progress toward performance of the Contract.
  - 4. The Contractor becomes subject to any bankruptcy or insolvency proceeding under federal or state law to the extent allowed by applicable federal or state law including bankruptcy laws; the Contractor terminates or suspends its business; or the County reasonably believes that the Contractor has become insolvent or unable to pay its obligations as they accrue consistent with applicable federal or state law.
  - 5. The Contractor has failed to comply with applicable federal, state and local laws, rules, County ordinances, regulations and orders when performing within the scope of the Contract.
  - 6. The Contractor has engaged in conduct that has or may expose the County or the State to liability, as determined in the County's sole discretion; or a material breach of the terms of the Contract by County upon County's failure to cure such material breach after written notice thereof has been delivered in accordance with ARTICLE #108.C. below constitutes cause for the Contractor to declare that the County is in default of its obligations under the Contract.
  - **C.** Notice of Default. If either party causes one or more of the default events set out in ARTICLE #108, then either party shall issue a written Notice-of-Default to the party that causes one or more of the default events, requesting that the breach or noncompliance be remedied within the period of time specified in the party's Notice-of-Default to the Contractor. If the breach or noncompliance is not remedied within the period of time specified in the written notice, the non-breaching party may:

- 1. Immediately terminate the Contract for default without additional written notice;
- 2. In the event of a breach by the Contractor, the County may procure substitute Services from another source and charge the difference between the Contract and the substitute Contract to the defaulting Contractor; and/or,
- 3. Enforce the terms and conditions of the Contract and seek any legal or equitable remedies.

# C. Termination Due to Non-Availability of Funds.

This Contract will terminate immediately and absolutely if the County determines that adequate funds are de-appropriated such that the County cannot fulfill its obligations under the Contract, such determination being at the County's sole discretion and conclusive. County agrees to provide prompt written notice to Contractor in the event of any de-appropriation.

# D. Termination due to Failure of Contractor to Act.

The County may terminate the Contract for any one or more of the following reasons effective immediately without advance notice:

- 1. In the event that the Contractor must be certified or licensed as a condition precedent to providing the Services, the revocation or loss of such license or certification may result in immediate termination of the Contract effective as of the date on which the license or certification is no longer in effect.
- 2. The County determines that the actions, or failure to act, of the Contractor, its agents, employees or sub-Contractors have caused, or reasonably could cause, life, health or safety to be jeopardized.
- 3. The Contractor furnished any statement, representation, or certification in connection with the Contract or the bidding process, which is materially false, deceptive, criminal activity, incorrect or incomplete.
- 4. Failure of the Contractor to obtain, provide, maintain, and deliver the Performance and Payment Bonds (if required) as and when required under this Contract, or failure to comply with any requirement pertaining to the appropriate amounts thereof as set forth in ARTICLE #123 PERFORMANCE AND PAYMENT BOND REQUIREMENT.
- E. Payment Limitation in Event of Termination. In the event of termination of the Contract for any reason by either party, the County shall pay only those amounts, if any, due and owing to the Contractor for Services actually received and

accepted by the County up to and including the date of termination of the Contract and for which the County is obligated to pay pursuant to the Contract.

- F. The Contractor's Termination Duties. Upon receipt of notice of termination, the Contractor shall:
  - 1. Cease work under the Contract and take all necessary or appropriate steps to limit disbursements and minimize costs and furnish a report within thirty (30) days of the date of notice of termination, describing the status of all work under the Contract, including, without limitation, results accomplished, conclusions resulting therefrom, and any other matters the County may require.
  - 2. Immediately cease using and return to the County, any personal property or materials, whether tangible or intangible, provided by the County to the Contractor.
  - 3. Comply with the County's instructions for the timely transfer of any active files and work product produced by the Contractor under the Contract.
  - 4. Cooperate in good faith with the County, its employees, agents, and Contractors during the transition period between the notification of termination and the substitution of any replacement Contractor; and
  - 5. Immediately return to the County any payments made by the County for goods and services that were not delivered by the Contractor.

# ARTICLE # 109 - NO DEFENSE OR INDEMNIFICATION BY COUNTY:

The parties agree that the County shall not be responsible for defending or indemnifying any Contractor from any claim brought by any third party against the Contractor.

# **ARTICLE #110 - ASSIGNMENT AND DELEGATION BY CONTRACTOR:**

The Contractor shall not assign or delegate this Contract, or any performance required by it, in whole or in part, without the prior express written consent of the County.

# ARTICLE #111 – USE OF THIRD-PARTIES (Sub-Contractors):

This Contract is for the benefit of the parties hereto only and is not intended to benefit any third-party or give rise to any duty or causes of action for any third party. All restrictions, obligations and responsibilities of the Contractor under the Contract shall also apply to third parties such as sub-Contractors, if allowed in writing by the County. Any Contract with a subcontractor must also preserve the rights of the County.

# ARTICLE #112 – SUPERSEDES FORMER CONTRACTS

Unless otherwise specified in the Contract, this Contract supersedes all prior Contracts or Agreements between the County and the Contractor for the Services provided in connection with the Contract.

# ARTICLE #113 - SEVERABILITY:

If any paragraph, sub-paragraph, sentence, clause, phrase, or portion of this Contract is declared invalid or unconstitutional by any Court of competent jurisdiction or if the provisions of any part of this Contract as applied to any particular situation or set of circumstances shall be declared invalid or unconstitutional, such invalidity shall not be construed to affect the remaining portions of this Contract not so held to be invalid or the application of this Contract to other circumstances not so held to be invalid.

# ARTICLE # 114 - RECORDS:

- A. Public Records Request. The Georgia Open Records Act, as provided in O.C.G.A. § 50-18-70 et seq, requires procurement records and all other records received by or prepared or maintained on behalf of the County, shall be made open to public inspection, unless otherwise provided by law.
- **B.** Record Retention and Access. The Contractor shall maintain books, records, and documents in accordance with generally accepted accounting principles and procedures and which sufficiently and properly document and calculate all charges billed to the County throughout the term of the Contract for a period of at least five (5) years following the date of final payment or completion of any required audit, whichever is later. Records to be maintained include both financial records and service records.

#### **ARTICLE # 115 - ADDITIONAL TERMS:**

- A. The County shall not be bound by any terms and conditions included in any Contractor's literature, packaging, invoice, catalog, brochure, technical data sheet, on-line representation, warranties or service level agreement or other document which attempts to impose any condition in variance with or in addition to the terms and conditions contained herein.
- B. The County shall not be bound to any Terms and Conditions of the Contractor that are only accessible by hyper-link. All Terms and Conditions must be in print and approved by the County.

# ARTICLE # 116 - WAIVER:

The failure of any party hereto to seek a remedy for any alleged breach of this Contract shall not constitute a waiver of any claim, cause of action, or remedy allowed by Georgia law for breach thereof.

# ARTICLE # 117 - CONTRACTOR AND COUNTY RIGHTS AND OBLIGATIONS:

- A. The County has the right at any time to require the Contractor to put an immediate stop to any procedure, or the use of any equipment (chemical, material, etc., if applicable) considered by the County to be hazardous (or toxic) to persons, buildings, or surfaces. The Contractor will utilize acceptable substitutes as quickly as possible. In the event of such replacement, Contractor shall notify County of any resulting replacement, (ii) introduce the individual serving as the replacement to County, and (iii) provide County with a résumé and any other information regarding the individual that may be reasonably requested by County.
- B. The County has the right to require the Contractor to reassign or remove any employee or subcontractor's employee from the premises temporarily or permanently when, in the County's sole opinion, the employee is not suitable. The County's decision on this matter shall be final, and Contractor will remove this employee immediately and replace with a person of at least equivalent training, experience and requisite qualifications as quickly as possible, subject to the County's prior approval.
- C. Contractor agrees to obtain prior written approval from the County for the use of sub-Contractors to provide the Services described in *SCOPE OF SERVICES* prior to subcontractor's performance of work.

# ARTICLE # 118- INSURANCE REQUIREMENT:

A. Insurance Requirements. N/A- The Contractor must maintain and warrant to Hall County insurance policies at the Contractor's own expense and must furnish the County with a Certificate of Insurance (COI) providing evidence of proof of coverage at least in the amounts indicated in this subsection. The insurance certificate must list Hall County, Georgia, Hall County Landfill, as the certificate holder and as an additional insured under the commercial general, automobile and umbrella liability policies as follows: "Hall County Government, its Board of Commissioners, its officers, employees and agents, 2875 Browns Bridge Rd, Gainesville, GA 30504".

The policy must protect the Contractor and the County (as a Certificate Holder and Additional Insured) from any claims for bodily injury, property damage, or personal injury covered by the indemnification obligations set forth herein throughout the duration of the Contract.

The Contractor must maintain the following insurance coverage during the term of the Contract, in at least the minimum amounts set forth below, to cover all loss and liability for damages on account of bodily injury, including death therefrom, and injury to or destruction of property caused by or arising from any and all services carried on and any and all work performed by the Contractor pursuant to this Contract:

- Workers Compensation Insurance (Occurrence) in the amounts of the statutory limits established by the General Assembly of the State of Georgia (A self-insurer must submit a certificate from the Georgia Board of Workers Compensation stating that the Contractor qualifies to pay its own workers compensation claims.). In addition, the Contractor must require all sub-Contractors occupying the premises or performing work under the Contract to obtain an insurance certificate showing proof of Workers Compensation Coverage with the following minimum coverage:
  - a. Bodily injury by accident per employee \$ 100,000
  - b. Bodily injury by disease per employee \$ 100,000
  - c. Bodily injury by disease policy limit \$ 500,000
- 2. Commercial General Liability Policy with at least the following minimum coverage:

a.	Each Occurrence Limit	\$1,000,000
b.	Personal & Advertising Injury Limit	\$1,000,000
C.	General Aggregate Limit	\$3,000,000
d.	Products/Completed Ops. Aggregate Limit	\$2,000,000

Automobile Liability with at least the minimum coverage:\$1,000,000Combined Single Limit to cover Any Vehicle, leased or rented by the Contractor

3.	Umbrella Liability, Excess Liability per Occurrence	\$2,000,000
	Aggregate	\$2,000,000

It shall be the responsibility of the Contractor to require all of its sub-Contractors to maintain Commercial General Liability insurance with business automobile liability coverage with companies and limits as stated above, and to provide a certificate evidencing that such insurance is in effect upon request. Endorsement must be provided with the insurance certificate.

B. **Insurance Certificates and General Requirements.** No Contract performance shall occur unless and until the County receives required insurance certificates.

The insurance certificate must reference the Contract number assigned by the County and document that the liability coverage purchased by the Contractor includes contractual liability coverage to insure the indemnity agreement as stated herein.

- C. The Contractor understands and agrees that the foregoing policies will not be canceled, or not renewed or allowed to lapse for any reason until at least thirty (30) days prior written notice has been given to the County, or until such time as other valid and effective insurance coverage acceptable in every respect to the County and providing protection equal to protection called for in the policies referenced in this section shall have been received, accepted, and acknowledged by the County. Certificates of insurance showing such coverage to be in force shall be filed with the County prior to commencement of any work under the Contract. The foregoing policies shall be obtained from insurance companies licensed to do business in Georgia and, unless waived or modified in writing by the County, shall be an insurer with a minimum A.M. Best Rating of "A-". All such coverage shall remain in full force and effect during the term and any renewal or extension thereof. The insurance certificate must be submitted with this Contract.
- D. **Waiver of Subrogation.** There is no waiver of subrogation rights by either Party with respect to insurance.

# ARTICLE # 119 - NO WAIVER:

A. **Authority to Enter into Contract.** The Contractor represents and warrants that it has full authority to enter into and perform its obligations under the Contract and that the Contract constitutes a legal, valid, and binding obligation upon the Contractor in accordance with its terms. The representatives of the parties hereto also represent and warrant that they are authorized to sign this Contract on behalf of each party hereto."

- B. **Solicitation**. The Contractor warrants that no person or selling agency (except bona fide employees or selling agents maintained for the purpose of securing business) has been employed or retained to solicit and secure the Contract upon an agreement or understanding for commission, percentage, brokerage or contingency.
- C. Vehicles and Equipment. With the exception of specified County Owned Equipment and Vehicles listed in Exhibit X, Contractor warrants that CDL drives will not use any other County owned vehicles or equipment in the performance of this Contract without express written consent. Contractor shall be responsible for providing all transportation necessary to deliver Services under the Contract.

# ARTICLE # 120 - INTELLECTUAL PROPERTY RIGHTS & OWNERSHIP:

Contractor agrees it will not use the name or any intellectual property, including but not limited to, County trademarks or logos in any manner, including commercial advertising or as a business reference, without the expressed prior written consent of the County.

# ARTICLE # 121 - COMPENSATION:

- A. The County will pay the Contractor for the Services provided pursuant to this Contract and in accordance with the prices quoted and conditions set forth in the Bidder's response on Exhibit C Mandatory Cost Proposal Worksheet, which is attached hereto and incorporated into this Contract as if fully set forth herein. Payments will be made monthly in arrears to the Contractor after acceptance of the Contractor's delivered Services by the County, and after receipt of undisputed invoice to the County.
- B. Prices quoted shall be firm and fixed throughout the term of this Contract, unless otherwise Amended or Modified by mutual agreement.
- C. Cost may be prorated for Services added or removed under this Contract to align cost with the remaining term of Contract.
- D. It is understood that this bid or proposal is made without collusion or fraud.
   Contractor understands and acknowledges that collusive bidding is a violation of state and federal law and may result in the cancellation of the Contract.

#### ARTICLE # 122 - COUNTY PAYMENT TO CONTRACTOR:

A. The County will issue a Notice to Proceed to the Contractor, and Purchase Order(s) (herein after 'PO'). The terms of this Contract shall be incorporated by reference into any and all PO(s) issued prior to the expiration or termination of

this Contract. The County will issue the PO by electronic mail (e-mail) to the Contractor's representative in *ARTICLE #103 - NOTICES*. A PO is considered "issued" when the e-mail containing the PO is sent by the County to the Contractor.

The Contractor shall not deliver any Services, equipment, devices, or components thereof until authorized in writing by the County through issuance of a PO, which shall provide a commencement Notice-to-Proceed date. Any work, including but not limited to travel, preliminary meetings, planning, etc., performed outside of the terms and conditions of and before the issuance of the PO will not be considered for payment. Contractors are not to begin work or ship any product on any verbal communication from within the County. The County will not be liable for payment for any work or product with the issuance of a verbal communication.

The Scope of Services shall remain in effect from the Notice to Proceed to completion of the project. The Parties agree that the County will not pay or otherwise compensate the Contractor for any Services, materials, equipment, devices or components thereof outside of the Scope of Work and/or beyond the term of this Contract, unless specifically authorized in writing as evidenced by an amendment (see ARTICLE #106 - CONTRACT AMENDMENTS &, MODIFICATION), a time extension letter, or as otherwise authorized by the County.

### B. Invoice/Payment.

- Contractor shall invoice the County via email <u>each month</u> solely to <u>accountspayable@hallcounty.org</u> and only after the County inspects and accepts the Services provided. Receipt of the Services does not constitute acceptance. Invoice amounts shall not exceed the Contractor's pricing set forth in ARTICLE #102.
- 2. Each invoice shall include the Contractor's current "Remit to" address; a description of the Services provided; the invoice amount; the Contract number; and the associated PO number issued. Each properly prepared invoice must be sent in accordance with the instructions listed on the PO. Standard payment terms are net 30 days (N30) in arrears from the date the invoice is accepted, following delivery of the Services.
- 3. The County does not pay for services not yet received but only in arrears.
- 4. The Contractor shall be solely responsible for paying all costs, expenses and charges it incurs in connection with its performance under the Contract.

# C. Unsatisfactory Performance; Delay of Payment.

1. If the County determines that the quality of the Services provided are deficient, unacceptable, or unsatisfactory, the County's Project Manager identified in *ARTICLE #103* shall issue a written notice to Contractor. Contractor agrees that upon receipt of the written notice, it shall make

every effort to correct the deficiency (ies) within the timeframe prescribed therein. If the Contractor fails to timely correct the deficiencies, the County reserves the right to delay payment pursuant to this *ARTICLE #122* or terminate the Contract (*ARTICLE #108 – TERMINATION PROVISIONS*).

- 2. Delay of Payment Due to Contractor's Failure. If the County determines that the Contractor has failed to perform or deliver any Services as required by the Contract, the Contractor shall not be entitled to any compensation under the Contract until such Services are delivered and accepted. In this event, the County may withhold that portion of the Contractor's compensation, which represents payment for Services that were not delivered. To the extent that the Contractor's failure to perform or deliver in a timely manner causes the County to incur costs, the County may deduct the amount of such incurred costs from any amounts payable to Contractor. The County's authority to deduct such incurred costs shall not in any way affect the County's authority to terminate the Contract.
- D. Set-Off Against Sums Owed by the Contractor. In the event that the Contractor owes the County any sum under the terms of the Contract, pursuant to any judgment, or pursuant to any law, the County may set off the sum owed by the Contractor against any sum owed to the Contractor, in the County's sole discretion.
- E. **Final Payment.** Contractor shall issue an invoice for final payment to the County no later than thirty (30) days following the expiration or termination date of the Contract.
- F. The Contractor must not "Factor or Assign Payments" to another or a financial institution. The County will only pay the party to whom it is contracted with. The County will not in any circumstances pay a third-party.

#### **ARTICLE #123 – PERFORMANCE AND PAYMENT BONDS**

The Contractor must furnish to the County a Performance Bond equal to one-hundred percent (100%) of the Contract's total initial term dollar amount, and additionally a Payment Bond equal to one-hundred percent (100%) of the total initial term dollar amount. After receipt of the bonds, the County will issue a Notice-to-Proceed. Only surety companies licensed to do business in the State of Georgia are acceptable. The Contractor is required to provide new bonds at the issuance of each Renewal Option Term(s) or Extension(s) that follow.

#### The County must receive all bonding instruments prior to the commencement of any work.

# ARTICLE #124 - RETAINAGE ( if applicable on this contract)

"Retainage (if required) will be withheld by Hall County in compliance with Georgia law. Hall County may hold up to ten-percent (**10%**) retainage throughout the entire project and will release said retainage at the point of final completion and final acceptance by the County."

# ARTICLE #125 - VENUE AND GOVERNING LAW

The parties agree that this Contract shall be interpreted, construed, and enforced in accordance with the laws of the State of Georgia. To the extent that either party may bring a legal suit to enforce the terms of this Contract, including suit in equity, the parties agree and consent to file any such suit in the Superior Court of Hall County, Georgia.

# ARTICLE # 126 - NOTICE OF INTENT TO LITIGATE

Contractor hereby agrees not to file any civil action of disputes or claims relating to the Contract except after first giving thirty days (30) written notice to the County of the claim and the intent to initiate a civil action.

# ARTICLE # 127- GEORGIA SECURITY AND IMMIGRATION COMPLIANCE ACT:

- A. By signing this Contract, the Contractor certifies that prior to and throughout the performance of all applicable work under this Contract it will remain in full compliance with all federal and state immigration laws, including but not limited to 8 U.S.C. § 1324a and the Georgia Security and Immigration Compliance Act (O.C.G.A. §13-10-90 et seq.), as amended by the Illegal Immigration Reform and Enforcement Act of 2011, regarding the verification of employment eligibility of employees under the Immigration Reform and Control Act of 1986. Contractor will ensure that only persons who are citizens or nationals of the United States or non-citizens authorized under federal immigration laws are employed to perform services under this Contract or any subcontract or sub-subcontract hereunder.
- B. Contractor further certifies its compliance with the aforementioned federal and state immigration laws set forth by signing a sworn affidavit, the Georgia Security and Immigration Compliance Act Affidavit, notarized by an Official Notary Public, and obtaining the same affidavits from any sub-contractor providing services pursuant to this Contract.

# ARTICLE # 128 – ORDER OF PRECEDENCE:

In the event of any inconsistency, ambiguity, or conflict among the specific provisions of the Contract and the Contractor's Response, the order of precedence shall be as follows:

- A. First, any amendments to the Contract, including all Exhibits thereto.
- B. Second, the Contract itself, including all Exhibits thereto.
- C. Third, Attachments appended to the Contract.

#### ARTICLE # 129- CONTRACT EXHIBITS AND ATTACHMENTS:

The Parties mutually acknowledge that any following Exhibits and Attachments listed below made a part of this Contract, as though expressly written in the RFQ/P documents and the bidder's response, are-herein-incorporated into this contract by reference.

#### EXHIBIT C - Mandatory Cost Proposal

#### ARTICLE # 130 - ENTIRE CONTRACT:

This Contract, as executed and approved, shall constitute the entire agreement between the Parties and supersedes all other prior and contemporaneous statements, agreements, and understandings between the Parties. No written or oral statements, agreements, or understandings that are not set out, referenced, or specifically incorporated in this Contract shall in any way be binding or of effect between the Parties.

#### ARTICLE # 131- VALIDITY

If any paragraph, sub-paragraph, sentence, clause, phrase or any portion of this agreement shall be declared invalid or unconstitutional by any Court of competent jurisdiction or if the provisions of any part of this agreement as applied to any particular situation or set of circumstances shall be declared invalid or unconstitutional, such invalidity shall not be constructed to affect the portions of this agreement not so held to be invalid or the application of this agreement to other circumstances not so held to be invalid. The parties hereby declare that this is the intent of the parties to this agreement is to provide for separate and divisible parts.



The request before you is the rezoning application of Reginald Crayton, P.E., to allow a grocery store, convenience store with gas & restaurant (shopping center, per definition in <u>17.20.1010</u>) on 6.34± acres. *It should be noted that a simultaneous conditional use request accompanies this request but has separate memos.* This item is located within Commission District 3.

Reginald Crayton, P.E., applicant.

At your January 12, 2023 you tabled this item so the applicant could revise their site plan to address concerns raised during the public hearing and from the Board of Commissioners. As of February 6, 2023, no revised site plan has been received. Multiple residents spoke in opposition to the rezoning at the January 12, 2023 meeting but no one spoke in opposition at the Planning Commission meeting on November 21, 2022.

At their November 21, 2022 meeting, the Hall County Planning Commission voted to recommend approval of the conditional use request with seven (7) conditions (4-0, Pilcher absent). The Planning Commission voted on a conditional use and the rezoning, although only the rezoning request was before them. A separate legal advertisement has been run for the conditional use. It has been placed on this agenda as well. The items can be heard together but require two separate motions and votes. Denial of the rezoning automatically results in denial of the conditional use.

The request before you is the rezoning application of Reginald Crayton, P.E., to allow a grocery store, convenience store with gas & restaurant (shopping center, per definition in <u>17.20.1010</u>) on 6.34± acres. *It should be noted that a simultaneous conditional use request accompanies this request but has separate memos.* This item is located within Commission District 3.

Reginald Crayton, P.E., applicant.

At your January 12, 2023 you tabled this item so the applicant could revise their site plan to address concerns raised during the public hearing and from the Board of Commissioners. As of February 6, 2023, no revised site plan has been received. Multiple residents spoke in opposition to the rezoning at the January 12, 2023 meeting but no one spoke in opposition at the Planning Commission meeting on November 21, 2022.

At their November 21, 2022 meeting, the Hall County Planning Commission voted to recommend approval of the conditional use request with seven (7) conditions (4-0, Pilcher absent). The Planning Commission voted on a conditional use and the rezoning, although only the rezoning request was before them. A separate legal advertisement has been run for the conditional use. It has been placed on this agenda as well. The items can be heard together but require two separate motions and votes. Denial of the rezoning automatically results in denial of the conditional use.

There were no written comments submitted in advance of the Planning Commission meeting and no one spoke during the public forum.

There have been no changes to the request since the Planning Commission took action.

**Planning Commission Approval Conditions:** 

- The proposed use shall substantially conform with the proposed narrative and site plan. The proposed development shall be allowed to have up to 20,000 sq. ft. total in the two buildings. No further action by the Hall County Planning Commission and the Board of Commission shall be required for the proposed use as submitted by the applicant.
- 2. The project building elevations, materials, and colors shall be submitted to the Director of Planning and Development during the design review process for approval.

The request before you is the rezoning application of Reginald Crayton, P.E., to allow a grocery store, convenience store with gas & restaurant on 6.34± acres. This item is located within Commission District 3.

The proposed use (a shopping center) is a use requiring County Commission approval but no concurrent application was submitted for review or approval. This is not unusual since applicants often want assurance of the appropriate zoning classification prior to investing in more detailed plans for a conditional use application. The Planning Commission voted to approve the use along with the rezoning. The use shall require a separate legal ad and sign posting before the Board of Commissioners can approve it. Should you approve the rezoning request, the use will be on your January 26, 2023 voting meeting agenda.

At their November 21, 2022 meeting, the Hall County Planning Commission voted to recommend approval of the Rezoning request (and use of a shopping center) with seven (7) conditions **(4-0, Pilcher absent)**.

There were no written comments submitted in advance of the Planning Commission meeting and no one spoke during the public forum.

There have been no changes to the request since the Planning Commission took action.

#### **Planning Commission Approval Conditions:**

 The proposed use shall substantially conform with the proposed narrative and site plan. The proposed development shall be allowed to have up to 20,000 sq. ft. total in the two buildings. No further action by the Hall County Planning Commission and the Board of Commission shall be required for the proposed use as submitted by the applicant.

- The project building elevations, materials, and colors shall be submitted to the Director of Planning and Development during the design review process for approval.

#### Public Forum:

There were no comments in support or opposition.

#### Summary Analysis

The applicant is requesting approval to rezone  $6.35\pm$  acres from Agricultural Residential III (AR-III, <u>17.110</u>) to Suburban Shopping (S-S, <u>17.140</u>) to develop the tract for retail purposes. The narrative submitted by the applicant states that the proposed rezoning will allow for the three proposed uses consisting of an 11,000 square foot grocery store, 4,000 square foot restaurant, and a 3,250 square foot convenience store with a gas station. The site is currently developed with a single-family residence.

The subject property is located on the west side of Cleveland Highway / US Highway 129, bounded by Jim Hood Road to the north and residential properties to the west and south of the property. The hours of operation for said establishments have not yet been determined, neither has the signage. However, the narrative states that the signage will be in compliance with the Zoning Regulations (<u>Title 17</u>) and will be no more than the maximum monument sign dimensions for nonresidential uses (48 square feet for the grocery store and 32 square feet for the restaurant and convenience store). The property also lies within the Gateway Corridor Overlay District (GCOD, <u>Chapter 17.420</u>).

The narrative states that according to the Zoning Regulations (<u>Title 17</u>), the minimum area and setback requirements are as follows: minimum lot size is 15,000 square feet, minimum frontage is 100 feet, front yard setback is 30 feet from the property line, minimum side yard setback is 20 feet, and the minimum rear yard setback is 10 feet, as shown on the conceptual site plan.

Water will be provided to the property by the City of Gainesville and sewage will be handled by an on-site septic system on the property. The property will maintain a minimum 10 feet landscape stripe along Cleveland Highway and Jim Hood Road and a 25 foot transitional property where it adjoins residential parcels.

Based on the future land-use plan, staff finds the <u>requested zoning designation</u> is consistent with the future land use map designation of a Community Crossroad within a Mixed Use Corridor; <mark>it should be noted that the use of a shopping center within the Suburban Shopping (S-S, <u>17.140</u>) zoning district requires</mark>

Planning Commission approval. A subsequent application will be required if the rezoning request is approved. Although listed as several different uses in this application, the proposal meets the definition of a shopping center (<u>17.20.1010</u>).

#### Zoning Analysis

• The proposed use of a grocery store, convenience store with gas & restaurant is consistent with the future land use map designation of a Community Crossroad within a Mixed Use Corridor.

When considering a zoning amendment to the zoning maps, the following items must be considered:

- Whether the zoning proposal will permit a use that is suitable in view of the use and development of adjacent and nearby property; The proposed zoning classification of Suburban Shopping (S-S, <u>17.140</u>) is suitable in view of the use and development of adjacent and nearby property. The intersection of Cleveland Highway and Jim Hood Road has been identified as a Community Crossroad in the Comprehensive Plan.
- 2. Whether the zoning proposal will adversely affect the existing use or usability of adjacent or nearby property; The zoning proposal should not have an adverse effect on the existing use or usability of adjacent or nearby property. The property abuts a divided 4-lane highway, (Hwy 129), and the nearest residential structure from the proposed shopping center is located at <u>4127 Jim Hood Road</u>.
- 3. Whether the property to be affected by the zoning proposal has reasonable economic use as currently zoned. The subject parcel has reasonable economic use as currently zoned. The property is developed with a single-family residence and can continue to be utilized as such.
- 4. Whether the zoning proposal will result in a use which will or could cause an excessive or burdensome use of existing streets, transportation facilities, or utilities; The proposed use of a grocery store, restaurant, & convenience store with a fueling station has the potential to increase traffic on the existing streets, but will likely attract customers who already travel the along Cleveland Highway rather than attracting new trips.
- 5. Whether the zoning proposal is in conformity with the policy and intent of the land use plan; The proposed use of a grocery store, convenience store with gas & restaurant is consistent with the future land use map designation of a Community Crossroad within a Mixed Use Corridor.
- 6. The extent to which property values are diminished by the existing zoning restrictions; Staff has not identified that the existing property values have been impacted by the existing zoning.
- 7. The extent to which the destruction of the subject property's value under the existing zoning promotes the health, safety, morals or general welfare of the public; Staff is unable to comment on the impact of property values without a full market analysis. Multiple factors impact property value including construction types, proposed uses, and maintenance. Often it is difficult to determine the effect of a development on adjacent properties until the development is completed.
- 8. The relative gain to the public as compared to the hardship imposed upon the individual property owner; Staff has not identified a hardship imposed on the property owner as the property is currently zoned. The property contains a single-family residential structure which could continue to be used as such under the existing zoning designation.

- 9. The length of time the property has been vacant as zoned considered in the context of land development in the area in the vicinity of the property; This criteria is not applicable to the application since the subject property is currently developed with a single-family residence. While it is unknown if the residence is occupied, there is nothing regulatory preventing it from being utilized in this manner.
- **10.** Whether there are other existing or changing conditions affecting the use or development of the property which give supporting grounds for either approval or disapproval of the zoning proposal; **Staff is not aware of any changing conditions that affect the use and development of the property.**
- 11. Whether the change would create an isolated district unrelated to the surrounding districts; The proposed Suburban Shopping (S-S, <u>17.140</u>) zoning classification would introduce a non-residential classification to this corner of the intersection of Jim Hood Road and Cleveland Highway. That being said, the properties to the north of Jim Hood Road are already zoned Suburban Shopping (S-S, <u>17.140</u>).
- **12.** Whether the present zoning district boundaries are illogically drawn in relation to existing conditions in the area; **There is no indication that the present zoning district boundaries are illogically drawn.**
- 13. Whether the change requested is out of scale with the needs of the county as a whole or the immediate neighborhood; The proposed use of a grocery store, convenience store with gas & restaurant would likely attract nearby residents and does not appear to be out of scale with the needs of the immediate neighborhood.
- 14. Whether it is impossible to find adequate sites for the proposed use in districts permitting such use and already appropriately zoned; There are other properties within the County that support the type of retail uses proposed and are already appropriately zoned.
- **15.** Whether the need for rezoning could be handled instead by a variance request to the [Planning Commission]; **The request could not be handled alternatively as a variance since the proposed use is neither permitted nor conditional in the AR-III district (<u>17.110</u>).**
- 16. Whether there would be an ecological or pollution impact resulting from major modifications to the land if the request is granted; Any land disturbance activities on the property shall be required to go through the land development permitting process and as a result are subject to local, state, and federal regulations. As a result there should not be an ecological or pollution impact resulting from any modification to the land if the request is granted. If the rezoning is approved, the proposed use requires a separate conditional use approval from the Hall County Planning Commission.
- 17. Whether there is reasonable evidence based upon existing and anticipated land use that would indicate a mistake was made in the original zoning of the property; There is no indication that a mistake was made in the original zoning of the property.

**Suburban Shopping (S-S)** standards are found in <u>chapter 17.140</u> which include the permitted and conditional uses allowed within the S-S district.

#### 17.380.050. - Submission requirements for a rezoning request

A. Any person or persons requesting a change in the official zoning map or use subject to approval of the county commission shall file an application with a plat or map of the property attached thereto, together with payment of such fees set forth in <u>chapter 17.30</u> to cover administrative and advertising costs, in the planning department office. Such person or persons or their authorized

agent shall appear in person at the public hearing held to consider the district change. **Proposal** meets the requirement. Applicant has paid the appropriate fees and understands that someone must be present at both the Hall County Planning Commission meeting and the voting meeting of the Hall County Board of Commissioners.

- B. All applications for a change of zoning classification or use subject to approval of the county commission shall include:
  - 1. A narrative statement identifying the existing and proposed use of the property and addressing each of the criteria set forth in section 17.380.060.C of this section [chapter]. The applicant has submitted a narrative and constitutional objections but did not specifically address the criteria listed in <u>17.380.060.C</u>.
  - 2. A site plan drawn to scale designating the area covered by the application and identifying existing and proposed buildings and uses, adjacent existing land uses, zoning on contiguous parcels, including those across an abutting public right-of-way, and any other significant site improvements proposed to accommodate the proposed use or buffer adjacent uses, etc., or a plat of the subject property where no specific land use is proposed. In cases where only a plat or map is provided and no land use is proposed, the planning commission and county commission shall evaluate the application based on the most intense possible land use permitted in the proposed district. **Proposal meets this requirement.**
- C. For any application for a slow rate land treatment system (see <u>chapter 17.20</u>), the following additional requirements apply. The development proposes to utilize an on-site septic system and as such this requirement is not applicable.

For any application proposing the development of 100 or more residential dwelling units, a traffic impact study shall be submitted prior to consideration of the application by the planning commission. In an email dated November 2, 2022, Lieutenant John Hornick, NPQ Fire Inspector 1, Plans Review, states "The Hall County Fire Marshal's Office has no comments regarding the planned commercial development as proposed."

#### Hall County Public Works and Utilities

In a memo dated November 3, 2022, from Srikanth Yamala, Director of Public Works and Utilities, the following comments were provided:

#### Engineering:

The site may require a stormwater management report, should the site plan indicate the proposed development meets stormwater thresholds for impervious surfaces and/or disturbed acreage. Show buffer and impervious setback from wrested vegetation, not centerline of creek.

# Traffic:

GDOT permit required

#### **Utilities:**

Gainesville/Hall county sewer district. No sewer available. On-site septic system proposed for wastewater, therefore Health Department approval required.

#### Georgia Department of Transportation

Per an email dated November 2, 2022, Parker Niebauer, District 1 Traffic Operations Supervisor, confirmed that this project **will** require GDOT coordination.

#### Excerpts from the minutes of the November 21, 2022 meeting

**Randi Doveton, Planning Director,** presented a summary of the request. Ms. Doveton stated that a conditional use would need to be considered for the shopping center.

**Raj Umani, 195 Antler Trail, Alpharetta,** presented the request. The applicant stated that the grocery store would roughly be about 11,000 sq. ft., restaurant 4,000 sq. ft. and convenience store with gas 3,000 sq. ft.

The Applicant, Reginald Crayton, Agent for the Owner, hereby submits a Zoning Application for approximately a 6.35-acre tract, herein after referred to as "Property", located at 4053 Cleveland Highway, Gainesville, GA 30506 (Parcel Number 12025 000036). The request to rezone from AR-III (Agricultural Residential) to SS (Suburban Shopping), to develop the tract for retail uses.

As stated in the paragraph above, the property currently is zoned AR III, Agriculture Residential, and currently has an existing residential home located onsite. The property is bounded by Jim Hood Road to the north, Cleveland Highway to the east, residential properties to the west and south of the property. The proposed rezoning to SS, Suburban Shopping, will only allow for the three proposed uses of a 11,000-sf grocery store, 4,000 sf restaurant and 3,250 sf convenience store with gas station. At this moment the hours of operation have not been determined. All the proposed developments will have associated utilities, parking and stormwater.

According to Hall County zoning ordinance the minimum area and set back requirements are as follows: minimum lot size is 15,000 sf, minimum frontage is 100 ft, front yard set back 30 ft from the property line, minimum side yard setback 20 ft, and the minimum rear yard set is 10 ft, as shown on the conceptual site plan.

Signage has not been determined but will be in compliance with the Hall County Unified Code and will be no more than the maximum monument sign dimensions for nonresidential uses, 48 sf for the grocery store and 32 sf for the restaurant and

Convenience store.


Water will be provided to the "Property" by the City of Gainesville, and Sewage will be handled by a septic tank located on the property.





Hello All,

Staff's concern is accessibility of northbound SR11/US129 (Cleveland Hwy.) to the proposed site. I spoke to GDOT regarding this and they advised that the right-in/right-out driveways on Cleveland Highway and Jim Hood Road are currently required to not interfere with intersection operations. This current driveway configuration will necessitate a u-turn maneuver at the intersection or an illegal left turn off of Jim Hood Road for northbound traffic to enter the site. GDOT is open to two additional options to address this issue. One is to consider an RCUT median opening on SR11/US129 (Clevelenad Hwy.) which will require studies and consideration by the Atlanta GDOT office, but required spacing is an issue. Two would be to consider a short left turn lane (but no decel lane due to adjacent property issues) on Jim Hood Road that would not affect the existing lanes or tapers for the intersection. This would require roadway widening, striping removal, replacement and GDOT approval. See the GDOT response below for details.

Hey Scott,

Thanks for taking my call today. I understand the concerns and we're open to discuss options here. Thanks for being so communicative with us.

An RCUT here would be viewed as a median opening by GDOT and would have to be approved by our downtown office and we will require the developer to provide, at a minimum, an Intersection Control Evaluation (ICE), and likely a traffic study as well.

Some of our initial concerns with the placement of a driveway further south on US 129 are median opening spacing and where the driveway would fall in the merge section.

A left turn in on Jim Hood may be feasible if we can be confident the left turns will neither back up traffic towards the signal nor reduce the existing eastbound left turn lane storage (whether through striping or actual queueing).

Please let us know how you would like to proceed.

Hall County Engineering would defer to GDOT for the access as the development is off a state road. However, we would suggest allowing an r-cut that would allow a left-in to the site from Cleveland Highway. On the previous version of the plan (second attachment), they showed a driveway on the southern end of their development that could have accommodated this movement without impacting the NB left turn bay into Jim Hood. This is being offered as a suggestion to avoid u-turns on Cleveland Highway in order to access the site.

Stephen,

Thanks for calling today. As discussed, a left turn lane from Jim Hood Rd into the development would impact the left turn lane from Jim Hood onto US 129/SR 11. We would not want to reduce the length of the existing LTL.

A Right-In/Right-Out (RIRO) may be a more appropriate option. Three lanes leaving the RIRO would not be approved, and will need to be limited to one right-in lane and one right-out lane.

Also note that the access on SR 11 shown in the site plan does not match the approved concept from October of 2022 (see attached).

First, please let me congratulate you on winning the race for Hall County District 3 Commissioner. I wish you success and hope to be able to support your decisions going forward.

I would like to express my concerns regarding the proposed shopping center development on Cleveland Hwy at Jim Hood Road. This proposed development includes a grocery store, convenience store and a restaurant.

In my opinion, this development is not necessary for the residents in this area of Hall County. Planning commissioner Stan Hunt stated that this project may relieve the traffic flow into Gainesville by giving people a place to shop closer. It should be noted that there are already 4 convenience stores, 5 gas stations, 6 restaurants, one hardware store, and one IGA grocery store all within a 3 mile radius of this property. There is also a Dollar General only .2 of a mile further out. This is more than adequate for the area given the current population and rate of residential growth in the area. Additionally, further development could increase the already high traffic safety hazard at this intersection.



The request before you is the conditional use application of Reginald Crayton, P.E., to allow a grocery store, convenience store with gas & restaurant (shopping center, per definition in <u>17.20.1010</u>) on 6.34± acres. *It should be noted that a simultaneous rezoning request accompanies this request but has separate memos.* This item is located within Commission District 3.

At your January 12, 2023 regular meeting you tabled the associated rezoning request so the applicant could revise their site plan to address concerns raised during the public hearing and from the Board of Commissioners. Multiple residents spoke in opposition to the rezoning at the January 12, 2023 meeting but no one spoke in opposition at the Planning Commission meeting on November 21, 2022.

At their November 21, 2022 meeting, the Hall County Planning Commission voted to recommend approval of the conditional use request with seven (7) conditions (4-0, Pilcher absent). The Planning Commission voted on a conditional use and the rezoning, although only the rezoning request was before them. A separate legal advertisement was published for the conditional use and a sign posted, as per posting policy. The Conditional Use has been placed on this agenda as well. The rezoning public hearing was closed on 1-26-2023 Denial of the rezoning automatically results in denial of the conditional use, but the Chairman will need to state this during the meeting.

There were no written comments submitted in advance of the Planning Commission meeting and no one spoke during the public forum.

There have been no changes to the request since the Planning Commission took action.

The Planning Commission imposed the same conditions on both the rezoning and conditional use.

Hello All,

Staff's concern is accessibility of northbound SR11/US129 (Cleveland Hwy.) to the proposed site. I spoke to GDOT regarding this and they advised that the right-in/right-out driveways on Cleveland Highway and Jim Hood Road are currently required to not interfere with intersection operations. This current driveway configuration will necessitate a u-turn maneuver at the intersection or an illegal left turn off of Jim Hood Road for northbound traffic to enter the site. GDOT is open to two additional options to address this issue. One is to consider an RCUT median opening on SR11/US129 (Clevelenad Hwy.) which will require studies and consideration by the Atlanta GDOT office, but required spacing is an issue. Two would be to consider a short left turn lane (but no decel lane due to adjacent property issues) on Jim Hood Road that would not affect the existing lanes or tapers for the intersection. This would require roadway widening, striping removal, replacement and GDOT approval. See the GDOT response below for details.

Thanks for taking my call today. I understand the concerns and we're open to discuss options here. Thanks for being so communicative with us.

An RCUT here would be viewed as a median opening by GDOT and would have to be approved by our downtown office and we will require the developer to provide, at a minimum, an Intersection Control Evaluation (ICE), and likely a traffic study as well.

Some of our initial concerns with the placement of a driveway further south on US 129 are median opening spacing and where the driveway would fall in the merge section.

A left turn in on Jim Hood may be feasible if we can be confident the left turns will neither back up traffic towards the signal nor reduce the existing eastbound left turn lane storage (whether through striping or actual queueing).

Hall County Engineering would defer to GDOT for the access as the development is off a state road. However, we would suggest allowing an r-cut that would allow a left-in to the site from Cleveland Highway. On the previous version of the plan (second attachment), they showed a driveway on the southern end of their development that could have accommodated this movement without impacting the NB left turn bay into Jim Hood. This is being offered as a suggestion to avoid u-turns on Cleveland Highway in order to access the site.

Thanks for calling today. As discussed, a left turn lane from Jim Hood Rd into the development would impact the left turn lane from Jim Hood onto US 129/SR 11. We would not want to reduce the length of the existing LTL.

A Right-In/Right-Out (RIRO) may be a more appropriate option. Three lanes leaving the RIRO would not be approved, and will need to be limited to one right-in lane and one right-out lane.

Also note that the access on SR 11 shown in the site plan does not match the approved concept from October of 2022 (see attached).

Let us know if you have any questions. We are happy to reach out to Hall County if you are getting conflicting review comments.



#### Summary Analysis

The applicant is requesting to rezone the subject property from Agricultural Residential IV (AR-IV, <u>17.120</u>) & Suburban Shopping (S-S, <u>17.140</u>) to Planned Industrial Development (PID, <u>17.180.090</u>) on a combined 91.51± acre tract for the purpose of developing a mixed-use business park. The intent is for the park to serve a mixture of industrial, commercial, highway business, and office-institutional uses. The narrative states the property may be developed as "pad ready" sites or sold as undeveloped parcels. The project is expected to be completed by 2033.

The narrative continues that access to the property is planned from Lula Road (SR 52), subject to GDOT approval, and from Cagle Road, subject to Hall County approval. Additionally, direct access from Cornelia Highway (SR 365) will be provided through an existing driveway easement to the property. The adjacent properties to the south and east are zoned Agricultural Residential IV (AR-IV, <u>17.120</u>) and properties to the west are zoned Planned Commercial Development (PCD, <u>17.180.080</u>) and Suburban Shopping (S-S, <u>17.140</u>).

52. Manufacturing, processing or storage in bulk of chemical and pharmaceutical products.

- 53. Motels, hotels.
- 54. Movie studio
- 55. Nursery schools or kindergartens.
- 56. Offices and office buildings, with a gross floor area not exceeding 50 percent of lot area.
- 57. Outdoor storage of materials and inventory, not including uses as included in section <u>17.170.020</u>.

- 60. Personal Service Establishment
- 61. Plastics/metals extrusion plant
- 62. Private directional signs for churches (defined under section <u>17.270.030</u>) up to 36 square feet in area.

- 65. Recreational and/or cultural uses of a commercial nature.
- 66. Restaurants.
- 67. Retail or retail service establishments.

The proposal is considered a <u>Development of Regional Impact (DRI)</u> by the <u>Georgia Department of</u> <u>Community Affairs</u> and as such the development was subject to review by the <u>Georgia Mountains Regional</u> <u>Commission</u> through the DRI review process. Hall County is classified as a metropolitan community and any industrial development with greater than 500,000 gross square feet; or employing more than 1,600 workers; or covering more than 400 acres triggers this review.

The Georgia Mountains Regional Commission provided a DRI Review Finding on November 30, 2022 which concluded that *"the proposed action does not present any potential adverse inter-jurisdictional impacts."* The City of Lula and Jackson County both submitted comments as part of the DRI review process. A copy of the DRI Review Findings and associated comments are included with this report.

Finally, the narrative concludes that the development shall be controlled by the Conceptual Master Plan. This plan is considered conceptual in nature, and as such, may require modifications during the engineering and development process. Modifications to the locations and arrangement of buildings, roads, and other improvements that do not conflict with specific standards of these conditions may be made by the developer or end user, so long as the modifications do not change the land use, increase the overall density of the project, or reduce any established exterior buffers or setbacks.

The submitted site plan shows a 1-story 1,001,000 square foot industrial building with associated parking along the eastern portion of the property, adjacent to both Lula Road / SR 52 and Cagle Road. Three additional 1 story industrial buildings, 30,000, 755,000, and 110,000 square feet in area, on the central and western portions of the proposed development. No parking calculations have been included, but the narrative states parking will be in accordance with Hall County regulations. Per off-street parking (<u>17.250.020</u>), 1.6 spaces for each 1,000 square feet of gross floor area is required for industrial developments. The current square footage would require 1,944 parking spaces based on a total of 1,215,000 square feet of industrial area.

The property has approximately 550 feet of frontage along Cornelia Highway / SR 365, and as such the development is subject to the standards of the Gateway Corridors Overlay District (GCOD, <u>17.420</u>). The applicant has requested a variance to permit tilt-up concrete construction and TPO roof systems. The narrative continues to say that alternatively, if a 100-foot buffer is maintained from the right-of-way of Cornelia Highway / SR 365, then no Gateway Corridors Overlay District (GCOD, <u>17.420</u>) shall apply. The applicant commits to subjecting the property to similar covenants that have previously been adopted for the Gateway Industrial Centre, located further south along Cornelia Highway / SR 365. <u>NOTE: A copy of the covenants for the Gateway Industrial Centre have been provided and are attached to this report. A Development Review Committee of three (3) individuals who shall review and approve all improvements to the site. The covenants detail design standards including setbacks, site coverage, parking, exterior facades, fencing, screening, signage, lighting, and landscaping requirements.</u>

Additionally, the applicant has requested a variance from the standards of the Tree Protection ordinance (<u>17.280</u>). Again, the applicant commits to subjecting the property to similar covenants that have been previously adopted from the Gateway Industrial Centre.

A separate variance report is provided related to these requested variances.

**Based on the future land-use plan, staff finds the** <u>requested zoning designation consistent with the Activity</u> <u>Center future land use classification</u> of the <u>Comprehensive Plan</u>. Specifically, the plan identifies the intersection of Cornelia Highway / SR 365 and Lula Road / SR 52 as an Employment Activity Center with primary land uses being mater planned business or industrial parks and mid-rise office developments.

#### Zoning Analysis

The proposal is consistent with the <u>Comprehensive Plan</u> and the future land use classification of an Activity Center. Specifically, this intersection is identified as an Employment Activity Center with appropriate primary land uses including mater planned business or industrial parks and mid-rise office developments.

When considering a zoning amendment to the zoning maps, the following items must be considered:

- Whether the zoning proposal will permit a use that is suitable in view of the use and development of adjacent and nearby property; The proposed use is suitable in view of the uses and development of adjacent and nearby properties. The intersection is already established with a mixture of commercial uses, with some of the adjoining property zoned as Planned Commercial Development (PCD, <u>17.180.080</u>) and Suburban Shopping (S-S, <u>17.140</u>).
- 2. Whether the zoning proposal will adversely affect the existing use or usability of adjacent or nearby property; The proposed development should not have an adverse effect on the existing uses or usability of adjacent or nearby property. The proposed use will be subject to all applicable local, state, and federal development regulations.
- 3. Whether the property to be affected by the zoning proposal has reasonable economic use as currently zoned. The property has reasonable economic values as currently zoned; allowable uses within the Agricultural Residential IV (AR-IV, <u>17.120</u>) & Suburban Shopping (S-S, <u>17.140</u>) zoning districts.
- 4. Whether the zoning proposal will result in a use which will or could cause an excessive or burdensome use of existing streets, transportation facilities, or utilities; The access to the development is proposed from 3 points: access easement from Cornelia Highway / SR 365, Lula Road / SR 52, and Cagle Road. As the end users have not identified it is difficult to determine the frequency and intensity of traffic using the site, but the submitted traffic study concludes that the project is expected to generate a total of 4,095 new trips on a typical weekday. The recommendations of the traffic study will be implemented as part of the development process, which should mitigate some of the impact.
- 5. Whether the zoning proposal is in conformity with the policy and intent of the land use plan; The proposal is consistent with the <u>Comprehensive Plan</u> and the future land use classification of an Activity Center. Specifically, this intersection is identified as an Employment Activity Center with appropriate primary land uses including mater planned business or industrial parks and mid-rise office developments.
- 6. The extent to which property values are diminished by the existing zoning restrictions; Staff has not identified that the existing property values have been impacted by the existing zoning.
- 7. The extent to which the destruction of the subject property's value under the existing zoning promotes the health, safety, morals or general welfare of the public; Staff is unable to comment on the impact of property values without a full market analysis. Multiple factors impact property value including construction types, proposed uses, and maintenance. Often it is difficult to determine the effect of a development on adjacent properties until the development is completed.

- 8. The relative gain to the public as compared to the hardship imposed upon the individual property owner; Staff has not identified a hardship imposed on the property owner as the property is currently zoned.
- **9.** The length of time the property has been vacant as zoned considered in the context of land development in the area in the vicinity of the property; **The property is currently developed with residential and agricultural structures.**
- **10.** Whether there are other existing or changing conditions affecting the use or development of the property which give supporting grounds for either approval or disapproval of the zoning proposal; **Staff is not aware of any changing conditions that affect the use and development of the property.**
- 11. Whether the change would create an isolated district unrelated to the surrounding districts; The proposed zoning would create an isolated district unrelated to the surrounding districts. There are industrially zoned parcels along Cornelia Highway, but none immediately adjacent.
- **12.** Whether the present zoning district boundaries are illogically drawn in relation to existing conditions in the area; **There is no evidence that the present zoning district boundaries are illogically drawn.**
- 13. Whether the change requested is out of scale with the needs of the county as a whole or the immediate neighborhood; The proposed use is not out of scale with the needs of the county as a whole. Cornelia Highway is an industrial corridor, as identified on the future land use map and 2022 Comprehensive Plan, page 23, which has identified this area as an Activity Center.
- 14. Whether it is impossible to find adequate sites for the proposed use in districts permitting such use and already appropriately zoned; There are other properties within the County that support the proposed use based on the Future Land Use Map and existing zoning designations.
- 15. Whether the need for rezoning could be handled instead by a variance request to the [Planning Commission]; The request could not be handled alternatively as a variance because it is a rezoning request.
- **16.** Whether there would be an ecological or pollution impact resulting from major modifications to the land if the request is granted; Any land disturbance activities on the property shall be required to go through the land development permitting process, and as a result are subject to local, state, and federal regulations. As a result there should not be an ecological or pollution impact resulting from any modification to the land if the request is granted.
- 17. Whether there is reasonable evidence based upon existing and anticipated land use that would indicate a mistake was made in the original zoning of the property; There is no indication that a mistake was made in the original zoning.

Planned Industrial Developments (PID, <u>17.180.090</u>) should consist of land which has been designated for a planned, organized and controlled industrial use or for multiple but compatible industrial uses in a planned industrial park. The standards employed should be designed to encourage the formation and continuance of a compatible environment for the planned industrial uses and the surrounding land uses. Carefully planned office and commercial uses may be incorporated as part of a planned industrial development.

The subject property falls within the Gateway Corridors Overlay District (GCOD, 17.420) with a small portion lying within the North Oconee Water Supply Watershed District (17.225.030).

**<u>17.380.050</u>**. - Submission requirements for a rezoning request have been met.

#### **Development Support and Constraints – Departmental / Agency Comments**

#### Hall County Environmental Health

An email dated December 13, 2022 from Emily McGahee states "Public sewer. Any abandoned well shall be properly closed as per Water Well Standards Act. Any abandoned septic tank shall be pumped by a State certified pumper/hauler and crushed/filled."

#### Hall County Fire Marshal

An email dated December 15, 2022 John Hornick, NPQ Fire Inspector 1, Plans Review Lieutenant provided the following preliminary comments:

- 1) IFC Section D104.1, buildings exceeding three stories or 30 feet in height shall have not fewer than two means of fire apparatus access for each structure.
- 2) IFC Section D104.2, buildings having a gross building area of more than 62,000 SF shall be provided with two separate and approved fire apparatus access roads.
- 3) IFC Section D104.3, where two fire apparatus roads are required, they shall be placed a distance apart equal to not less than one half of the length of the maximum overall diagonal dimension of the lot or area to be served, measured in a straight line between accesses.
- 4) IFC Section D105.2, aerial apparatus access roads shall have a minimum unobstructed width of 26' exclusive of shoulders in the immediate vicinity of the building or portion thereof.
- 5) IFC Section D103.4, dead end fire apparatus roads in excess of 150 feet shall be provided with width and turnaround provisions in accordance with table D103.4
- 6) IFC Section 903.2, where required approved automatic sprinkler systems in new buildings shall be provided in the locations described in sections 903.2.1 through 903.2.12
- 7) IFC Section 503, fire apparatus access roads shall be provided and maintained in accordance with sections 503.1.1 through 503.1.3
- 8) IFC Section 506.1, access controlled gate(s) will require a Knox key switch override device for fire department access.
- 9) IFC Section 510, emergency responder radio coverage confirmation will apply to each building
- 10) IFC Section 507, all buildings must be with in the 400' hose lay distance requirements from a fire hydrant as the truck travels. Fire hydrant(s) may have to be installed along the fire access route to meet the hose lay distance requirements.
- 11) All underground fire line shall be installed to NFPA 24 Standards.

#### Hall County Public Works and Utilities

In a memo dated December 14, 2022, from Srikanth Yamala, Director of Public Works and Utilities, provided the following comments:

#### Engineering:

This site may require a stormwater management report, should the site plan indicate the proposed development meets stormwater thresholds for impervious surface and/or disturbed acreage. Show buffer and impervious setback from wrested vegetation, not centerline of creek. North Oconee Watershed District

#### Traffic:

Driveway access of Cornelia Highway and Lula Road will need to be permitted through GDOT. Since Cagle Road is not adequate for commercial / industrial traffic, access should be from Cornelia Highway (SR354) and Lula Road (SR52) only. Access via Cagle Road should be restricted or, if considered, the roadway should be improved to County commercial / industrial standards.

#### **Utilities**

Hall County Sewer District

In a letter dated October 20, 2022 Bill Nash, Assistant Director of Public Works and Utilities for Hall County provided confirmation that there is sufficient volume to serve the development with an estimated average daily flow of 80,000 GPD. The letter continues to confirm that the existing sewer line is on the subject property. Further it states that sanitary sewer capacity allocation is available on a first come, first serve basis by purchasing the sewer taps. As such, this "availability" letter does not guarantee capacity. Additionally, this letter is non-transferable. If the project design changes, this letter is void and a new "availability" letter must be obtained.

#### **City of Gainesville Water Resources**

In a letter dated August 16, 2022, Nick Swafford, Permitting Services Manager, provided a letter confirming availability of water and sanitary sewer service for the property. Specifically, the letter states that:

"The City of Gainesville owns and operates an existing 12-inch DIP water main in the northeast right-of-way of Lula Road as well as a 12-inch DIP water main in the right-of-way of Cornelia Highway (SR 365).

Currently, the City has adequate domestic capacity for your proposed industrial park development.

This confirmation of water and sewer availability is good for one year from the date of this letter at which time, it will become null and void unless engineered plans have been submitted for issuance of a development permit."

#### **Georgia Department of Transportation**

In an email dated December 19, 2022 Parker Niebauer, confirmed this project will require GDOT coordination.

#### Excerpts from the minutes of the January 3, 2023 meeting

#### Applicant's Presentation:

Randi Doveton, Planning Director, presented a summary of the request.

Brian Rochester, 425 Oak Street, Gainesville, presented the request. The applicant stated that Hall County sewer reached the site. The applicant presented renderings of the buildings. The applicant stated that the properties were utilized for farming in the past but farming is no longer viable. The applicant stated that the buildings will be built in phases.

Kayla Maddox, 4960 Cagle Road, Lula, spoke in opposition. Concerns were traffic.

Logan Johnson, 4389 East Hall Road, Gainesville, spoke in opposition. Concerns were commercial development.

Elijah Stuart, 7609 Fern Lane, Lula, spoke in opposition. Concerns were traffic and safety.

#### **Planning Commission Comments:**

Mr. Hunt questioned if they will work with Public Works to have signage for no trucks on Cagle Road. The applicant agreed. Ms. Pilcher questioned if the applicant is willing to remove the driveway from Cagle Road. The applicant stated they do need the second entrance but they will work with staff if requested. Mr. Braswell wanted to make sure there was a 50 foot buffer to surrounding residences.

#### Zoning Analysis

The Planning Commission is hereby authorized to grant variances from the strict application of this Resolution upon proof by a preponderance of the evidence that 2.60.030.J provided the request meets the criteria set forth in 2.60.030.K.

- There are extraordinary and exceptional conditions pertaining to the particular lot in question because of its size, shape or topography (the hardship must relate to the physical character of the lot and not to a personal or economic hardship); No, there do not appear to be extraordinary and exceptional conditions pertaining to the subject property because of its size, shape, or topography.
- 2. The application of the requirements of this <u>Title 17</u> to this particular piece of property would create an unusual hardship; **The property can be developed without the requested variances.**
- Such conditions are peculiar to the particular piece of property involved and are not common to other properties in the neighborhood; and No, the conditions are not peculiar to the particular piece of property, other properties zoned Planned Industrial Development (PID, <u>17.180.090</u>) are subject to the requirements of the Tree Protection (<u>17.280</u>) and the Gateway Corridors Overlay District (GCOD, <u>17.420</u>).
- 4. Such conditions are not the result of any actions of the property owner; and **The applicant is** proposing the development standards for the project that require the variance request.
- 5. Relief, if granted, would not cause substantial detriment to the public good or impair the purposes and intent of <u>Title 17</u>; provided, however, that no variance may be granted for a use of land or building or structure that is prohibited by <u>Title 17</u> or for a conditional use which has been denied by the county planning commission. The requirements of the Tree Protection (<u>17.280</u>) code and the Gateway Corridors Overlay District (GCOD, <u>17.420</u>) were adopted by the Hall County Board of Commissioners to ensure aesthetically cohesive and consistent design standards are applied to the gateways throughout Hall County while also protecting the tree canopy and environmentally sensitive areas of the community.

#### **Development Support and Constraints – Departmental / Agency Comments**

#### Hall County Environmental Health

An email dated December 13, 2022 from Emily McGahee states "Public sewer. Any abandoned well shall be properly closed as per Water Well Standards Act. Any abandoned septic tank shall be pumped by a State certified pumper/hauler and crushed/filled."

#### Hall County Fire Marshal

An email dated December 15, 2022 John Hornick, NPQ Fire Inspector 1, Plans Review Lieutenant provided the following preliminary comments:

- 1) IFC Section D104.1, buildings exceeding three stories or 30 feet in height shall have not fewer than two means of fire apparatus access for each structure.
- 2) IFC Section D104.2, buildings having a gross building area of more than 62,000 SF shall be provided with two separate and approved fire apparatus access roads.

- 3) IFC Section D104.3, where two fire apparatus roads are required, they shall be placed a distance apart equal to not less than one half of the length of the maximum overall diagonal dimension of the lot or area to be served, measured in a straight line between accesses.
- 4) IFC Section D105.2, aerial apparatus access roads shall have a minimum unobstructed width of 26' exclusive of shoulders in the immediate vicinity of the building or portion thereof.
- 5) IFC Section D103.4, dead end fire apparatus roads in excess of 150 feet shall be provided with width and turnaround provisions in accordance with table D103.4
- 6) IFC Section 903.2, where required approved automatic sprinkler systems in new buildings shall be provided in the locations described in sections 903.2.1 through 903.2.12
- 7) IFC Section 503, fire apparatus access roads shall be provided and maintained in accordance with sections 503.1.1 through 503.1.3
- 8) IFC Section 506.1, access controlled gate(s) will require a Knox key switch override device for fire department access.
- 9) IFC Section 510, emergency responder radio coverage confirmation will apply to each building
- 10) IFC Section 507, all buildings must be with in the 400' hose lay distance requirements from a fire hydrant as the truck travels. Fire hydrant(s) may have to be installed along the fire access route to meet the hose lay distance requirements.
- 11) All underground fire line shall be installed to NFPA 24 Standards.

#### Hall County Public Works and Utilities

In a memo dated December 14, 2022, from Srikanth Yamala, Director of Public Works and Utilities, provided the following comments:

#### **Engineering:**

This site may require a stormwater management report, should the site plan indicate the proposed development meets stormwater thresholds for impervious surface and/or disturbed acreage. Show buffer and impervious setback from wrested vegetation, not centerline of creek. North Oconee Watershed District

#### Traffic:

Driveway access of Cornelia Highway and Lula Road will need to be permitted through GDOT. Since Cagle Road is not adequate for commercial / industrial traffic, access should be from Cornelia Highway (SR354) and Lula Road (SR52) only. Access via Cagle Road should be restricted or, if considered, the roadway should be improved to County commercial / industrial standards.

#### **Utilities**

Hall County Sewer District

In a letter dated October 20, 2022 Bill Nash, Assistant Director of Public Works and Utilities for Hall County provided confirmation that there is sufficient volume to serve the development with an estimated average daily flow of 80,000 GPD. The letter continues to confirm that the existing sewer line is on the subject property. Further it states that sanitary sewer capacity allocation is available on a first come, first serve basis by purchasing the sewer taps. As such, this "availability" letter does not guarantee capacity. Additionally, this letter is non-transferable. If the project design changes, this letter is void and a new "availability" letter must be obtained.

#### **City of Gainesville Water Resources**

In a letter dated August 16, 2022, Nick Swafford, Permitting Services Manager, provided a letter confirming availability of water and sanitary sewer service for the property. Specifically, the letter states that:

"The City of Gainesville owns and operates an existing 12-inch DIP water main in the northeast right-of-way of Lula Road as well as a 12-inch DIP water main in the right-of-way of Cornelia Highway (SR 365).

Currently, the City has adequate domestic capacity for your proposed industrial park development.

This confirmation of water and sewer availability is good for one year from the date of this letter at which time, it will become null and void unless engineered plans have been submitted for issuance of a development permit."

#### **Georgia Department of Transportation**

In an email dated December 19, 2022 Parker Niebauer, confirmed this project will require GDOT coordination.

#### Excerpts from the minutes of the January 3, 2023 meeting

#### Applicant's Presentation:

Randi Doveton, Planning Director, presented a summary of the request.

**Brian Rochester, 425 Oak Street, Gainesville,** presented the request. The applicant stated that Hall County sewer reached the site. The applicant presented renderings of the buildings. The applicant discussed the proffered conditions: 1. the development shall generally occur as depicted on the site plan and described in the project narrative, modified for compliance with zoning conditions and Hall County regulations. Both documents are incorporated and adopted as exhibits herein. a. The Planning Director can approve changes in the layout related to engineering constraints or specific requirements of the end user provided the revisions do not create a need for any variances, does not reduce setback requirements, meets GCOD standards (as amended herein), increase the aggregate gross floor area of the development, reduce buffers, or change the height, design, or material of the structures. 2. The standards of the Gateway Corridors Overlay District (GCOD, 17.420) shall apply to any buildings visible from Cornelia Highway / SR 365 and Lula Road / SR 52, with the exception that tilt-up concrete construction & TPO Roof Systems shall be allowed. Alternatively, if a 100-foot buffer from the Cornelia Highway / SR 365 and Lula Road / SR 52 is maintained, no GCOD standards shall be applied to these lots. 3. Remove condition. 4. All costs associated with projected related right-of way improvements, as recommended by the Keck & Wood traffic study, or as required by zoning conditions imposed by the Hall County Board of Commissioners, shall be the Developer's responsibility and completed no later than the issuance of a CO for the project's improvements on the northeast side of the stream that bisects the property. No system related improvements are required. 5. No Change. 6. No Change. 7. No Change. 8. A landscape and lighting plan, similar to those required for the Gateway Industrial Centre, shall be approved by the Planning Director prior to issuance of land disturbance permits for the individual parcels. The applicant stated that there is a 50 foot buffer for the neighboring residential lots.

#### Rebuttal

The applicant stated that the community is growing in development. The applicant stated that freight will not be going through Cagle Road. The applicant stated that there will be a 50 foot buffer as well as the stream buffer that cuts through the properties. The applicant stated that the properties were utilized for farming in the past but farming is no longer viable. The applicant stated that the buildings will be built in phases.

#### Public Forum:

Wayne Coy, 4900 Cagle Road, Lula, spoke in opposition. Concerns were narrow road and traffic.

**Brett Maddox, 4969 Cagle Road, Lula**, spoke in opposition. Concerns were safety, traffic, wrecks, commercial visibility, noise, and property values.

Joseph Thomas, 4948 Cagle Road, Lula, spoke in opposition. Concerns were commercial development flood, traffic, and mixed use.

Kayla Maddox, 4960 Cagle Road, Lula, spoke in opposition. Concerns were traffic.

**Logan Johnson, 4389 East Hall Road, Gainesville,** spoke in opposition. Concerns were commercial development.

Elijah Stuart, 7609 Fern Lane, Lula, spoke in opposition. Concerns were traffic and safety.

#### Planning Commission Comments:

Mr. Hunt questioned if they will work with Public Works to have signage for no trucks on Cagle Road. The applicant agreed. Ms. Pilcher questioned if the applicant is willing to remove the driveway from Cagle Road. The applicant stated they do need the second entrance but they will work with staff if requested. Mr. Braswell wanted to make sure there was a 50 foot buffer to surrounding residences.

No system related improvements are required. Traffic for the proposed development is not allowed on Cagle Road in any form and signage shall be coordinated.
- 6. The development shall follow all Hall County Development Review processes and Storm Water requirements for the park infrastructure.
- 7. The development shall follow standard Hall County plat review standards and process requirements.
- 8. Each parcel created within the park shall obtain separate land disturbance permits and building permits prior to commencing development.
- 9. A landscape and lighting plan similar to those required for the Gateway industrial centers shall be approved by the Planning Director prior to issuance of land disturbance permits for the individual parcels.
- 10. Developmental restricted covenants shall be recorded prior to release of the final plat.
- 11. All conditions of zoning shall be placed on the final plat.
- 12. Front building setbacks along SR 52 shall be 100 feet from the center line of the street or 75 feet from the property line, whichever is greater.
- 13. Parking space requirements and parking lot design shall meet Hall County guidelines.

# **Project Narrative for Cagle 52 Business Park**

LOCATION – Cornelia Hwy (SR 365), Lula Rd (SR 52) & Cagle Rd., Lula, GA 30554 ACREAGE – 91.51 acres +/-APPLICANT – Solidium Holdings, LLC

## **Summary**

The accompanying application seeks zoning district change from AR-IV & S-S to PID for 91.51 acres +/of undeveloped property located on Cornelia Highway (SR 365), Lula Road (SR 52) and Cagle Road in northeast Hall County. The intent is to develop a mixed-use business park that will serve industrial, commercial, highway business and office-institutional uses. The property may be developed as "pad ready" sites or sold as undeveloped parcels. This narrative will propose a unified set of standards for project. The location and proposed use is consistent with the Hall County Comprehensive Plan's designation as a "Mixed-Use Corridor" and appropriate for Hall County's Planned Industrial Development (PID) District. Completion of development is anticipated by 2033.

## Site Description

The site has approximately 550 LF of frontage along Cornelia Highway (SR 365), 1650 LF along Lula Road (SR 52) and 3000 LF along Cagle Road. A portion of the site along SR 365 is located within the Gateway Corridor Overlay District. The site is comprised of multiple tax parcels and is irregular in shape. The eastern boundary of the site is primarily Cagle Road while the northern boundary is Lula Road (SR 52). An unnamed tributary of Hagen Creek bisects the site from east to west. The site contains both cleared areas and a random stands of trees with rolling topography. Public water is available through the City of Gainesville and is located in the Lula Road (SR 52) right-of-way. Hall County public sewer is located within the site. All other dry utilities are located within a reasonable distance for service extensions. There are no known impediments to its successful development for the purposes intended.

## Adjacencies

The property is surrounded by residential zonings AR – IV to the south and east and PCD and S-S to the west. The parcel to the north (across Lula Road) is being planned as a business park also.

## **Access**

Access to the property is planned from Lula Road (SR 52), subject to GDOT approval, and from Cagle Road, subject to Hall County approval. Additionally, direct access from Cornelia Highway (SR 365) will be provided through an existing driveway and easement to the property.

## Proximity to Other Uses

 Nearest distance to undeveloped commercial property – parcel 09084 000006 zoned S-S, at 6069 Lula Rd.

- Nearest distance to developed commercial property parcel 09085 000008 zoned PCD, at 4436 Old Cornelia Hwy.
- Nearest distance to a single family home a single family home at 4969 Cagle Rd is located within 330' of the southeast boundary.
- Nearest distance to a subdivision The Riley Farm S/D is located approximately one mile south of the property.

## Comprehensive Plan Consistency

The project is consistent with the "Activity Center" of the Future Land Use Map and the primary future land uses notes as:

- Cleveland Hwy/Brookton Lula commercial uses serving local residents and proving employment opportunities; civic buildings/spaces
- Employment Activity Centers: Master planned business park or industrial park, mid-rise office
- Mixed Use Centers: Retail, office, higher density residential (including multi-family), civic uses, open/park space

The project is consistent with the Goals, Policies and Objectives of the Comprehensive Plan and is not known or believed to be in conflict with any of the above.

## Hall County Gateway Corridor Overlay District (GCOD)

A small portion of the site (550') that fronts to SR 365 is within the Hall County Gateway Corridor Overlay District. The Applicant requests a variance from Chapter 17.420 of the Hall County Code of Ordinances to allow the use of tilt-up concrete construction and TPO roof systems. Alternatively, if a 100-foot buffer is maintained from the SR 365 R/W, no GCOD standards shall apply. The Applicant commits to subjecting the property to similar covenants that have previously been adopted for the Gateway Industrial Centre

## Hall County Tree Ordinance

The Applicant requests a variance from Chapter 17.280 of the Hall County Code of Ordinances. The Applicant commits to subjecting the property to similar covenants that have been previously adopted for the Gateway Industrial Centre.

## Proposed Uses

The project may contain a variety of uses consistent with those allowed in the PID district and specifically as shown in Exhibit "A".

- 2) IFC Section D104.2, buildings having a gross building area of more than 62,000 SF shall be provided with two separate and approved fire apparatus access roads.
- 3) IFC Section D104.3, where two fire apparatus roads are required, they shall be placed a distance apart equal to not less than one half of the length of the maximum overall diagonal dimension of the lot or area to be served, measured in a straight line between accesses.



> The request before you is to consider a variance in <u>Section 16.50.040</u> to allow an existing +/- 9.5-acre lot of record to be divided into two tracts. One tract will contain an existing home and accessory structures and will consist of +/-3.93 acres; the other will contain a commercial kennel and will consist of +/-5.57 acres. As a lot of record, the property is accessed via a non-exclusive perpetual 50FT easement. The Board approved a commercial kennel (ZON2007-00113) on August 23, 2007; a variance to the rear setback for the kennel (ZON2007-00153) on November 5, 2007. The property is located in Commission District 3.

### Proposed Conditions if approved:

- 2. No further subdivision of the two newly created parcels shall be allowed.

The following note shall be placed on the plat of record: "Purchaser understands that to the extent that the property is accessed through the current common access driveway, and non-exclusive perpetual easement, the current common access driveway is not maintained by Hall County, does not meet Hall County's common driveway standards, and may not be accessible to emergency vehicles."
- 6. The two parcels shall be conveyed to one owner or entity.
- 7. Standard Hall County Platting procedures shall be followed.

### Summary Analysis

The current owners wish to subdivide an existing +/- 9.5-acre lot of record into two (2) tracts. One tract will contain an existing home and accessory structures and will consist of +/-3.93 acres; the other will contain a commercial kennel authorized by ZON2007-00113, and will consist of +/- 5.57 acres. The property was

transferred by a deed (DB 3547/198-199) in 1999 and accessed via a non-exclusive perpetual 50FT easement, also included in the deed. The 50FT easement is the flag pole to 8720 Forrester Road and serves four (4) tax parcels, including 8730 Forrester Road. Although no plat has been found in the Superior Court Clerk's online records the ZON2007-00113 includes a copy of recorded plat and the historical zoning maps indicate that the property was a lot of record since 1965. The Planning Commission and Board of Commissioners approved the construction of a commercial kennel (ZON2007-00113) on August 23, 2007; a variance in the rear setback for the kennel (ZON2007-00153) on November 5, 2007, a house (RES1999-00155), a barn (MIS2007-00443), a swimming pool (MIS2020-00072), and kitchen remodel in 2019.

The adjacent properties to the east, west, and south are also zoned AR-IV and are either vacant or contain single-family dwellings. The property to the north has a zoning designation of Planned Commercial Farm Development (PCFD).

Section 17.240.130.A states that no principal building shall be placed or erected on a parcel not abutting a street or a public way not maintained by the county and the easement does not meets the definition of Public Way, as listed in 17.20.850; however, the parent parcel is a legal lot of record. The minimum lot frontage in an AR-IV district is 50FT; <u>17.20.480</u> defines "frontage" as the dimension of a lot along a street line.

<u>Section 16.50.040</u> requires access for every subdivision lot to have access over a public road or common access drive meeting the common access drive standards. The existing easement exceeds the width requirement of <u>common access drive</u> but the existing drive does not meet the current standard.

A **variances** related to access will be required if the subdivision, as presented, is approved because the proposal does not meet the above listed requirements.

• All lots are to access a public road or a common access drive (<u>16.50.040</u>).

Should the Board of Commissioners grant this variance request, the applicant must follow the standard Hall County platting procedures.

### Zoning Analysis

The Commission is hereby authorized to grant variances from the strict application of this Resolution upon proof by a preponderance of the evidence that:

(a) By reason of exceptional narrowness, shallowness, shape, topographical conditions, or other extraordinary situations or conditions peculiar to a specific parcel of property, the strict application of these regulations would result in peculiar or unusual, practical, difficulties to or exceptional or undue hardship upon the owner of such property; The existing parcel has existed since at least 1965 without frontage on a public right-of-way and the current owners purchased it in 1999. The parcel and three others use a 50FT non-exclusive perpetual easement for access. The owners were granted permits for the existing residence and residential ancillary buildings, and granted a land-use with a variance in required setback for a commercial kennel. During those reviews, <u>16.50.040</u> was not mentioned since the lot was a legal lot of record. The current request seeks approval to allow the property to be subdivided into two (2) tracts. The proposed parcels exceed the minimum lot area for the district but cannot meet the requirement of <u>16.50.040</u> since the parent parcel does not have road frontage.

- (b) Such variance is the minimum reasonably necessary to overcome the aforesaid exceptional conditions; The owner has approximately 800 LF along the perpetual easement but no frontage onto Forrester Road. Lots of record cannot be altered without meeting the current standards. As such, it is up to the property owner to explore options of obtaining the reuired road frontage.
- (c) Such variance can be granted without substantial impairment to the intent, purpose, and integrity of this Resolution and/or the comprehensive plan or other master plan adopted for the property; and The parcel has existed without frontage on a public right-of-way since at least 1965, as shown on the historical zoning map. The perpetual easement is referenced in the 1999 deed. Permits were issued for the home in 1999 and the kennel in 2007. The proposal will not increase the intensity of the use nor the traffic. Both parcels will continue to be served by the perpetual easement and the concrete drive that currently serve the property.
- (d) Such variance will not be detrimental to the use and enjoyment of adjoining or neighboring properties. These provisions, however, shall not permit the Commission to grant any variance to any setback or yard requirements for property zoned for commercial or industrial purposes when such property abuts or immediately adjoins any property zoned for residential purposes unless such residential property is proposed for commercial or industrial use on the comprehensive land development plan. The proposal should not have a detrimental impact to the adjacent properties since the use will not change.

### STATEMENT OF HARDSHIP

The Hall County Planning Commission has the authority, in specific cases, to grant variances from the terms of the Zoning Regulations when the variance will not be contrary to the public interest where, owing to special conditions, a literal enforcement of the Zoning Regulations will, in specific cases, result in unnecessary hardship and so that the resolution shall be observed, public safety and welfare secured, and substantial justice done. 1. There are extraordinary and exceptional conditions pertaining to the particular piece of property in question because of its size, shape or topography (the hardship must relate to the physical character of the lot and not to a personal or economic hardship).

The current house, residential accessory buildings, and commercial kennel is located on a 9.49-acre parcel with no frontage on a public right-of-way.

The property is accessed via permanent perpetual non-exclusive 50FT easement. The easement is the flag pole portion of tax parcel 12128.000005, also known as 8720 Forrester Rd. The property was created by deed in the early 1990's and has continued to be transferred by deed.

The application of the requirements of this resolution to this particular property would create an unusual hardship. 2. The parcel currrently exists as a non-conforming parcel which was created by a deed in the early 1990s. Permits to construct a house, accessory buildings, and a commercial kennel were obtained between 1999 and 2020. We have a buyer for both the house and commercial

kennels but the purchaser must obtain loans from 2 differrent sources; therefore, th property must be subdivided.

Such conditions are peculiar to the particular piece of property involved and not common to other properties in the neighborhood. That is, the application of the regulation would deprive the applicant of the rights commonly enjoyed by

others in the neighborhood. All lots served by the flag pole prescriptive easement have the same access issue. This property is being sold to 1 owner but must be separated

to meet the lendign criteria of the bank and SBA. The property will continue to under one ownership

Such conditions are not the result of any actions of the property owner.

Relief, if granted, would not cause substantial detriment to the public good or impair the purposes and intent of this resolution provided; however, that no variance may be granted for a use of land or building or structure that is prohibited by this resolution. For example, granting the variance would not confer any special privilege that is denied

by this regulation to other property in the same zoning district. Granting a variance will not create an issue related to safety and access since nothing is changing except that an existing parcel with an existing

residential use and commercial use is being sold to one buyer with separate lien holders

The request before you is the request of Walter R. Hope/Total Construction to rezone 127.81± acres. The purpose of the rezoning request is to have consistent zoning on the parcel instead having a split zoning. The intent is to construct a single family dwelling and barn on one portion and to seek a conditional use to allow caretaker residences on the portion currently zoned as R-I-L. The conditional use application will be heard by the Planning Commission at a later date. This item is located within Commission District 3.

At their February 20, 2023 meeting, the Hall County Planning Commission voted to recommend approval with five (5) conditions **(5-0)**.

There were **no written comments** submitted in advance of the Planning Commission meeting and **no one spoke during the public hearing.** 

There have been no changes to the request since the Planning Commission took action.

### Public Forum:

There were no comments in support or opposition.

### Summary Analysis

The applicant is requesting to rezone the subject properties from Residential I Low Density (R-I-L, <u>17.70</u>) & Agricultural Residential IV (AR-IV, <u>17.120</u>) to Agricultural Residential IV (AR-IV, <u>17.120</u>) for the purpose of developing the property as a private equestrian farm. The applicant's narrative describes the intent of developing a main house, stables, an equipment shed, shop and hay-shaving barn with three stalls, a riding ring, and paddocks and pastures for horses. All of the above mentioned improvements are permitted uses within the Agricultural Residential IV (AR-IV, <u>17.120</u>) district.

If the rezoning request is approved, the applicant intends to apply for conditional use approval to construct two (2) caretakers residences on the property, subject to the standards found in 17.350.120, caretaker or employee residences, as required by 17.120.030.

The applicant has requested no variances as part of this application, nor has staff identified any during the analysis of this request.

The property has a conservation easement attached to the property from the Hall County Tax Assessors recorded 4/20/2022 at DB 9108, Pages 354-355 and DB 9108, Pages 356-357.

A permit for an agricultural barn is pending on this property, as of 2-10-2023, with the following conditions from the Planning Department attached to the permit (HRNEW23-0238):

"As per application and site plan presented, approval is authorized for a stable with equipment shed and personal workshop. Future shed as shown on site plan is not authorized by this release. Primary residence

as shown on site plan shall require a separate permit. Workshop is for personal use and no commercial or business activity is authorized by this approval. Stables is authorized for 4 horses. Stabling 5 horses or boarding for other people shall constitute an equestrian center and require HCPC and BOC approval. Subject to requirements of Environmental Health, Building Inspections, and all other applicable local, state, and federal regulations."

# Based on the future land-use plan, staff finds the <u>requested zoning designation consistent</u> with the future land use classification of Rural in the <u>Comprehensive Plan</u>.

### Zoning Analysis

The proposed use of having a single family residence with associated accessory structures is consistent with the permitted uses within the Agricultural Residential IV (AR-IV, 17.120) zoning district. The applicant intends to use the property as a private equestrian center. If the rezoning request is approved then the applicant intends to submit a conditional use request for two (2) caretaker residences.

When considering a zoning amendment to the zoning maps, the following items must be considered:

- 1. Whether the zoning proposal will permit a use that is suitable in view of the use and development of adjacent and nearby property; Yes, the proposed use is suitable in view of the use and development of adjacent and nearby property. The subject property is located in the eastern portion of the county, where larger parcels and agricultural uses are common.
- 2. Whether the zoning proposal will adversely affect the existing use or usability of adjacent or nearby property; The zoning proposal should not adversely affect the existing use or usability of adjacent or nearby properties. The proposed use of a private equestrian farm is consistent with the surrounding development pattern.
- Whether the property to be affected by the zoning proposal has reasonable economic use as currently zoned. The subject property is zoned both Residential I Low Density (R-I-L, <u>17.70</u>) & Agricultural Residential IV (AR-IV, <u>17.120</u>). Within the R-I-L district caretaker residences are not a permitted use. The applicant would not be able to construct the intended caretaker residence on the R-I-L portion of the property.
- 4. Whether the zoning proposal will result in a use which will or could cause an excessive or burdensome use of existing streets, transportation facilities, or utilities; No, the proposed use should not cause an excessive or burdensome use of existing streets, transportation facilities, or utilities. The applicant is proposing a maximum of 3 residences (one primary and two caretaker) on approximately 127 acres.
- 5. Whether the zoning proposal is in conformity with the policy and intent of the land use plan; Yes, the requested zoning designation consistent with the future land use classification of Rural in the <u>Comprehensive Plan</u>.
- 6. The extent to which property values are diminished by the existing zoning restrictions; Staff has not identified that the existing property values have been impacted by the existing zoning.
- 7. The extent to which the destruction of the subject property's value under the existing zoning promotes the health, safety, morals or general welfare of the public; **Staff is unable to comment on the impact of property values without a full market analysis. Multiple factors impact property value including**

construction types, proposed uses, and maintenance. Often it is difficult to determine the effect of a development on adjacent properties until the development is completed.

- 8. The relative gain to the public as compared to the hardship imposed upon the individual property owner; Staff has not identified a hardship imposed on the property owner as the property is currently zoned.
- 9. The length of time the property has been vacant as zoned considered in the context of land development in the area in the vicinity of the property; Hall County aerial imagery shows various accessory structures on the property, though the applicant states that the property is currently vacant.
- **10.** Whether there are other existing or changing conditions affecting the use or development of the property which give supporting grounds for either approval or disapproval of the zoning proposal; **There are no known changing conditions affecting the use or development of the property.**
- 11. Whether the change would create an isolated district unrelated to the surrounding districts; No, rezoning the property from Residential I Low Density (R-I-L, <u>17.70</u>) to Agricultural Residential IV (AR-IV, <u>17.120</u>) will be consistent with adjacent properties.
- **12.** Whether the present zoning district boundaries are illogically drawn in relation to existing conditions in the area; **There is no evidence that the present zoning district boundaries are illogically drawn.**
- 13. Whether the change requested is out of scale with the needs of the county as a whole or the immediate neighborhood; The proposed use is not out of scale with the needs of the county as a whole. The preservation of large agricultural tracts of land in the eastern portion of the county are consistent with the intent of the rural future land use classification in the <u>Comprehensive Plan</u>.
- 14. Whether it is impossible to find adequate sites for the proposed use in districts permitting such use and already appropriately zoned; There are other properties within the County that support the proposed use based on the Future Land Use Map and existing zoning designations.
- 15. Whether the need for rezoning could be handled instead by a variance request to the [Planning Commission]; No, the request could not be handled alternatively as a variance as the requested use is not permitted within the Residential I Low Density (R-I-L, <u>17.70</u>).
- **16.** Whether there would be an ecological or pollution impact resulting from major modifications to the land if the request is granted; There are no significant changes proposed to the site. Further, any land disturbance activities on the property shall be required to go through the land development permitting process, and as a result are subject to local, state, and federal regulations. As a result there should not be an ecological or pollution impact resulting from any modification to the land if the request is granted.
- 17. Whether there is reasonable evidence based upon existing and anticipated land use that would indicate a mistake was made in the original zoning of the property; There is no evidence to indicate a mistake was made in the original zoning of the property.

Per <u>17.120.010</u> (permitted uses within the AR-IV zoning district) site-built single-family detached dwellings are a permitted use. Site-built single-family detached dwelling unit is defined in <u>17.20.1052</u> as "a single-family detached dwelling constructed on the building site from basic materials delivered to the site, and which is constructed in accordance with all requirements of the Building Code as adopted by Hall County." There may only be one site-build single-family detached dwelling unit on each parcel.

In addition to this structure the applicant is proposing to construct two (2) caretaker residences, subject to the approval of the Planning Commission, per the requirements of <u>17.120.030</u>. A caretaker or employee residence is defined in 17.20.280 as an accessory residence (including manufactured homes) placed on an occupied tract for use by a bona fide caretaker, employee or the owner himself and approved by the zoning board of adjustment in accordance with <u>17.350.120</u>. Subject to approval by the Planning Commission, in the Agricultural Residential IV (AR-IV, <u>17.120</u>) zoning district, one caretaker and/or employee residence may be permitted for each five acres.

### 17.380.050. - Submission requirements for a rezoning request

- A. Any person or persons requesting a change in the official zoning map or use subject to approval of the county commission shall file an application with a plat or map of the property attached thereto, together with payment of such fees set forth in <u>chapter 17.30</u> to cover administrative and advertising costs, in the planning department office. Such person or persons or their authorized agent shall appear in person at the public hearing held to consider the district change. Proposal meets the requirement. Applicant has paid the appropriate fees and understands that someone must be present at both the Hall County Planning Commission meeting and the voting meeting of the Hall County Board of Commissioners.
- B. All applications for a change of zoning classification or use subject to approval of the county commission shall include:
  - A narrative statement identifying the existing and proposed use of the property and addressing each of the criteria set forth in section 17.380.060.C of this section [chapter]. In cases where only a plat or map is provided and no land use is proposed, the planning commission and county commission shall evaluate the application based on the most intense possible land use permitted in the proposed district. The submitted site plan is hand drawn and not to scale, but does show the approximate locations of the proposed residences and accessory structures on the site.
- C. For any application for a slow rate land treatment system (see <u>chapter 17.20</u>), the following additional requirements apply. This standard is not applicable as the site will be served an onsite septic system.
- D. For any application proposing the development of 100 or more residential dwelling units, a traffic impact study shall be submitted prior to consideration of the application by the planning commission. At the applicant's expense, the traffic impact study shall be prepared by a professional engineer in accordance with requirements established by the Hall County Engineering Department. The engineering department shall review the traffic impact study and forward any comments to the Hall County Planning Commission. As there are not 100 or more residential dwelling units proposed this question is not applicable.



The vote was 5-0 and no one spoke in favor or opposition during the public hearing.

## <u>A RESOLUTION TO AMEND THE CODE OF ORDINANCES OF HALL COUNTY</u> WITH REGARD TO SPITE STRIPS AND STREET FRONTAGE REQUIREMENTS

WHEREAS, Hall County has developed zoning regulations governing street frontage requirements found in Chapter 17.240 of the Official Code of Hall County, Georgia; and

WHEREAS, due to the creation of Lake Lanier and other developments, Hall County historically permitted the subdivision of lots along established easements or private ways during the period generally ending before January 2000, and

WHEREAS, many of such lots remain landlocked and present challenges to their owners and the County's staff in determining the uses that may be permitted on such properties; and

WHEREAS, the Board of Commissioners has determined that it is in the County's best interest to assist the owners of such lots and property by taking steps to avoid the designation of these lots as landlocked and non-conforming to existing regulations; and

WHEREAS, the Board of Commissioners has determined that it is in the best interest of County residents to remove barriers to the use and marketability of certain landlocked and nonconforming parcels when access has historically been provided by a recorded easement or private way; and

WHEREAS, the County has determined that amendments should be made to the County's street frontage requirements so as to provide lot frontage regulations for certain lots accessed only by private easements or ways; and

WHEREAS, the County has also determined that provisions should be added to the Official Code of Hall County so as to prohibit "spite strips" which are defined as portions of lots that run for sixty feet or more along a public road with an average depth of the strip along the public road of less than forty feet; and

WHEREAS, the County's Board of Commissioners believes that the elimination of spite strips will benefit the County's landowners and residents by encouraging access and frontage to public streets and roads; and

WHEREAS, the County's Board of Commissioners believes that the above-referenced changes to its zoning code as described herein are in the best interests of residents and businesses of Hall County, Georgia, and would promote the public health, safety, and general welfare of such residents and businesses.

**NOW, THEREFORE,** the Board of Commissioners does hereby amend The Official Code of Hall County, Georgia as follows:

1.

Section 17.240.130 (Street frontage requirements) of the Official Code of Hall County, Georgia is hereby amended by deleting subsection A in its entirety, and by replacing it with a new subsection A which provides as follows:

"17.240.130. - Street frontage requirements.

- A. No principal building shall be placed or erected on a lot or parcel which does not abut:
  - 1. A street or road shown on the official county road map or otherwise maintained by a governmental unit; or
  - 2. An existing public way not maintained by the county; or

- 3. A newly created street which meets the standards of the county subdivision regulations; or
- 4. An existing private way serving as the sole access for no more than five lots, provided that such private way is depicted on a recorded plat created before January 1, 2000."

2.

Chapter 17.240 of the Official Code of Hall County, Georgia is further amended by adding a new Section 17.240.170 which provides as follows:

"17.240.170 – Spite strips and access to landlocked property.

Spite strips shall be prohibited. A spite strip is a portion of a lot that runs for sixty feet or more along a public road with an average depth of the strip along the public road of less than forty feet.

Any landlocked lot of record which is served by an easement and which is within 100 feet of the public road where such easement originates or connects shall be deemed to meet all road frontage requirements of this Code.

3.

The remaining provisions of Chapter 17.240 of the Hall County Code of Ordinances shall remain as they were, unchanged by this amendment.

## Public Forum

There were no comments in support or opposition.

#### **Summary Analysis**

Staff and legal have discovered areas of Chapter 17.20, Section 17.20.1110 (Definitions – Street, arterial), Section 17.20.1120 (Definitions – Street, collector), Section 17.20.1130 (Definitions – Street, Connector) & Section 17.240.040 (Setbacks from arterial streets). These definitions and regulations are being changed and Appendix B is being removed in its entirety because of conflict with other portions of the regulations. This proposed amendment will correct those items.

When considering a text amendment, the Planning Commission must follow the same procedural guidelines as for a rezoning request (<u>17.380.040</u>), this includes public notice. The proposal was advertised in the Gainesville Times but since the proposal is not related to a specific parcel, no signs were posted.The staff report includes strikethrough and additions.

## STREET, ARTERIAL

The current definition is as follows:

1. Section 17.20.1110 (Definitions – Street, arterial) "Street, arterial" means a major street,

highway or state route with intersections at grade and direct access to abutting

property, and on which geometric design and traffic control measures are used to expedite the safe movement of through traffic between major traffic generators.

#### The new proposal is as follows:

- Section 17.20.1110 (Definitions Street, arterial) is hereby amended by deleting Section 17.20.1110 in its entirety and inserting in lieu thereof a new Section 17.20.1110 which provides as follows:

The County shall compile and maintain an approved record of collector streets. See also "Street, residential collector.

### STREET, CONNECTOR

## The current definition is as follows:

3. Section 17.20.1130 (Definitions Street, connector) "Connector street" means a street supplementary to the major state and U.S. highway systems running throughout the country and primarily a means of intercommunication between this system and smaller areas.

### The new proposal is as follows:

3. Section 17.20.1130 (Definitions – Street, connector) is hereby amended by deleting Section 17.20.1130 in its entirety and inserting in lieu thereof a new Section 17.20.1130 which provides as follows:

"Street, connector" or "connector street" means a street supplementary to the major state and U.S. highway systems running throughout the country and primarily a means of intercommunication between this system and smaller areas. The County shall compile and maintain an approved record of connector streets.

## SETBACKS FROM ARTERIAL STREETS

## The current ordinance reads:

4. Section 17.240.040. Setbacks from arterial streets. No structure may be placed less than 100 feet from the center line of an arterial street (as defined in section 17.20). Arterial streets shall be so designated by the county commission. (See appendix B.)

## The new proposal is as follows:

4. Section 17.240.040 (Setbacks from arterial streets) is hereby amended by deleting Section

## A RESOLUTION TO AMEND THE CODE OF ORDINANCES OF HALL COUNTY WITH REGARD TO ZONING REGULATIONS

WHEREAS, Hall County has developed comprehensive regulations governing zoning and development in the County found in Title 17 of the Official Code of Hall County, Georgia; and

WHEREAS, the County's Board of Commissioners wishes to alter current regulations to clarify the code relating to road frontage and setbacks from certain streets, to delete its current list of roads found in Appendix B and replace that list with updated lists, and provide for more clear designation and listing of various County roads; and

WHEREAS, the County's Board of Commissioners wishes to provide for a more efficient and clear method for defining and designating certain County roads for purposes of road frontage and setbacks, and

WHEREAS, the County's Board of Commissioners believes that these changes to its zoning and development regulations as described herein are in the best interests of residents and businesses of Hall County, Georgia, and would promote the public health, safety, and general welfare of such residents and businesses.

**NOW, THEREFORE,** the Board of Commissioners does hereby amend The Official Code of Hall County, Georgia as follows:

1.

Section 17.20.1110 (Definitions – Street, arterial) is hereby amended by deleting Section 17.20.1110 in its entirety and inserting in lieu thereof a new Section 17.20.1110 which provides as follows:

""Street, arterial" or "arterial street" means a major street, highway, or state route with intersections at grade and direct access to abutting property, on which geometric design and traffic control measures are used to expedite the safe movement of through traffic between major traffic generators. The County shall compile and maintain an approved record of arterial streets."

2.

Section 17.20.1120 (Definitions – Street, collector) is hereby amended by deleting Section 17.20.1120 in its entirety and inserting in lieu thereof a new Section 17.20.1120 which provides as follows:

""Street, collector" or "collector street" means any street designed and located to collect traffic from intersecting minor streets while still giving access to abutting property, so as to conduct such traffic to and from a variety of destinations outside a single subdivision, neighborhood, or business district. The County shall compile and maintain an approved record of collector streets. See also "Street, residential collector"."

3.

Section 17.20.1130 (Definitions – Street, connector) is hereby amended by deleting Section 17.20.1130 in its entirety and inserting in lieu thereof a new Section 17.20.1130 which provides as follows:

""Street, connector" or "connector street" means a street supplementary to the major state and U.S. highway systems running throughout the country and primarily a means of intercommunication between this system and smaller areas. The County shall compile and maintain an approved record of connector streets." Section 17.240.040 (Setbacks from arterial streets) is hereby amended by deleting Section 17.240.040 in its entirety and inserting in lieu thereof a new Section 17.240.040 which provides as follows:

"No structure may be placed less than 100 feet from the center line of an arterial street (as defined in Section 17.20). The County maintains an approved list of arterial streets per Section 17.20."

5.

Chapter 17 of the Hall County Code is further amended by deleting Appendix B thereto in its entirety.

6.

The remaining provisions of Title 17 (Zoning Regulations) of the Hall County Code of Ordinances shall remain as they were, unchanged by this amendment.

## A RESOLUTION TO AMEND THE CODE OF ORDINANCES OF HALL COUNTY WITH REGARD TO SUBDIVISION REGULATIONS

WHEREAS, Hall County has developed comprehensive regulations governing subdivisions in the County found in Title 16 of the Official Code of Hall County, Georgia; and

WHEREAS, Hall County has amended its zoning and development regulations found in Title 17 of the Official Code of Hall County, Georgia regarding road frontage and arterial and collector streets; and

WHEREAS, the County's Board of Commissioners wishes to alter the County's subdivision regulations, and particular its ordinances relating to road frontage on arterial or collector streets so as to reduce the minimum road frontage subject to review by the County's engineers, and to make the County's subdivision regulations consistent with the zoning code as to the definition of collector streets; and

WHEREAS, the County's Board of Commissioners believes that these changes to its subdivision regulations as described herein are in the best interests of residents and businesses of Hall County, Georgia, and would promote the public health, safety, and general welfare of such residents and businesses.

**NOW, THEREFORE,** the Board of Commissioners does hereby amend The Official Code of Hall County, Georgia as follows:

Section 16.20.090 (Collector street) is hereby amended by deleting Section 16.20.090 in its entirety and inserting in lieu thereof a new Section 16.20.090 which provides as follows:

"Collector street" shall have the same meaning as contained in Chapter 17.20 of the Hall County Zoning Code."

### 2.

Section 16.50.040 (Access) is hereby amended by deleting Section 16.50.040 in its entirety and inserting in lieu thereof a new Section 16.50.040 which provides as follows:

"Access to every subdivision lot shall be provided over a public road or over a common access driveway which meets the standards set forth in the driveway regulations. The planning commission may control access to freeway, expressway, arterial, and collector roads by requiring all buildings to face and have access to only minor roads. (See planning department for guidelines.) In any subdivision not involving the construction of new roads and in any minor subdivision (as defined by the Hall County zoning regulations), all new lots accessing a road designated as an arterial street or collector street (as defined in Chapter 17.20 of the Hall County Code) shall have a minimum frontage of 90 feet, with driveways identified and approved by the Hall County Engineer or his or her designee to ensure adequate sight distance for vehicles entering the roadway to avoid collisions."

The remaining provisions of Title 16 (Subdivisions) of the Hall County Code of Ordinances shall remain as they were, unchanged by this amendment.

WHEREAS, the Board of Commissioners has determined that the revisions to Chapter 12.20 of The Official Code of Hall County, Georgia attached hereto as Exhibit A are in the best interest of the residents of Hall County, and will promote the health, safety, and general welfare of the residents and businesses in Hall County.

**NOW, THEREFORE,** the Board of Commissioners does hereby amend The Official Code of Hall County, Georgia as follows:

## CHAPTER 2.20. - COUNTY ROAD SYSTEM

## 12.20.010. - Established; official road map.

The county will recognize and maintain as part of the county road maintenance system (hereinafter "system") those publicly maintained roads or streets within the county which are shown on the official road map of the county dated November 10, 1975, as revised from time to time, and those roads or streets which have been accepted into the system by action of the county board of commissioners, since the latest revisions to the map. A road which is accepted into the system shall be known as a publicly maintained road.

## 12.20.020 - Road acceptance standards.

The board of commissioners or its designee shall establish standards for acceptance for various classes of roads accepted into the county's system. These standards shall be known as the county road maintenance system acceptance standards (hereinafter "standards"). Except as provided in this Chapter, all persons applying for acceptance of a road into the system must establish compliance with the provisions of the standards.

## 12.20.030 - Contents of application for road acceptance.

Owners of property which abuts a road adjacent to a publicly maintained road may petition the board of commissioners for acceptance of the road into the system by making application to the county's department of Public Works and Utilities (hereinafter "department").

- A. In all cases, the application shall contain the following:
  - 1. The name, address, telephone number, and signature of each owner adjacent to the road which is proposed for acceptance;
  - 2. An adequate description of the road sought to be accepted into the county's system that reasonably describes it for purposes of land records, such as by legal description, survey, plat, or other sufficient methods;
  - 3. Proof of express dedication of the road to public use evidenced by a right-of-way deed, properly executed, witnessed, and notarized in accordance with state law and acceptable for recording, and conveying to the county the minimum necessary right-of-way required for the class of road involved according to then existing standards, or proof of implied dedication as evidenced by permitted open, continuous, and notorious use by the public, or both;
  - 4. Proof of express acceptance by the board of commissioners of such dedication evidenced by entry on the minutes of the commission or proof of implied acceptance of such dedication by acts of the county constituting maintenance, improvement, or control over the road;
  - 5. Proof that the road is a road dedicated to the public and open to vehicular traffic, and is not a private road, a developer's road, or a driveway;
  - 6. Proof that there is an average of one house per 500 linear feet of road; and
  - 7. Proof that the road serves a public purpose.
- B. As to roads which were previously publicly maintained roads, the application shall also contain:

- 1. Proof that the road was previously a publicly maintained road, maintained by the county, which burden of proof shall be on the applicant(s);
- 2. If the road needs to be upgraded to a condition that allows for county maintenance, a proposal for the payment of fees sufficient to cover the costs of the necessary upgrade. The Department of Public Works and Utilities shall determine the amount of the fees to be paid, and the department's determination must reflect the cost of providing the necessary upgrading to the road. To the extent that the creation of a special taxing district is necessary in order to ensure that the fees are paid in full, the county is authorized to create such a district and assess it accordingly. In such an instance, the proposal for the payment of fees shall request that the county create such a district, and provide all of the information on the properties and property owners covered by the district that is necessary to implement accurate and timely assessments.
- C. As to roads which have never been part of the system, or as to which the applicant(s) cannot meet the burden of proof required in subsection B of this section, the application shall also contain proof that the road meets minimum standards for acceptance into the system for that class of road, as provided by the existing standards.

### 12.20.040 - Hearing on application for road acceptance.

Upon submission of a properly completed application, the county's department of Public Works and Utilities shall consider the application and prepare a written recommendation within 60 days of the submission of a completed application. The application and the department's written recommendation shall then be forwarded to the Planning Commission, together with all related documentation, which shall consider the application and recommendation at a meeting within 60 days of its submission to the Planning Commission. The Planning Commission shall consider the application, recommendation, and documentation and shall conduct a public hearing and then make a recommendation to the board of commissioners as to whether to accept or reject the application, and shall forward its recommendation, together with the application, departmental recommendation, and any additional documentation to the board of commissioners. The board of commissioners shall then, at a regularly scheduled public meeting, consider the application, departmental recommendation, Planning Commission recommendation, and any additional documentation and shall either approve the acceptance of the road or deny the acceptance of the road.

#### 12.20.050 - Procedure for road abandonment.

Whenever the board of commissioners determines that a section of the county road system has for any reason ceased to be used by the public to the extent that no substantial public purpose is served by it or that its removal from the county road system is otherwise in the best public interest, the county, by certification recorded in its minutes, accompanied by a plat or a sketch, and, after notice to property owners located thereon, and after notice of such determination is published in the newspaper in which the sheriff's advertisements for the county are published once a week for a period of two weeks, and after a public hearing on such issue, may declare that section of the county road system abandoned. Thereafter, that section of road shall no longer be part of the county road system and the rights of the public in and to the section of road as a public road shall cease. Prior to certifying the abandonment of a road or section thereof, the county shall give notice of its intention to any municipality into which or through which any part of such road passes. To the extent that the above-referenced procedures differ from those provided by Title 32 of the Georgia Code, the provisions of the Georgia Code shall control. The County shall comply with Title 32 of the Georgia Code in disposal of any property interest in any county road or street.

## **12.20.060 – Creation of special taxing district for road improvements.**

Pursuant to the Georgia Constitution, Article IX, Section II, Paragraph VI, a special district may be created for the purpose of providing street and road construction, maintenance, repair, and/or improvement.

- A. *Creation of special taxing district.* A special district may be created by resolution or ordinance of the Hall County Board of Commissioners within the unincorporated land district of Hall County, Georgia, which special district shall be composed of all of that land abutting the previously maintained public right-of-way proposed to be improved. The implementing resolution or ordinance of the board of commissioners will contain a description that adequately describes the boundaries of any such special taxing district.
- B. *Burden of proof.* Proof that the road or street proposed to be improved was a previously maintained public way shall be on the applicants or petitioners.
- C. Assessment provisions. The owner of each parcel of land in such special district shall be assessed a road improvement fee. Assessments for each affected property parcel shall be made in a fair and reasonable manner with assessments being directly tied to the purpose of providing adjacent road and street improvements. Such assessments shall become a lien against each parcel of real estate in such special district when assessed in the same manner as all other real estate tax assessments.
- D. *Payment of assessments.* The assessments provided for in paragraph B of this section shall be included in the land owner's real estate tax assessment and shall be payable in the same manner as other real estate taxes on said parcel.
- E. *Delinquency.* Failure to pay any assessment provided for in this section shall subject the responsible party to the same liens and penalties provided for failure to pay other real estate taxes on said parcel and will result in the delinquency of the entire account of said parcel. Such assessment will not be deemed paid until all real estate taxes for such parcel, including the special assessment, are paid in full.
- F. *Revenue from assessments.* The proceeds of the assessments provided for herein shall be used exclusively to defray the cost of providing road and street improvements for such special district.
- G. *Petition requirements*. As a prerequisite to the consideration of the creation of a special taxing district as provided herein for street and road construction maintenance, repair, and/or improvement, 80 percent of the landowners of the property adjacent to the previously maintained public right-of-way to be improved must petition in the affirmative the board of commissioners of Hall County asking for the creation of a special taxing district for road and street improvement.

#### 12.20.070 - Developments with private roads.

Any residential development or subdivision which includes private streets, either designated as such on the development plat or otherwise, and which seeks approval and permitting by the County must demonstrate the formation of a homeowners' association which will be responsible for the maintenance and upkeep of all private streets therein. The County shall not approve the plat for any residential subdivision or development containing private streets which does not sufficiently demonstrate to the county's administrative officials that a homeowners' association has been created and that the association has been given the full power and responsibility for future maintenance of all private streets within the development. All such private roads shall comply with the existing road standards adopted by Hall County.

## 12.20.080 – Public streets privately maintained.

- A. As of the date of the enactment of this ordinance, the county shall not designate any additional roads or streets in the unincorporated area of the county as a "public road privately maintained" on the official county road map, and no additional roads shall be accepted or designated as such after the date of the enactment hereof. All future roads shall be designated as either a private road with private maintenance or accepted into the County's public road system.
- B. Within sixty (60) days of the enactment of this ordinance, the department of Public Works and Utilities shall compile a full and accurate list of all of the existing roads and streets within the unincorporated limits of Hall County, Georgia that have been designated as a "public road privately maintained" on the county's official road map. The list shall be maintained in the department in order to keep accurate record of the designated roads and streets. Any road or street within the unincorporated limits of Hall County, Georgia that is not on the maintained list containing all roads designated "public road privately maintained" shall be designated as either a public road or a private road privately maintained.
- C. All existing streets, roads, ways, easements, and all other forms of access avenues that have been designated as "public road privately maintained" by the County shall be maintained solely by the private parties having an interest therein.

## 12.20.090 - Procedure for acceptance of roads not meeting road acceptance standards.

Owners of property which abuts a road that does not meet the county's road acceptance standards adjacent to a publicly maintained road may petition the county's board of commissioners for acceptance of the non-standard road into the system by making application to the county's department of Public Works and Utilities (hereinafter "department").

- A. In all cases, the application shall contain the following:
  - 1. The name, address, telephone number, and signature of each owner adjacent to the road which is proposed for acceptance;

- 2. An adequate description of the road sought to be accepted into the county's system that reasonably describes it for purposes of land records, such as by legal description, survey, plat, or other sufficient methods;
- 3. Proof that the road is a road open to public vehicular traffic, and is not a private road, developer's road, or driveway;
- 4. Proof that the road serves a public purpose; and
- 5. Adequate factual circumstances justifying the acceptance of the road into the county's road system.
- B. Applications not properly completed will be returned with instructions as to the deficiencies noted by the department.
- C. Upon submission of a properly completed application, the county's department of Public Works and Utilities shall consider the application and prepare a written recommendation within 60 days of the submission of said application. The application and the department's written recommendation, together with all related documentation, shall then be forwarded to the Planning Commission, which shall consider the application and recommendation at a meeting within 60 days of its submission to the Planning Commission. The Planning Commission shall consider the application, recommendation, and documentation and shall conduct a public hearing and then make a recommendation to the board of commissioners as to whether to accept or reject the application, and shall forward its recommendation, together with the application, departmental recommendation, and any additional documentation to the board of commissioners. The board of commissioners shall then, at a regularly scheduled public meeting, consider the application, departmental recommendation, Planning Commission recommendation, and any additional documentation and shall either approve the acceptance of the road or deny the acceptance of the road, subject to and contingent upon the creation of a special taxing district as described in subsection D.
- D. If following the process in subsection C the board of commissioners determines that a road which does not meet the county's minimum road acceptance standards should be accepted into the county's road system, the road shall only be accepted into the county's system contingent upon the creation of a special taxing district pursuant to Code section 12.20.060, which shall be for the purpose of providing street or road construction, maintenance, repair, and/or improvement of the accepted road. Following the road's acceptance by the board of commissioners, the department of Public Works and Utilities shall determine the extent of the construction, maintenance, repair, and/or improvement of the road, repair, and/or improvement of the construction and maintenance, repair, and/or improvement of the road necessary to ensure: (1) continued safety for public travel on the road, (2) acceptable construction and maintenance of drainage facilities on or near the road, and (3) proper maintenance of the special taxing district and subsequently inform all landowners of the amount, extent, and duration of the resulting assessment, and the County shall then create the necessary special taxing district via resolution or ordinance.
- E. As to all roads accepted into the county's road system pursuant to this section that do not meet the county's road acceptance standards, the department of Public Works and Utilities shall maintain a list of all such roads, and shall include in each such list an accurate description of the extent and boundaries of the road so accepted, the construction, maintenance, repair,

and/or improvement of the road done by the county, and the amounts assessed to each landowner pursuant to the special taxing district.

•

F. Should the landowners fail to fulfill their obligations to the special taxing district as assessed by the county, the county shall have the right to remove the road from its public road system and cease all construction, maintenance, repair, and/or improvement of the road, and shall have no further such obligation.

## For the provision of Demand Services for Construction of Right-Turn Lane on Jim Hood Road At Mount Vernon Road

## **ARTICLE #101 - INTRODUCTION**

This Contract for Construction of Right-Turn Lane on Jim Hood Road At Mount Vernon Road, (hereinafter "Services") with an Effective Date \_\_\_\_\_\_\_\_\_\_\_ is by and between; <u>Hall County, Georgia</u> (hereinafter "County") located at 2875 Browns Bridge Rd, Gainesville, Georgia 30504, and <u>Chattahoochee Group, Inc.</u> located at 220 Carter St, Clermont, GA 30527 (hereinafter "Contractor"). Contractor is an entity that is legally registered and qualified, and holding any such licenses and certifications as may be required to render Services to do business in the State of Georgia. County and Contractor are known individually as a "Party" and collectively as the "Parties".

**Whereas,** the parties do mutually desire to enter into this Contract to document the provision of Services or other valuable consideration by the Contractor to the County in exchange for payment as compensation.

"This Contract is the result of <u>Task Order #2023-012</u>, the Contractor's response to the Task Order, the Scope of Work, Exhibits, Attachments, and references are all incorporated herein by reference. Therefore, in consideration of the terms-and-conditions and mutual promises contained herein, the receipt and sufficiency of which are hereby acknowledged by both parties, the parties hereto agree as follows:

#### ARTICLE #102 - CONTRACT

- A. Contractor agrees to provide the Services to the County as detailed herein in the Scope of Work, and for locations and services as described as Grading, Survey, Asphalt, Striping, Curb and gutter, Erosion control, Demo, Fencing, Traffic control. Price to include all material to complete proposed items, all cost associated with necessary equipment needed to complete scope, all taxes and fees for materials.
- B. County hereby agrees to the compensation as provided in the attached bidder's response which is-herein-incorporated thereof by

reference, for the cost of for the sum-not-to-exceed <u>\$283,665.19</u>. All payments are in arrears.

C. Reserved.

#### ARTICLE #104 – NON-EXCLUSIVE RIGHTS:

The Contract is not exclusive. The County reserves the right to select other Contractors to provide the Services similar to those described in this Contract, during the term of the Contract should the need arise or the contractor fail to perform.

#### ARTICLE #105 – CONTRACT TERM:

- A. Initial Contract Term. This Contract is effective on the date of signature shown in *ARTICLE #101* by all parties unless a future date is so noted on this contract. The term will last until completion.
- B. Contract Renewal. Reserved
- C. Contract Extension. Reserved

#### ARTICLE #106 - CONTRACT AMENDMENTS AND MODIFICATION:

This Contract can only be modified, amended, or added to in writing and fully executed by both parties hereto. This Contract document constitutes the sole and entire Contract and understanding between the parties as to the subject matter hereof, and no verbal promises have been made by either party in relation hereto.

### ARTICLE # 107 - REMEDIES AND CONTRACT PERFORMANCE:

In the event that either party to this Contract breaches this Contract, including by failure to meet the timetables set forth herein, the non-breaching party shall provide written notice to the breaching party which describes the breach of this Contract. The party whose breach is alleged shall have thirty (30) days from the date of receipt of the written notice to cure the breach or to otherwise negotiate a resolution of the breach.

If the breach has not been cured and the parties hereto have not resolved the issue described in the notice letter by thirty (30) days after receipt of the notice letter, the party authoring the letter shall be entitled to seek any and all remedies allowed by Georgia law, including damages, equitable relief, declaratory relief, specific performance, and/or seeking relief as to any bonds issued hereon. Additional provisions are;

A. Delay or Impossibility of Performance. Any failure or delay must be beyond the control of and without the fault or negligence of the Contractor. If the Services to be provided to the County are interrupted by a Force Majeure Event, as defined below, the County will be entitled to an equitable adjustment to the fees and other payments due to the Contractor under this Contract. If delay results from a subcontractor's negligent conduct or failure to perform, the Contractor shall not be excused from compliance with the terms and obligations of the Contract. Epidemics and pandemics are not considered Force Majeure events by the County.

Neither party shall be held liable or responsible to the other party nor be deemed to have defaulted under or breached this Agreement for failure or delay in fulfilling or performing any obligation under this Agreement when such failure or delay is caused by or results from causes beyond the reasonable control of the affected party, including but not limited to fire, floods, embargoes, war, acts of war, insurrections, riots, strikes, lockouts or other labor disturbances, or acts of God; provided, however, that the party so affected shall use reasonable commercial efforts to avoid or remove such causes of nonperformance, and shall continue performance hereunder with reasonable dispatch whenever such causes are removed. Either party shall provide the other party with prompt written notice of any delay or failure to perform that occurs by reason of Force Majeure. **Definition:** The term 'force majeure' as defined in Black's Law Dictionary, is 'an event or effect that can be neither anticipated nor controlled. It is a contractual provision allocating the risk of loss if performance becomes impossible or impracticable, especially as a result of an event that the parties could not have anticipated or controlled."

- **B. Obligations beyond Contract Term**. The Contract shall remain in full force and effect to the end of the specified term or until terminated or canceled pursuant to the Contract.
- C. Transition Cooperation with the County and Cooperation with other Contractors. Contractor agrees that upon termination of this Contract for any reason, it shall provide sufficient efforts and reasonable cooperation and assistance to the County to ensure an orderly and efficient transition to the County or an alternative Contractor. Further, in the event that the County has entered into or enters into contracts with other Contractors related to the Services, Contractor agrees to cooperate fully with such other Contractors. Contractor shall not engage in any act that will interfere with the performance of work by any other Contractor.

# **ARTICLE # 108 - TERMINATION:**

Either party may terminate this Contract by providing thirty (30) days written notice to the other party at any time. Should either party terminate this Contract prior to the date of automatic termination pursuant to section 4 above, Contractor shall provide the County with all deliverables up to the date of termination (30 days after the notice is provided), and the County shall pay the Contractor for all work properly performed in compliance with the terms of the Contract up to the date of termination.

- A. **Termination for Convenience.** Following thirty (30) days written notice, either party may terminate the Contract in whole or in part for any reason without the payment of any penalty or incurring any further obligation to the Contractor.
- B. **Termination for Cause**. The occurrence of any one or more of the following events shall constitute cause for the County to declare the Contractor in default of its obligations under the Contract:
  - 1. The Contractor fails to deliver or has delivered nonconforming Services or fails to perform, to the County's satisfaction, any material requirement of the Contract or is in violation of a material provision of the Contract, including, but without limitation, the express warranties made by the Contractor.
  - 2. The County determines that satisfactory performance of the Contract is substantially endangered or that a default is likely to occur.
  - 3. The Contractor fails to make substantial and timely progress toward performance of the Contract.

- 4. The Contractor becomes subject to any bankruptcy or insolvency proceeding under federal or state law to the extent allowed by applicable federal or state law including bankruptcy laws; the Contractor terminates or suspends its business; or the County reasonably believes that the Contractor has become insolvent or unable to pay its obligations as they accrue consistent with applicable federal or state law.
- 5. The Contractor has failed to comply with applicable federal, state and local laws, rules, County ordinances, regulations and orders when performing within the scope of the Contract.
- 6. The Contractor has engaged in conduct that has or may expose the County or the State to liability, as determined in the County's sole discretion; or a material breach of the terms of the Contract by County upon County's failure to cure such material breach after written notice thereof has been delivered in accordance with ARTICLE #108.C. below constitutes cause for the Contractor to declare that the County is in default of its obligations under the Contract.
- **C.** Notice of Default. If either party causes one or more of the default events set out in ARTICLE #108, then either party shall issue a written Notice-of-Default to the party that causes one or more of the default events, requesting that the breach or noncompliance be remedied within the period of time specified in the party's Notice-of-Default to the Contractor. If the breach or noncompliance is not remedied within the period of time specified in the written notice, the non-breaching party may:
  - 1. Immediately terminate the Contract for default without additional written notice;
  - 2. In the event of a breach by the Contractor, the County may procure substitute Services from another source and charge the difference between the Contract and the substitute Contract to the defaulting Contractor; and/or,
  - 3. Enforce the terms and conditions of the Contract and seek any legal or equitable remedies.

# C. Termination Due to Non-Availability of Funds.

This Contract will terminate immediately and absolutely if the County determines that adequate funds are de-appropriated such that the County cannot fulfill its obligations under the Contract, such determination being at the County's sole discretion and conclusive. County agrees to provide prompt written notice to Contractor in the event of any de-appropriation.

# D. Termination due to Failure of Contractor to Act.

The County may terminate the Contract for any one or more of the following reasons effective immediately without advance notice:

- 1. In the event that the Contractor must be certified or licensed as a condition precedent to providing the Services, the revocation or loss of such license or certification may result in immediate termination of the Contract effective as of the date on which the license or certification is no longer in effect.
- 2. The County determines that the actions, or failure to act, of the Contractor, its agents, employees or sub-Contractors have caused, or reasonably could cause, life, health or safety to be jeopardized.
- 3. The Contractor furnished any statement, representation, or certification in connection with the Contract or the bidding process, which is materially false, deceptive, criminal activity, incorrect or incomplete.
- 4. Failure of the Contractor to obtain, provide, maintain, and deliver the Performance and Payment Bonds (if required) as and when required under this Contract, or failure to comply with any requirement pertaining to the appropriate amounts thereof as set forth in ARTICLE #123 PERFORMANCE AND PAYMENT BOND REQUIREMENT.
- E. Payment Limitation in Event of Termination. In the event of termination of the Contract for any reason by either party, the County shall pay only those amounts, if any, due and owing to the Contractor for Services actually received and accepted by the County up to and including the date of termination of the Contract and for which the County is obligated to pay pursuant to the Contract.
- F. The Contractor's Termination Duties. Upon receipt of notice of termination, the Contractor shall:
  - 1. Cease work under the Contract and take all necessary or appropriate steps to limit disbursements and minimize costs and furnish a report within thirty (30) days of the date of notice of termination, describing the status of all work under the Contract, including, without limitation, results accomplished, conclusions resulting therefrom, and any other matters the County may require.
  - 2. Immediately cease using and return to the County, any personal property or materials, whether tangible or intangible, provided by the County to the Contractor.
  - 3. Comply with the County's instructions for the timely transfer of any active files and work product produced by the Contractor under the Contract.
  - 4. Cooperate in good faith with the County, its employees, agents, and Contractors during the transition period between the notification of termination and the substitution of any replacement Contractor; and
  - 5. Immediately return to the County any payments made by the County for goods and services that were not delivered by the Contractor.

# ARTICLE # 109 - NO DEFENSE OR INDEMNIFICATION BY COUNTY:

The parties agree that the County shall not be responsible for defending or indemnifying any Contractor from any claim brought by any third party against the Contractor.

# ARTICLE #110 - ASSIGNMENT AND DELEGATION BY CONTRACTOR:

The Contractor shall not assign or delegate this Contract, or any performance required by it, in whole or in part, without the prior express written consent of the County.

# ARTICLE #111 – USE OF THIRD PARTIES (Sub-Contractors):

This Contract is for the benefit of the parties hereto only and is not intended to benefit any third-party or give rise to any duty or causes of action for any third party. All restrictions, obligations and responsibilities of the Contractor under the Contract shall also apply to third parties such as sub-Contractors, if allowed in writing by the County. Any Contract with a subcontractor must also preserve the rights of the County.

# ARTICLE #112 – SUPERSEDES FORMER CONTRACTS

Unless otherwise specified in the Contract, this Contract supersedes all prior Contracts or Agreements between the County and the Contractor for the Services provided in connection with the Contract.

# ARTICLE #113 - SEVERABILITY:

If any paragraph, sub-paragraph, sentence, clause, phrase, or portion of this Contract is declared invalid or unconstitutional by any Court of competent jurisdiction or if the provisions of any part of this Contract as applied to any particular situation or set of circumstances shall be declared invalid or unconstitutional, such invalidity shall not be construed to affect the remaining portions of this Contract not so held to be invalid or the application of this Contract to other circumstances not so held to be invalid.

# ARTICLE # 114 - RECORDS:

- A. Public Records Request. The Georgia Open Records Act, as provided in O.C.G.A. § 50-18-70 et seq, requires procurement records and all other records received by or prepared or maintained on behalf of the County, shall be made open to public inspection, unless otherwise provided by law.
- B. Record Retention and Access. The Contractor agrees to maintain books, records, and documents in accordance with generally accepted accounting principles and procedures,

and which sufficiently and properly document and calculate all charges billed to the County throughout the term of the Contract, for a period of at least five (5) years, following the date of final payment or completion of any required audit, whichever is later. The Contractor is required to keep both financial records and service records.

## ARTICLE # 115 - ADDITIONAL TERMS:

- A. The County shall not be bound by any terms and conditions included in any Contractor's literature, packaging, invoice, catalog, brochure, technical data sheet, on-line representation, warranties or service level agreement or other document which attempts to impose any condition in variance with or in addition to the terms and conditions contained herein.
- B. The County shall not be bound to any Terms and Conditions of the Contractor that are only accessible by hyper-link. All Terms and Conditions must be in print and approved by the County.

### ARTICLE # 116 - WAIVER:

The failure of any party hereto to seek a remedy for any alleged breach of this Contract shall not constitute a waiver of any claim, cause of action, or remedy allowed by Georgia law for breach thereof.

# ARTICLE # 117 - CONTRACTOR AND COUNTY RIGHTS AND OBLIGATIONS:

- A. The County has the right at any time to require the Contractor to put an immediate stop to any procedure, or the use of any equipment (chemical, material, etc., if applicable) considered by the County to be hazardous (or toxic) to persons, buildings, or surfaces. The Contractor will utilize acceptable substitutes as quickly as possible. In the event of such replacement, Contractor shall notify County of any resulting replacement, (ii) introduce the individual serving as the replacement to County, and (iii) provide County with a résumé and any other information regarding the individual that may be reasonably requested by County.
- B. The County has the right to require the Contractor to reassign or remove any employee or subcontractor's employee from the premises temporarily or permanently when, in the County's sole opinion, the employee is not suitable. The County's decision on this matter shall be final, and Contractor will remove this employee immediately and replace with a person of at least equivalent training, experience and requisite qualifications as quickly as possible, subject to the County's prior approval.
- C. Contractor agrees to obtain prior written approval from the County for the use of sub-Contractors to provide the Services described in *SCOPE OF SERVICES* prior to subcontractor's performance of work.

### ARTICLE # 118- INSURANCE REQUIREMENT:

A. Insurance Requirements. The Contractor must maintain and warrant to Hall County insurance policies at the Contractor's own expense and must furnish the County with a Certificate of Insurance (COI) providing evidence of proof of coverage at least in the amounts indicated in this subsection. The insurance certificate must list Hall County, Georgia, as the certificate holder and as an additional insured under the commercial general, automobile and umbrella liability policies as follows: "Hall County Government, its Board of Commissioners, its officers, employees and agents, 2875 Browns Bridge Rd, Gainesville, GA 30504".

The policy must protect the Contractor and the County (as a Certificate Holder and Additional Insured) from any claims for bodily injury, property damage, or personal injury covered by the indemnification obligations set forth herein throughout the duration of the Contract.

The Contractor must maintain the following insurance coverage during the term of the Contract, in at least the minimum amounts set forth below, to cover all loss and liability for damages on account of bodily injury, including death therefrom, and injury to or destruction of property caused by or arising from any and all services carried on and any and all work performed by the Contractor pursuant to this Contract:

 Workers Compensation Insurance (Occurrence) in the amounts of the statutory limits established by the General Assembly of the State of Georgia (A self-insurer must submit a certificate from the Georgia Board of Workers Compensation stating that the Contractor qualifies to pay its own workers compensation claims.). In addition, the Contractor must require all sub-Contractors occupying the premises or performing work under the Contract to obtain an insurance certificate showing proof of Workers Compensation Coverage with the following minimum coverage:

a.	Bodily injury by accident - per employee	\$ 100,000
b.	Bodily injury by disease - per employee	\$ 100,000
C.	Bodily injury by disease – policy limit	\$ 500,000

2. Commercial General Liability Policy with at least the following minimum coverage:

3.	Umbrella Liability, Excess Liability per Occurrence	\$2,000,000

It shall be the responsibility of the Contractor to require all of its sub-Contractors to maintain Commercial General Liability insurance with business automobile liability coverage with companies and limits as stated above, and to provide a certificate evidencing that such insurance is in effect upon request. Endorsement must be provided with the insurance certificate.

B. **Insurance Certificates and General Requirements.** No Contract performance shall occur unless and until the County receives required insurance certificates.

The insurance certificate must reference the Contract number assigned by the County and document that the liability coverage purchased by the Contractor includes contractual liability coverage to insure the indemnity agreement as stated herein.

- C. The Contractor understands and agrees that the foregoing policies will not be canceled, or not renewed or allowed to lapse for any reason until at least thirty (30) days prior written notice has been given to the County, or until such time as other valid and effective insurance coverage acceptable in every respect to the County and providing protection equal to protection called for in the policies referenced in this section shall have been received, accepted, and acknowledged by the County. Certificates of insurance showing such coverage to be in force shall be filed with the County prior to commencement of any work under the Contract. The foregoing policies shall be obtained from insurance companies licensed to do business in Georgia and, unless waived or modified in writing by the County, shall be an insurer with a minimum A.M. Best Rating of "A-". All such coverage shall remain in full force and effect during the term and any renewal or extension thereof. The insurance certificate must be submitted with this Contract.
- D. Waiver of Subrogation. There is no waiver of subrogation rights by either Party with respect to insurance.

## ARTICLE # 119 - NO WAIVER:

A. **Authority to Enter into Contract.** The Contractor represents and warrants that it has full authority to enter into and perform its obligations under the Contract and that the Contract constitutes a legal, valid, and binding obligation upon the Contractor in accordance with its terms. The representatives of the parties hereto also represent and warrant that they are authorized to sign this Contract on behalf of each party hereto."

- B. Solicitation. The Contractor warrants that no person or selling agency (except bona fide employees or selling agents maintained for the purpose of securing business) has been employed or retained to solicit and secure the Contract upon an agreement or understanding for commission, percentage, brokerage or contingency.
- C. Vehicles and Equipment. Contractor warrants that its employees will not use, drive or otherwise operate any County owned vehicles or equipment in the performance of this Contract without express written consent. Contractor shall be responsible for providing all transportation necessary to deliver Services under the Contract.

# ARTICLE # 120 – INTELLECTUAL PROPERTY RIGHTS & OWNERSHIP:

Contractor agrees it will not use the name or any intellectual property, including but not limited to, County trademarks or logos in any manner, including commercial advertising or as a business reference, without the expressed prior written consent of the County.

### ARTICLE # 121 - COMPENSATION:

- A. The County will pay the Contractor for the Services provided pursuant to this Contract and in accordance with the prices quoted and conditions set forth in the Bidder's response, which is attached hereto and incorporated into this Contract as if fully set forth herein. Payments will be made in arrears to the Contractor after acceptance of the Contractor's delivered Services by the County, and after receipt of undisputed invoice to the County.
- B. Prices quoted shall be firm and fixed throughout the term of this Contract, unless otherwise Amended or Modified by mutual agreement.
- C. Cost may be prorated for Services added or removed under this Contract to align cost with the remaining term of Contract.
- D. It is understood that this bid or proposal is made without collusion or fraud.
   Contractor understands and acknowledges that collusive bidding is a violation of state and federal law and may result in the cancellation of the Contract.

### ARTICLE # 122 - COUNTY PAYMENT TO CONTRACTOR:

A. The County will issue a Notice to Proceed to the Contractor, and Purchase Order(s) (herein after 'PO'). The terms of this Contract shall be incorporated by reference into any and all PO(s) issued prior to the expiration or termination of this Contract. The County will issue the PO by electronic mail (e-mail) to the Contractor's representative in *ARTICLE #103 - NOTICES*. A PO is considered

"issued" when the e-mail containing the PO is sent by the County to the Contractor.

The Contractor shall not deliver any Services, equipment, devices, or components thereof until authorized in writing by the County through issuance of a PO, which shall provide a commencement Notice-to-Proceed date. Any work, including but not limited to travel, preliminary meetings, planning, etc., performed outside of the terms and conditions of and before the issuance of the PO will not be considered for payment. Contractors are not to begin work or ship any product on any verbal communication from within the County.

The County will not be liable for payment for any work or product with the issuance of a verbal communication. The Scope of Services shall remain in effect from the Notice to Proceed to completion of the project. The Parties agree that the County will not pay or otherwise compensate the Contractor for any Services, materials, equipment, devices or components thereof outside of the Scope of Work and/or beyond the term of this Contract, unless specifically authorized in writing as evidenced by an amendment (see ARTICLE #106 - CONTRACT AMENDMENTS &, MODIFICATION), a time extension letter, or as otherwise authorized by the County.

# B. Invoice/Payment.

- Contractor shall invoice the County via email [List] solely to accountspayable@hallcounty.org and only after the County inspects and accepts the Services provided. Receipt of the Services does not constitute acceptance. Invoice amounts shall not exceed the Contractor's pricing set forth in ARTICLE #102.
- 2. Each invoice shall include the Contractor's current "Remit to" address; a description of the Services provided; the invoice amount; the Contract number; and the associated PO number issued. Each properly prepared invoice must be sent in accordance with the instructions listed on the PO. Standard payment terms are net 30 days (N30) in arrears from the date the invoice is accepted, following delivery of the Services.
- 3. The County does not pay for services not yet received but only in arrears.
- 4. The Contractor shall be solely responsible for paying all costs, expenses and charges it incurs in connection with its performance under the Contract.

### C. Unsatisfactory Performance; Delay of Payment.

1. If the County determines that the quality of the Services provided are deficient, unacceptable, or unsatisfactory, the County's Project Manager identified in *ARTICLE #103* shall issue a written notice to Contractor. Contractor agrees that upon receipt of the written notice, it shall make every effort to correct the deficiency (ies) within the timeframe prescribed

therein. If the Contractor fails to timely correct the deficiencies, the County reserves the right to delay payment pursuant to this *ARTICLE #122* or terminate the Contract (*ARTICLE #108 – TERMINATION PROVISIONS*).

- 2. Delay of Payment Due to Contractor's Failure. If the County determines that the Contractor has failed to perform or deliver any Services as required by the Contract, the Contractor shall not be entitled to any compensation under the Contract until such Services are delivered and accepted. In this event, the County may withhold that portion of the Contractor's compensation, which represents payment for Services that were not delivered. To the extent that the Contractor's failure to perform or deliver in a timely manner causes the County to incur costs, the County may deduct the amount of such incurred costs from any amounts payable to Contractor. The County's authority to deduct such incurred costs shall not in any way affect the County's authority to terminate the Contract.
- D. Set-Off Against Sums Owed by the Contractor. In the event that the Contractor owes the County any sum under the terms of the Contract, pursuant to any judgment, or pursuant to any law, the County may set off the sum owed by the Contractor against any sum owed to the Contractor, in the County's sole discretion.
- E. **Final Payment.** Contractor shall issue an invoice for final payment to the County no later than thirty (30) days following the expiration or termination date of the Contract.
- F. The Contractor must not "Factor or Assign Payments" to another or a financial institution. The County will only pay the party to whom it is contracted with. The County will not in any circumstances pay a third-party.

## **ARTICLE #123 – PERFORMANCE AND PAYMENT BONDS**

The Contractor must furnish to the County a Performance Bond equal to one-hundred percent (100%) of the Contract's total initial term dollar amount, and additionally a Payment Bond equal to one-hundred percent (100%) of the total initial term dollar amount. After receipt of the bonds, the County will issue a Notice-to-Proceed. Only surety companies licensed to do business in the State of Georgia are acceptable. The Contractor is required to provide new bonds at the issuance of each Renewal Option Term(s) or Extension(s) that follow.

# The County must receive all bonding instruments prior to the commencement of any work.

# ARTICLE #124 – RETAINAGE (not applicable on this contract)

"Retainage (if required) will be withheld by Hall County in compliance with Georgia law. Hall County may hold up to ten-percent (**10%**) retainage throughout the entire project and will release said retainage at the point of final completion and final acceptance by the County."

# ARTICLE #125 - VENUE AND GOVERNING LAW

The parties agree that this Contract shall be interpreted, construed, and enforced in accordance with the laws of the State of Georgia. To the extent that either party brings suit to enforce the terms of this Contract, including suit in equity, the parties agree and consent to file any such suit in the Superior Court of Hall County, Georgia.

# ARTICLE # 126 - NOTICE OF INTENT TO LITIGATE

Contractor hereby agrees not to file any civil action of disputes or claims relating to the Contract except after first giving thirty days (30) written notice to the County of the claim and the intent to initiate a civil action.

# ARTICLE # 127- GEORGIA SECURITY AND IMMIGRATION COMPLIANCE ACT:

- A. By signing this Contract, the Contractor certifies that prior to and throughout the performance of all applicable work under this Contract it will remain in full compliance with all federal and state immigration laws, including but not limited to 8 U.S.C. § 1324a and the Georgia Security and Immigration Compliance Act (O.C.G.A. §13-10-90 et seq.), as amended by the Illegal Immigration Reform and Enforcement Act of 2011, regarding the verification of employment eligibility of employees under the Immigration Reform and Control Act of 1986. Contractor will ensure that only persons who are citizens or nationals of the United States or non-citizens authorized under federal immigration laws are employed to perform services under this Contract or any subcontract or sub-subcontract hereunder.
- B. Contractor further certifies its compliance with the aforementioned federal and state immigration laws set forth by signing a sworn affidavit, the Georgia Security and Immigration Compliance Act Affidavit, notarized by an Official Notary Public, and obtaining the same affidavits from any sub-contractor providing services pursuant to this Contract.

## ARTICLE # 128 - ORDER OF PRECEDENCE:

In the event of any inconsistency, ambiguity, or conflict among the specific provisions of the Contract and the Contractor's Response, the order of precedence shall be as follows:

- A. First, any amendments to the Contract, including all Exhibits thereto.
- B. Second, the Contract itself, including all Exhibits thereto.
- C. Third, Attachments appended to the Contract.

# ARTICLE # 129- CONTRACT EXHIBITS AND ATTACHMENTS:

The Parties mutually acknowledge that any following Exhibits and Attachments listed below made a part of this Contract, as though expressly written in the RFQ/P documents and the bidder's response, are-herein-incorporated into this contract by reference.

# ARTICLE # 130 - ENTIRE CONTRACT:

This Contract, as executed and approved, shall constitute the entire agreement between the Parties and supersedes all other prior and contemporaneous statements, agreements, and understandings between the Parties. No written or oral statements, agreements, or understandings that are not set out, referenced, or specifically incorporated in this Contract shall in any way be binding or of effect between the Parties.

# ARTICLE # 131- VALIDITY

If any paragraph, sub-paragraph, sentence, clause, phrase or any portion of this agreement shall be declared invalid or unconstitutional by any Court of competent jurisdiction or if the provisions of any part of this agreement as applied to any particular situation or set of circumstances shall be declared invalid or unconstitutional, such invalidity shall not be constructed to affect the portions of this agreement not so held to be invalid or the application of this agreement to other circumstances not so held to be invalid. The parties hereby declare that this is the intent of the parties to this agreement is to provide for separate and divisible parts.

# ARTICLE #132 – SALES TAX EXEMPTION STATUS

The County is exempt from Federal Excise Taxes and from Georgia State and Local Sales and Use Taxes on the Services. The Contractor may request a copy of the County's Georgia Sales and Use Tax Exemption Certificate.

## ARTICLE #133 – HOLD HARMLESS AGREEMENT

The successful respondent hereby agrees to indemnify, hold free and harmless, Hall County Government, County Commissioners, its agents, employees, officers, directors and elected officials, or any other person(s) against any loss or expense. This includes attorney fees, because of any liability imposed by law upon the County, except in cases of the County's sole negligence, sustained by any person(s) on account of bodily injury or property damage arising out of or in the consequence of this agreement.

# ARTICLE # 134 – CONTRACT TERMS AND CONDITIONS

- 1. All purchases must comply with The Official Code of Hall County Sections 3.10.010 3.10.190.
- 2. If any conflict or ambiguity arises between the Terms and Conditions herein, and The Official Code of Hall County, the latter will govern.
- 3. The Terms and Conditions set forth herein shall supersede and govern over all Contractor's Terms and Conditions or Service Level Agreements.
- 4. Hall County, Georgia, herein referred to as 'The County', retains the right to 'red-line' sections of the Supplier's Terms and Conditions if such are in conflict with the best interest of the County.
- 5. Acceptance of a Purchase Order (PO) and delivery of Goods or Services serves as the Supplier's full and complete acceptance of The County's Terms and Conditions.
- 6. The terms; supplier, vendor, bidder, offeror, Contractor, Contractor, designer, distributor, dealer or manufacturer or otherwise purveyor or source of supply or performance of service shall mean one-and-the-same, herein denoted as 'Supplier' for goods and 'Contractor' for services.
- 7. Furthermore, the terms; goods, materials, commodities, components, drawings, drafts, renderings, plans, physical or digital, software, SaaS, Engineering, Architectural, capital asset equipment, vehicles, heavy earth-moving or other equipment, purchased or leased, or other such deliverables are herein denoted as 'Goods' and shall mean one-and-the-same.
- 8. 'Services' shall mean all services, either financial, advisory, consultative, labor, staff augmentation, construction, rehabilitation, restoration, repair, support or maintenance, communication, telephony, internet, TV or streaming, pest control, grounds maintenance, custodial and janitorial, street or paved surfaces cleaning, drain cleaning or otherwise where services are offered for consideration.
- The County's payment terms are Net 30 days. The County may consider Prompt Pay Terms if offered at least five percent (5%) of the total cost and not less than fifteen (15) days terms. A supplier simply offering a discount does not constitute the County's acceptance of such, and the County is not be bound to the offer.
- 10. The Supplier shall transfer and deliver all goods or services described on the attached PO for the consideration set forth herein.
- 11. The Supplier shall only deliver goods and services as described on the PO and within the Scope of Work and the Supplier's Bid Response.
- 12. The County holds no obligation to pay for goods delivered or services rendered unless specified on a written Purchase Order or a Change Order of such.
- 13. The Supplier shall not construe any verbal consent to purchase goods or services as valid.
- 14. The County does not accept substitutions of services or goods that do not comply with the Scope of Work or Specifications set forth in the Purchase Order, Contract or Agreement, unless mutually agreed in writing by both parties.
- 15. The County does not accept automatic renewals with the exception of monthly subscription services.
- 16. The County only pays for services rendered in arrears. The County does not pay for services not yet rendered.
- 17. The County does not pay deposits towards goods ordered. Exceptions exist for custom made items (such as window coverings and blinds, or carpet, tile etc.), fabrication, decoration, or otherwise custom designed specifically for the County.

- 18. The County will accept backorders only if goods are out of stock and with prior written notice. Supplier's shall ship all quantities that it has in stock and hold orders for backorders.
- 19. The County participates in Cooperative Purchasing Agreements, State of Georgia Statewide Contracts, and other state, local, Intergovernmental Agreements, Memorandums-of-Understanding and other such Agreements.
- 20. In all cases, the jurisdiction shall be the State of Georgia, County of Hall, for arbitration or other legalities
- 21. Deliveries go to the ship-to addresses listed on the PO and within the time specified. The Supplier must follow instructions if multiple ship-to address exist on the PO.
- 22. Risk of loss of the goods shall pass to The County upon inspection and acceptance only.
- 23. Receipt of goods or services does not constitute acceptance.
- 24. Title to the goods shall remain with the Supplier until acceptance by The County.
- 25. The Supplier warrants that the goods are merchantable and that the Supplier has a legal right to deliver the goods and services and as described herein.
- 26. The County shall have the right to inspect all goods or services at the time and place of delivery.
- 27. Vendor agrees not to assign in full or part of the Contract to another party without the County's express written consent. Any attempted assignment or delegation shall void and make ineffectual for all purposes unless made in conformity with this paragraph.
- 28. The County is exempt from Federal Excise Tax and Georgia Sales and Use Tax.
- 29. This issuance of the PO shall not violate the Code of Ethics and Conflicts of Interest for Public Officers and Employees for Government Service set forth in the 2020 Section 45-1020 *et seq.* of the Official Code of Georgia Annotated and the Official Code of Hall County Section 3.10.070 governing Ethics.
- 30. All goods and services supplied pursuant to this PO shall, unless otherwise noted, must conform exactly to all of the descriptions, specifications, Exhibits and attachments contained in the Bid Solicitation upon which a PO is based and all the terms, conditions, and specifications of the Bid Solicitation are incorporated herein by reference and made a part hereof.
- 31. Any-and-all media production, recordings, videos, photography, artwork, plates, engravings, and other printed or digital media materials paid in full by The County is considered County property and shall be delivered to The County upon request.
- 32. Invoices submitted to The County will reflect the language of the PO with the PO Number printed on each invoice submitted.
- 33. In the event that a PO has an attached Contract or Agreement, the terms and conditions of the latter shall govern in the event of any conflict with these terms and conditions.
- 34. The Supplier may be suspended, terminated, or debarred if it is determined that the Supplier has made false certification(s) or has violated such certification(s) by failure to carry out the requirements herein.
- 35. The Supplier certifies that it and its subcontractors are not been debarred, suspended, or declared ineligible by any agency of the County, or State of Georgia or as defined in the Federal Acquisition Regulation (FAR) 48 C.F.R. Ch. 1 Subpart 9.4.
- 36. The Supplier certifies that the Supplier is not currently engaged in an active or pending lawsuit or other grievance, injunction, or levy against the County.
- 37. Goods are Free-On-Board (F.O.B.) destination and freight, shipping and delivery shall be prepaid and added to the invoice as a separate line item.
- 38. The County does not pay late fees nor interest charges.







§ 2 If the Contractor promptly makes payment of all sums due to Claimants, and defends, indemnifies and holds harmless the Owner from claims, demands, liens or suits by any person or entity seeking payment for labor, materials or equipment furnished for use in the performance of the Construction Contract, then the Surety and the Contractor shall have no obligation under this Bond.

§ 3 If there is no Owner Default under the Construction Contract, the Surety's obligation to the Owner under this Bond shall arise after the Owner has promptly notified the Contractor and the Surety (at the address described in Section 13) of claims, demands, liens or suits against the Owner or the Owner's property by any person or entity seeking payment for labor, materials or equipment furnished for use in the performance of the Construction Contract and tendered defense of such claims, demands, liens or suits to the Contractor and the Surety.

§ 4 When the Owner has satisfied the conditions in Section 3, the Surety shall promptly and at the Surety's expense defend, indemnify and hold harmless the Owner against a duly tendered claim, demand, lice or suit.

§ 5 The Surety's obligations to a Claimant under this Bond shall arise after the following:

§ 5.1 Claimants, who do not have a direct contract with the Contractor,

- .1 have furnished a written notice of non-payment to the Contractor, stating with substantial accuracy the amount claimed and the name of the party to whom the materials were, or equipment was, furnished or supplied or for whom the labor was done or performed, within ninety (90) days after having last performed labor or last furnished materials or equipment included in the Claim; and
- .2 have sent a Claim to the Surety (at the address described in Section 13).

§ 5.2 Claimants, who are employed by or have a direct contract with the Contractor, have sent a Claim to the Surety (at the address described in Section 13).

§ 6 If a notice of non-payment required by Section 5.1.1 is given by the Owner to the Contractor, that is sufficient to satisfy a Claimant's obligation to furnish a written notice of non-payment under Section 5.1.1.

§ 7 When a Claimant has satisfied the conditions of Sections 5.1 or 5.2, whichever is applicable, the Surety shall promptly and at the Surety's expense take the following actions:

§ 7.1 Send an answer to the Claimant, with a copy to the Owner, within sixty (60) days after receipt of the Claim, stating the amounts that are undisputed and the basis for challenging any amounts that are disputed; and

§ 7.2 Pay or arrange for payment of any undisputed amounts.

§ 7.3 The Surety's failure to discharge its obligations under Section 7.1 or Section 7.2 shall not be deemed to constitute a waiver of defenses the Surety or Contractor may have or acquire as to a Claim, except as to undisputed amounts for which the Surety and Claimant have reached agreement. If, however, the Surety fuils to discharge its obligations under Section 7.1 or Section 7.2, the Surety shall indemnify the Claimant for the reasonable attorney's fees the Claimant incurs thereafter to recover any sums found to be due and owing to the Claimant.

§ 8 The Surety's total obligation shall not exceed the amount of this Bond, plus the amount of reasonable attorney's fees provided under Section 7.3, and the amount of this Bond shall be credited for any payments made in good faith by the Surety.

The Owner shall not be liable for the payment of any costs or expenses of any Claimant under this Bond, and shall have under this Bond no obligation to make payments to, or give notice on behalf of, Claimants or otherwise have any obligations to Claimants under this Bond.

§ 11 The Surety hereby waives notice of any change, including changes of time, to the Construction Contract or to related subcontracts, purchase orders and other obligations.

§ 12 No suit or action shall be commenced by a Claimant under this Bond other than in a court of competent jurisdiction in the state in which the project that is the subject of the Construction Contract is located or after the expiration of one year from the date (1) on which the Claimant sent a Claim to the Surety pursuant to Section 5.1.2 or 5.2, or (2) on which the last labor or service was performed by anyone or the last materials or equipment were furnished by anyone under the Construction Contract, whichever of (1) or (2) first occurs. If the provisions of this Paragraph are void or prohibited by law, the minimum period of limitation available to sureties as a defense in the jurisdiction of the suit shall be applicable.

§ 13 Notice and Claims to the Surety, the Owner or the Contractor shall be mailed or delivered to the address shown on the page on which their signature appears. Actual receipt of notice or Claims, however accomplished, shall be sufficient compliance as of the date received.

§ 14 When this Bond has been furnished to comply with a statutory or other legal requirement in the location where the construction was to be performed, any provision in this Bond conflicting with said statutory or legal requirement shall be deemed deleted herefrom and provisions conforming to such statutory or other legal requirement shall be deemed incorporated herein. When so furnished, the intent is that this Bond shall be construct as a statutory bond and not as a common law bond.

- .7 the total amount of previous payments received by the Claimant; and
- .8 the total amount due and unpaid to the Claimant for labor, materials or equipment furnished as of the date of the Claim.

§ 16.2 Claimant. An individual or entity having a direct contract with the Contractor or with a subcontractor of the Contractor to furnish labor, materials or equipment for use in the performance of the Construction Contract. The term Claimant also includes any individual or entity that has rightfully asserted a claim under an applicable mechanic's lien or similar statute against the real property upon which the Project is located. The intent of this Bond shall be to include without limitation in the terms "labor, materials or equipment" that part of water, gas, power, light, heat, oil, gasoline, telephone service or rental equipment used in the Construction Contract, architectural and engineering services required for performance of the work of the Contractor and the Constructors, and all other items for which a mechanic's lien may be asserted in the jurisdiction where the labor, materials or equipment were furnished.

§ 16.3 Construction Contract. The agreement between the Owner and Contractor identified on the cover page, including all Contract Documents and all changes made to the agreement and the Contract Documents.

The Hall County Safe Passage Initiative represents a crucial investment of Federal taxpayer dollars for several compelling reasons. First and foremost, the current state of the culverts in Hall County poses an urgent safety hazard to both local residents and businesses. 











#### NURSING SERVICES AGREEMENT

This Agreement made this 1st day of July, 2023 by and between Hall County, Georgia, a political subdivision of the State of Georgia ("County") and Correctional Nursing Services, LLC, a Georgia limited liability company ("Independent Contractor").

**WHEREAS,** the County operates the Hall County Jail and Detention Center (the "Detention Center"), and desires to services of qualified personnel to provide healthcare services to the inmates housed in the Detention Center from time to time; and

WHEREAS, Independent Contractor employs qualified, licensed nursing personnel, and provides healthcare services; and

**WHEREAS,** Independent Contractor agrees to supply said personnel to perform, from time to time, the services contracted for hereunder on behalf of the County; and

**NOW, THEREFORE,** in consideration of the mutual covenants and promises of the parties hereto, it is mutually agreed as follows:

1. Nursing Services. Independent Contractor agrees to provide qualified, licensed personnel to perform nursing services and healthcare services for a base census count of approximately 1,100 inmates at the Detention Center. Independent Contractor shall manage labor, taxes, licenses, and insurance for all personnel supplied to the County to perform said Nursing Services.

2. **Compensation.** Independent Contractor shall be compensated for providing the Nursing Services described in Paragraph 1 above pursuant to the Cost Schedule attached as **Exhibit "A"** hereto and incorporated herein by reference. The County is not responsible for any overtime pay in compensation for nursing services.

**3. Term.** This Agreement shall be in effect beginning on July 1, 2023, and shall terminate on June 30, 2024.

**4. Termination without Cause.** Without cause, either party may terminate this Agreement at any time upon ninety (90) days prior written notice. In such event, the Independent Contractor, if requested by the County, shall continue to render services, and shall be paid Base Compensation up to the date of termination. Independent Contractor shall receive no severance allowance in the event this Agreement is terminated.

5. Leave. Independent Contractor shall give the County at least nine (9) days' notice prior to the intended absence of any personnel regularly scheduled to perform services hereunder whenever possible.

6. Independent Contractor. Independent Contractor shall be and is an independent contractor, and it and its employee's are not employees of the County. Independent Contractor understands, acknowledges and agrees that the County would not contract with Independent Contractor for the services hereunder except as an independent contractor. Independent Contractor declares and warrants that it has complied with all federal, state, and local laws regarding business permits and licenses that may be required to carry out the work to be performed under this Agreement. Independent Contractor

also understands, acknowledges and agrees that, as an independent contractor, Independent Contractor is not entitled to be treated as an employee with respect to its services performed hereunder for federal or state tax purposes, nor shall Independent Contractor participate in any employee fringe benefits, health benefits, vacations, holidays, employee welfare benefit plans, or employee retirement plans sponsored by the County. Independent Contractor shall not have the right, nor shall Independent Contractor represent to any person that it has any authority, to bind the County in any contractual manner.

**7. Taxes.** Payroll taxes, including federal, state, and local taxes shall not be withheld or paid by the County on behalf of Independent Contractor or for the employees of Independent Contractor. Independent Contractor shall be solely responsible to pay all taxes as mandated by law.

**8. No Joint Venture.** Nothing in this Agreement shall constitute or be construed as the creation of a partnership or joint venture.

**9. Workers Compensation.** The County shall not obtain workers' compensation insurance on behalf of Independent Contractor or the employees of Independent Contractor. Independent Contractor agrees to comply with the workers' compensation law concerning its business and its employees. Independent Contractor shall have sole responsibility for purchasing any and all liability insurance as required by law.

**10. Indemnity.** Independent Contractor's work hereunder is to be entirely at Independent Contractor's own risk and expense. Independent Contractor agrees to indemnify and hold the County harmless for any liability or loss to Independent Contractor or any third party in any manner arising out of its performance of its services hereunder, including, without limitation, all damages that may be occasioned on account of the operation of this Agreement, whether the same be for medical malpractice, personal injuries, damage to property, damages of any other kind, or for any applicable federal, state, or local taxes.

**11. Waiver of Breach**. The waiver by either party of a breach of any provision of this agreement shall not operate or be construed as a waiver of any subsequent breach. No waiver shall be valid unless in writing and signed by either party.

**12.** Notices. Any notice required or desired to be given under this agreement shall be deemed given if in writing and sent by certified mail to the County and/or Hall County Sheriff's Office at 2859 Browns Bridge Rd, Gainesville, GA 30504 and to Independent Contractor at Correctional Nursing Services, LLC c/o Linwood Zoller, M.D., 4921 Rilla Road, Gainesville, Georgia 30506.

**13. No Drafting Presumptions.** The parties have had full opportunity to participate and have participated in the drafting and revising of the language of this Agreement, and nothing in this Agreement shall be construed against the party drafting this Agreement because of having drafted this Agreement or any specific provision thereof.

14. Choice of Law. This Agreement shall be construed under the laws of the State of Georgia.

**15.** Entire Agreement. This agreement contains the entire understanding of the parties. It may not be changed orally but only by an agreement in writing signed by the party against whom enforcement of any waiver, change, modification, extension, or discharge is sought.

### EXHIBIT J

### MANDATORY ETHICS AFFIDAVIT For Compliance with Official Code 3.10.070 of Hall County

Contractors, consultants, and vendors of any service or commodity to Hall County, Georgia must read and affirm to adhere to the following ethics requirements. 3.10.070. – Ethics.

A. It is the policy of Hall County to seek the best overall value when procuring goods and services. Toward this end, the county finds and declares that its objectives will best be achieved through an open, competitive process with a broad range of responsible vendors wishing to furnish products and services to the county. Hall County will establish and conduct a procurement program that maximizes service benefit to the community and awards contracts to vendors who offer the best quality and value.

B. Hall County declares that county employees and officials, along with those wishing to do business with the county, have the shared responsibility for avoiding biased, anticompetitive, or unethical practices.

C. Hall County employees, officials, and their family members are prohibited from seeking, requesting, or receiving any material payment, gift, job offer, security, promise of future benefit, or any other tangible or intangible thing of value when such receipt has the potential to influence a procurement decision or to gain undue advantage in a procurement competition.

D. Prospective vendors must compete for county business within the parameters of the solicitation process and are prohibited from seeking to obtain inside information, attempting to skew the writing of specifications, or influencing a procurement decision through any means outside the process established for the particular solicitation. This principle applies to any contractor, subcontractor, representative, employee, or agent that may be associated with a procurement transaction.

E. Bidders and proposers shall disclose on competitive bid responses any individual(s), firm(s), and/or county official(s) who do business with the county if there is an appearance of a conflict of interest.

F. Ethical business practices are important, both, during a solicitation, and after the decision to grant an award. The county seeks to establish relationships with business partners whose ongoing ethical standards of business conduct are congruent with those outlined here. The purchasing manager, subject to the approval of the director of financial services, is charged with establishing methods for ongoing monitoring for non-compliance with these principles. The prohibition against the offering of or the acceptance of kickbacks, gratuities, payments or any other instrument of value extends beyond and outside any specific procurement or solicitation.

G. A vendor's contract compliance history with Hall County and other contractual parties is a valid element in the decision to award a solicitation.

H. Hall County stipulates that the furtherance of its strategic goals for job creation, stability and growth in the tax base, business retention, and other fiscal and economic development objectives may be considered during the procurement process. The purchasing manager, subject to the approval of the director of financial services, is authorized to establish procurement initiatives consistent with the

county's strategic economic development objectives. These procurement practices shall be applied consistently and equitably and shall have a direct relationship to the county's goals.

I. Hall County employees, officials, and their family members are generally prohibited from participation in any procurement decision or any gain of undue advantage in a procurement competition as a result of contemporaneous employment with a potential or actual business partner.

J. It is unethical for any county employee to purchase commodities or services from a county contract for personal use.

K. With the exception of solicitations for the sale of real property, individuals, firms and businesses seeking an award of a Hall County contract may not initiate or continue any verbal or written communications regarding a solicitation with any county officer, elected official, employee or other county representative other than the purchasing associate named in the solicitation, or the county's financial advisor, between the date of the issuance of the solicitation and the date of the final contract award by the board of commissioners. The purchasing manager will review violations. If determined that such communication has compromised the competitive process, the offer submitted by the individual, firm or business may be disqualified from consideration for award. Solicitations for the sale of real property may allow for verbal or written communications with the appropriate Hall County representative.

L. All county commissioners, officials, and employees shall adhere to the standards outlined in the Hall County Code of Ethics.

M. (AMENDED) The purchasing division of the financial services department shall determine and implement methods of educating all prospective contractors, bidders, proposers, and vendors on the requirements and provisions of Code Section 3.10.070, including, but not limited to, requiring each prospective contractor, bidder, proposer, and vendor that expresses an intent to do business with the County to sign an affidavit attesting that they have read this Chapter and have more specifically also read Code Section 3.10.070." (Res. of 11-14-19(1), § 1(Exh. A))

### **GOVERNMENT AGENCY CUSTOMER AGREEMENT**

This Government Agency Agreement (this "Agreement") is entered into by and between Flock Group, Inc. with a place of business at 1170 Howell Mill Rd NW Suite 210, Atlanta, GA 30318 ("Flock") and the police department or government agency identified in the signature block below ("Agency") (each a "Party," and together, the "Parties").

### RECITALS

WHEREAS, Flock offers a software and hardware solution for automatic license plate detection through Flock's technology platform (the "Flock Service"), and upon detection, the Flock Service creates images and recordings of suspect vehicles ("Footage") and can provide notifications to Agency upon the instructions of Non-Agency End User ("Notifications");

WHEREAS, Agency desires to purchase, use and/or have installed access to the Flock Service in order to create, view, search and archive Footage and receive Notifications, including those from non-Agency users of the Flock System (where there is an investigative purpose) such as schools, neighborhood homeowners associations, businesses, and individual users;

WHEREAS, because Footage is stored for no longer than 30 days in compliance with Flock's records retention policy, Agency is responsible for extracting, downloading and archiving Footage from the Flock System on its own storage devices; and

WHEREAS, Flock desires to provide Agency the Flock Service and any access thereto, subject to the terms and conditions of this Agreement, solely for the purpose of crime awareness and prevention by police departments and archiving for evidence gathering ("Purpose").

#### AGREEMENT

NOW, THEREFORE, Flock and Agency agree as follows and further agree to incorporate the Recitals into this Agreement.

#### **1. DEFINITIONS**

Certain capitalized terms, not otherwise defined herein, have the meanings set forth or cross-referenced in this Section 1.

1.1 "Authorized End User" shall mean any individual employees, agents, or contractors of Agency accessing or using the Services through the Web Interface, under the rights granted to Agency pursuant to this Agreement.

1.2 "*Agency Data*" will mean the data, media and content provided by Agency through the Services. For the avoidance of doubt, the Agency Content will include the Footage and geolocation information and environmental data collected by sensors built into the Units.

1.3 "Documentation" will mean text and/or graphical documentation, whether in electronic or printed format, that describe the features, functions and operation of the Services which are provided by Flock to Agency in accordance with the terms of this Agreement.

1.4 "Embedded Software" will mean the software and/or firmware embedded or preinstalled on the Hardware.

1.5 "*Flock IP*" will mean the Flock Services, the Documentation, the Hardware, the Embedded Software, the Installation Services, and any and all intellectual property therein or otherwise provided to Agency and/or its Authorized End Users in connection with the foregoing.

1.6 "Footage" means still images and/or video captured by the Hardware in the course of and provided via the Services.

1.7 "Hardware" shall mean the Flock Cameras and any other physical elements that interact with the Embedded Software and the Web Interface to provide the Services. The term "Hardware" excludes the Embedded Software.

1.8 "Installation Services" means the services provided by Flock regarding the installation, placements and configuration of the Hardware, pursuant to the Statement of Work attached hereto.

1.9 "Flock Services" means the provision, via the Web Interface, of Flock's software application for automatic license plate detection, searching image records, and sharing Footage.

1.10 "Non-Agency End User" means a Flock's non-Agency customer that has elected to give Agency access to its data in the Flock System.

1.11 "Non-Agency End User Data" means the Footage, geolocation data, environmental data and/or Notifications of a Non-Agency End User.

1.12 "Unit(s)" shall mean the Hardware together with the Embedded Software.

1.13 "Web Interface" means the website(s) or application(s) through which Agency and its Authorized End Users can access the Services in accordance with the terms of this Agreement.

#### 2. FLOCK SERVICES AND SUPPORT

2.1 Provision of Access. Subject to the terms of this Agreement, Flock hereby grants to Agency a non-exclusive, non-transferable right to access the features and functions of the Flock Services via the Web Interface during the Service Term and No-Fee Term, solely for the Authorized End Users. The Footage will be available for Agency's designated administrator, listed on the Order Form, and any Authorized End Users to access via the Web Interface for 30 days. Authorized End Users will be required to sign up for an account, and select a password and username ("User ID"). Flock will also provide Agency the Documentation to be used in accessing and using the Flock Services. Agency shall be responsible for all acts and omissions of Authorized End Users, and any act or omission by an Authorized End User which, if undertaken by Agency, would constitute a breach of this Agreement, shall be deemed a breach of this Agreement by Agency. Agency shall undertake reasonable efforts to make all Authorized End Users aware of the provisions of this Agreement as applicable to such Authorized End User's use of the Flock Services and shall cause Authorized End Users to comply with such provisions. Flock may use the services of one or more third parties to deliver any part of the Flock Services, including without limitation using a third party to host the Web Interface which the Flock Services make available to Agency and Authorized End Users. Flock will passthrough any warranties that Flock receives from its then current third-party service provider to the extent that such warranties can be provided to Agency. SUCH WARRANTIES, AS PROVIDED AS HONORED BY SUCH THIRD PARTIES, ARE THE CUSTOMER'S SOLE AND EXCLUSIVE REMEDY AND FLOCK'S SOLE AND EXCLUSIVE LIABILITY WITH REGARD TO SUCH THIRD-PARTY SERVICES, INCLUDING WITHOUT LIMITATION HOSTING THE WEB INTERFACE. To the extent practicable, Agency agrees to comply with any acceptable use policies and other terms of any third-party service provider that are provided or otherwise made available to Agency from time to time.

2.2 Embedded Software License. Subject to all terms of this Agreement, Flock grants Agency a limited, nonexclusive, non-transferable, non-sublicensable (except to the Authorized End Users), revocable right to use the Embedded Software as installed on the Hardware by Flock; in each case, solely as necessary for Agency to use the Flock Services.

2.3 **Documentation License.** Subject to the terms of this Agreement, Flock hereby grants to Agency a nonexclusive, non-transferable right and license to use the Documentation during the Service Term for Agency's internal purposes in connection with its use of the Flock Services as contemplated herein.

2.4 Usage Restrictions. The purpose for usage of the equipment, the Services and support, and the Flock IP is solely to facilitate gathering evidence that could be used in a criminal investigation by the appropriate government agency

and not for tracking activities that the system is not designed to capture ("Permitted Purpose"). Agency will not, and will not permit any Authorized End Users to, (i) copy or duplicate any of the Flock IP; (ii) decompile, disassemble, reverse engineer or otherwise attempt to obtain or perceive the source code from which any software component of any of the Flock IP is compiled or interpreted, or apply any other process or procedure to derive the source code of any software included in the Flock IP, or attempt to do any of the foregoing, and Agency acknowledges that nothing in this Agreement will be construed to grant Agency any right to obtain or use such source code; (iii) modify, alter, tamper with or repair any of the Flock IP, or create any derivative product from any of the foregoing, or attempt to do any of the foregoing, except with the prior written consent of Flock; (vi) interfere or attempt to interfere in any manner with the functionality or proper working of any of the Flock IP; (v) remove, obscure, or alter any notice of any intellectual property or proprietary right appearing on or contained within any of the Application IP; (vii) use the Flock Services for timesharing or service bureau purposes or otherwise for the benefit of a third party or any purpose other than the Purpose; (viii) use the Services, support, equipment and the Flock IP for anything other than the Permitted Purpose; or (ix) assign, sublicense, sell, resell, lease, rent or otherwise transfer or convey, or pledge as security or otherwise encumber, Agency's rights under Sections 2.1, 2.2, or 2.3.

2.5 **Retained Rights; Ownership.** As between the Parties, subject to the rights granted in this Agreement, Flock and its licensors retain all right, title and interest in and to the Flock IP and its components, and Agency acknowledges that it neither owns nor acquires any additional rights in and to the foregoing not expressly granted by this Agreement. Agency further acknowledges that Flock retains the right to use the foregoing for any purpose in Flock's sole discretion. There are no implied rights.

2.6 Suspension. Notwithstanding anything to the contrary in this Agreement, Flock may temporarily suspend Agency's and any Authorized End User's access to any portion or all of the Flock IP if (i) Flock reasonably determines that (a) there is a threat or attack on any of the Flock IP; (b) Agency's or any Authorized End User's use of the Flock Service disrupts or poses a security risk to the Flock Service or any other customer or vendor of Flock; (c) Agency or any Authorized End User is/are using the Flock IP for fraudulent or illegal activities; (d) Flock's provision of the Flock Services to Agency or any Authorized End User is prohibited by applicable law; or (e) any vendor of Flock has suspended or terminated Flock's access to or use of any third party services or products required to enable Agency to access the Flock (each such suspension, in accordance with this Section 2.6, a "Service Suspension"). Flock will make commercially reasonable efforts, circumstances permitting, to provide written notice of any Service Suspension to Agency (including notices sent to Flock's registered email address) and to provide updates regarding resumption of access to the Flock IP following any Service Suspension. Flock will use commercially reasonable efforts to resume providing access to the Application Service as soon as reasonably possible after the event giving rise to the Service Suspension is cured. Flock will have no liability for any damage, liabilities, losses (including any loss of data or profits) or any other consequences that Agency or any Authorized End User may incur as a result of a Service Suspension. To the extent that the service suspension is not caused by Agency's direct actions or by the actions of parties associated with the Agency, the expiration of the Term will be tolled by the duration of any suspension (for any continuous suspension lasting at least one full day).

#### 2.7 Installation Services.

2.7.1 Designated Locations. Prior to performing the physical installation of the Units, Flock shall advise Agency on the location and positioning of the Units for optimal license plate image capture, as conditions and location allow. Flock and Agency must mutually agree on the location (mounting site or pole), position and angle of the Units (each Unit location so designated by Agency, a "Designated Location"). Flock shall have no liability to Agency resulting from any poor performance, functionality or Footage resulting from or otherwise relating to the Designated Locations or delay in installation due to Agency's delay in identifying the choices for the Designated Locations, in ordering and/or having the Designated Location ready for installation including having all electrical work preinstalled and permits ready. Designated Locations. After a deployment plan with Designated Locations and equipment has been agreed upon by both Flock and the Agency, any subsequent changes to the deployment plan ("Reinstalls") driven by Agency's request will incur a charge for Flock's then-current list price for Reinstalls, as listed in the then-current Reinstall Policy (available at https://www.flocksafety.com/reinstall-fee-schedule) and any equipment charges. These changes include but are not limited to camera re-positioning, adjusting of camera mounting, re-angling, removing foliage, camera replacement, changes to heights of poles, regardless of whether the need for Reinstalls related to vandalism, weather, theft, lack of criminal activity in view, and the like.

2.7.2 Agency's Installation Obligations. Agency agrees to allow Flock and its agents reasonable access in and near the Designated Locations at all reasonable times upon reasonable notice for the purpose of performing the installation work, The "Agency Installation Obligations" include, to the extent required by the Deployment Plan, but are not limited to electrical work to provide a reliable source of 120V AC power that follow Flock guidelines and comply with local regulations if adequate solar exposure is not available. Agency is solely responsible for (i) any permits or associated costs, and managing the permitting process; (ii) any federal, state or local taxes including property, license, privilege, sales, use, excise, gross receipts or other similar taxes which may now or hereafter become applicable to, measured by or imposed upon or with respect to the installation of the Hardware, its use, or (iii) any other services performed in connection with installation of the Hardware. Any fees payable to Flock exclude the foregoing. Without being obligated or taking any responsibility for the foregoing, Flock may pay and invoice related costs to Customer if Customer did not address them or a third party requires Flock to pay. Agency represents and warrants that it has all necessary right title and authority and hereby authorizes Flock to install the Hardware at the Designated Locations and to make any necessary inspections or tests in connection with such installation.

2.7.3 Flock's Installation Obligations. The Hardware shall be installed in a workmanlike manner in accordance with Flock's standard installation procedures, and the installation will be completed within a reasonable time from the time that the Designated Locations are selected by Agency. Following the initial installation of the Hardware and any subsequent Reinstalls or maintenance operations, Flock's obligation to perform installation work shall cease; however, Flock will continue to monitor the performance of the Units and receive access to the Footage for a period of 3 business days for maintenance purposes. Customer can opt out of Flock's access in the preceding sentence, which would waive Flock's responsibility to ensure such action was successful. Agency understands and agrees that the Flock Services will not function without the Hardware. Labor may be provided by Flock or a third party.

2.7.4 Security Interest. The Hardware shall remain the personal property of Flock and will be removed upon the termination or expiration of this Agreement. Agency agrees to perform all acts which may be necessary to assure the retention of title of the Hardware by Flock. Should Agency default in any payment for the Flock Services or any part thereof or offer to sell or auction the Hardware, then Agency authorizes and empowers Flock to remove the Hardware or any part thereof. Such removal, if made by Flock, shall not be deemed a waiver of Flock's rights to any damages Flock may sustain as a result of Agency's default and Flock shall have the right to enforce any other legal remedy or right.

2.8 Hazardous Conditions. Unless otherwise stated in the Agreement, Flock's price for its services under this Agreement does not contemplate work in any areas that contain hazardous materials, or other hazardous conditions, including, without limit, asbestos. In the event any such hazardous materials are discovered in the designated locations in which Flock is to perform services under this Agreement, Flock shall have the right to cease work immediately in the area affected until such materials are removed or rendered harmless. Any additional expenses incurred by Flock as a result of the discovery or presence of hazardous material or hazardous conditions shall be the responsibility of Agency and shall be paid promptly upon billing.

2.9 Support Services. Subject to the payment of fees, Flock shall monitor the performance and functionality of Flock Services and may, from time to time, advise Agency on changes to the Flock Services, Installation Services, or the Designated Locations which may improve the performance or functionality of the Services or may improve the quality of the Footage. The work, its timing, and the fees payable relating to such work shall be agreed by the Parties prior to any alterations to or changes of the Services or the Designated Locations ("Monitoring Services"). Subject to the terms hereof, Flock will provide Agency with reasonable technical and on-site support and maintenance services ("On-Site Services") in-person or by email at hello@flocksafety.com. Flock will use commercially reasonable efforts to respond to requests for support.

2.10 Special Terms. From time to time, Flock may offer certain "Special Terms" related to guarantees, service and support which are indicated in the proposal and on the order form and will become part of this Agreement.

#### 3. AGENCY RESTRICTIONS AND RESPONSIBILITIES

3.1 Agency Obligations. Agency agrees to provide Flock with accurate, complete, and updated registration information. Agency may not select as its User ID a name that Agency does not have the right to use, or another person's name with the intent to impersonate that person. Agency may not transfer its account to anyone else without prior written permission of Flock. Agency will not share its account or password with anyone, and must protect the security of its account and password. Agency is responsible for any activity associated with its account. Agency shall be responsible for obtaining and maintaining any equipment and ancillary services needed to connect to, access or otherwise use the Services. Agency will, at its own expense, provide assistance to Flock, including, but not limited to, by means of access to, and use of, Agency facilities, as well as by means of assistance from Agency personnel, to the limited extent any of the foregoing may be reasonably necessary to enable Flock to perform its obligations hereunder, including, without limitation, any obligations with respect to Support Services or any Installation Services.

3.2 Agency Representations and Warranties. Agency represents, covenants, and warrants that Agency will use the Services only in compliance with this Agreement and all applicable laws and regulations, including but not limited to any laws relating to the recording or sharing of video, photo, or audio content and retention thereof. Although Flock has no obligation to monitor Agency's use of the Services, Flock may do so and may prohibit any use of the Services it believes may be (or alleged to be) in violation of the foregoing.

#### 4. CONFIDENTIALITY; AGENCY DATA; NON-AGENCY DATA

4.1 Confidentiality. Each Party (the "Receiving Party") understands that the other Party (the "Disclosing Party") has disclosed or may disclose business, technical or financial information relating to the Disclosing Party's business (hereinafter referred to as "Proprietary Information" of the Disclosing Party). Proprietary Information of Flock is non-public information including but not limited to features, functionality, designs, user interfaces, trade secrets, intellectual property, business plans, marketing plans, works of authorship, hardware, customer lists and requirements, and performance of the Flock Services. Proprietary Information of Agency includes non-public Agency Data, Non-Agency End User Data, and data provided by Agency or a Non-Agency End User to Flock or collected by Flock via the Unit, including the Footage, to enable the provision of the Services. The Receiving Party shall not disclose, use, transmit, inform or make available to any entity, person or body any of the Proprietary Information, except as a necessary part of performing its obligations hereunder, and shall take all such actions as are reasonably necessary and appropriate to preserve and protect the Proprietary Information and the parties' respective rights therein, at all times exercising at least a reasonable level of care. Each party agrees to restrict access to the Proprietary Information of the other party to those employees or agents who require access in order to perform hereunder. The Receiving Party agrees: (i) to take the same security precautions to protect against disclosure or unauthorized use of such Proprietary Information that the party takes with its own proprietary information, but in no event will a party apply less than reasonable precautions to protect such Proprietary Information, and (ii) not to use (except in performance of the Services or as otherwise permitted herein) or divulge to any third person any such Proprietary Information. Flock's use of the Proprietary Information may include processing the Proprietary Information to send Agency Notifications or alerts, such as when a car exits Agency's neighborhood, or to analyze the data collected to identify motion or other events.

The Disclosing Party agrees that the foregoing shall not apply with respect to any information that the Receiving Party can document (a) is or becomes generally available to the public, or (b) was in its possession or known by Receiving Party prior to receipt from the Disclosing Party, or (c) was rightfully disclosed to Receiving Party without restriction by a third party, or (d) was independently developed without use of any Proprietary Information of the Disclosing Party.

Nothing in this Agreement will prevent the Receiving Party from disclosing the Proprietary Information pursuant to any subpoena, summons, judicial order or other judicial or governmental process, provided that the Receiving Party gives the Disclosing Party reasonable prior notice of such disclosure to obtain a protective order or otherwise oppose the disclosure. For clarity, Flock may access, use, preserve and/or disclose the Footage to law enforcement authorities, government officials, and/or third parties, if legally required to do so or if Flock has a good faith belief that such access, use, preservation or disclosure is reasonably necessary to: (a) comply with a legal process or request; (b) enforce this Agreement, including investigation of any potential violation thereof; (c) detect, prevent or otherwise address security, fraud or technical issues; or (d) protect the rights, property or safety of Flock, its users, a

third party, or the public as required or permitted by law, including respond to an emergency situation. Having received notice prior to data being deleted, Flock may store Footage in order to comply with a valid court order but such retained Footage will not be retrievable without a valid court order.

4.2 **Agency and Non-Agency End User Data.** As between Flock and Agency, all right, title and interest in the Agency Data and Non-Agency End User Data, belong to and are retained solely by Agency. Agency hereby grants to Flock a limited, non-exclusive, royalty-free, worldwide license to use the Agency Data and Non-Agency End User Data and perform all acts with respect to the Agency Data and Non-Agency End User Data as may be necessary for Flock to provide the Flock Services to Agency, including without limitation the Support Services set forth in Section 2.9 above, and a non-exclusive, perpetual, irrevocable, worldwide, royalty-free, fully paid license to use, reproduce, modify and distribute the Agency Data and Non-Agency End User Data as a part of the Aggregated Data (as defined in Section 4.4 below). As between Flock and Agency, Agency is solely responsible for the accuracy, quality, integrity, legality, reliability, and appropriateness of all Agency Data and Non-Agency End User Data. As between Agency and Non-Agency End Users that have prescribed access of Footage to Agency, each of Agency and Non-Agency End Users will share all right, title and interest in the Non-Agency End User Data. This Agreement does not by itself make any Non-Agency End User Data the sole property or the Proprietary Information of Agency. Flock will automatically delete Footage older than 30 days. Agency has a 30-day window to view, save and/or transmit Footage to the relevant government agency prior to its deletion.

4.3 Feedback. If Agency provides any suggestions, ideas, enhancement requests, feedback, recommendations or other information relating to the subject matter hereunder, Agency hereby assigns (and will cause its agents and representatives to assign) to Flock all right, title and interest (including intellectual property rights) with respect to or resulting from any of the foregoing.

4.4 Aggregated Data. Notwithstanding anything in this Agreement to the contrary, Flock shall have the right to collect and analyze data that does not refer to or identify Agency or any individuals or de-identifies such data and other information relating to the provision, use and performance of various aspects of the Services and related systems and technologies (including, without limitation, information concerning Agency Data and data derived therefrom). Agency acknowledges that Flock will be compiling anonymized and/or aggregated data based on Agency Data and Non-Agency End User Data input into the Services (the "Aggregated Data"). Agency hereby grants Flock a non-exclusive, worldwide, perpetual, royalty-free right and license (during and after the Service Term hereof) to (i) use and distribute such Aggregated Data to improve and enhance the Services and for other marketing, development, diagnostic and corrective purposes, other Flock offerings, and crime prevention efforts, and (ii) disclose the Agency Data and Non-Agency End User Data (both inclusive of any Footage) to enable law enforcement monitoring against law enforcement hotlists as well as provide Footage search access to law enforcement for investigative purposes only. No rights or licenses are granted except as expressly set forth herein.

#### **5. PAYMENT OF FEES**

5.1 Fees. Agency will pay Flock the first Usage Fee, the Installation Fee and any Hardware Fee (defined on the Order Form, together the "Initial Fees") as set forth on the Order Form on or before the 7th day following the Effective Date of this Agreement. Flock is not obligated to commence the Installation Services unless and until the Initial Fees have been made and shall have no liability resulting from any delay related thereto. Agency shall pay the ongoing Usage Fees set forth on the Order Form with such Usage Fees due and payable thirty (30) days in advance of each Payment Period. All payments will be made by either ACH, check, or credit card. The first month of Services corresponding to the first Usage Fee payment will begin upon the first installation. For 10+-camera offerings where only some of the cameras are installed at the first installation and additional cameras will be installed later, prorated Usage Fees corresponding to the then-installed cameras will be invoiced to Agency immediately after installation and to the later camera installation(s) subsequently invoiced.

5.2 Changes to Fees. Flock reserves the right to change the Fees or applicable charges and to institute new charges and Fees at the end of the Initial Term or any Renewal Term, upon sixty (60) days' notice prior to the end of such Initial Term or Renewal Term (as applicable) to Agency (which may be sent by email). If Agency believes that Flock has billed Agency incorrectly, Agency must contact Flock no later than sixty (60) days after the closing date on the first billing statement in which the error or problem appeared, in order to receive an adjustment or credit.

Inquiries should be directed to Flock's customer support department. Agency acknowledges and agrees that a failure to contact Flock within this sixty (60) day period will serve as a waiver of any claim Agency may have had as a result of such billing error.

5.3 Invoicing, Late Fees; Taxes. Flock may choose to bill through an invoice, in which case, full payment for invoices issued in any given month must be received by Flock thirty (30) days after the mailing date of the invoice. Unpaid amounts are subject to a finance charge of 1.5% per month on any outstanding balance, or the maximum permitted by law, whichever is lower, plus all expenses of collection, and may result in immediate termination of Service. Agency shall be responsible for all taxes associated with Services other than U.S. taxes based on Flock's net income.

5.4 No-Fee Term Access. Subject to Flock's record retention policy, Flock offers complimentary access to the Flock System for 30 days ("No Fee Term") to Agency when Non-Agency End Users intentionally prescribe access or judicial orders mandate access to Non-Agency End User Data. No hardware or installation services will be provided to Agency. No financial commitment by Agency is required to access the Flock Services or Footage. Should such access cause Flock to incur internal or out-of-pocket costs that are solely the result of the access, Flock reserves the right to invoice these costs to Agency under Section 5.3 and Agency agrees to pay them. For clarity, No-Fee Terms and Service Terms can occur simultaneously, and when a No-Fee Term overlaps with a Service Term, Agency agrees to pay the Initial Fees and Usage Fees payments according to Section 5.1.

### 6. TERM AND TERMINATION

6.1 Term. Subject to earlier termination as provided below, the initial term of this Agreement shall be for the period of time set forth on the Order Form (the "Initial Term"). Following the Initial Term, unless otherwise indicated on the Order Form, this Agreement will automatically renew for successive renewal terms for the greater of one year and the length set forth on the Order Form (each, a "Renewal Term", and together with the Initial Term, the "Service Term") unless either party gives the other party notice of non-renewal at least thirty (30) days prior to the end of the then-current term.

6.2 Agency Satisfaction Guarantee. At any time during the agreed upon term, a customer not fully satisfied with the service or solution may self-elect to terminate their contract. Self-elected termination will result in a one-time fee of actual cost of removal, said cost not to exceed \$500 per camera. Upon self-elected termination, a refund will be provided, prorated for any fees paid for the remaining Term length set forth previously. Self-termination of the contract by the customer will be effective immediately. Flock will remove all equipment at its own convenience upon termination. Advance notice will be provided.

6.3 **Termination.** In the event of any material breach of this Agreement, the non-breaching party may terminate this Agreement prior to the end of the Service Term by giving thirty (30) days prior written notice to the breaching party; provided, however, that this Agreement will not terminate if the breaching party has cured the breach prior to the expiration of such thirty-day period. Either party may terminate this Agreement, without notice, (i) upon the institution by or against the other party of insolvency, receivership or bankruptcy proceedings, (ii) upon the other party's making an assignment for the benefit of creditors, or (iii) upon the other party's dissolution or ceasing to do business. Upon termination for Flock's breach, Flock will refund to Agency a pro-rata portion of the pre-paid Fees for Services not received due to such termination.

6.4 Effect of Termination. Upon any termination of the Service Term, Flock will collect all Units, delete all Agency Data, terminate Agency's right to access or use any Services, and all licenses granted by Flock hereunder will immediately cease. Agency shall ensure that Flock is granted access to collect all Units and shall ensure that Flock personnel does not encounter Hazardous Conditions in the collection of such units. Upon termination of this Agreement, Agency will immediately cease all use of Flock Services.

6.5 No-Fee Term. The initial No-Fee Term will extend, after entering into this Agreement, for 30 days from the date a Non-Agency End User grants access to their Footage and/or Notifications. In expectation of repeated non-continuous No-Fee Terms, Flock may in its sole discretion leave access open for Agency's Authorized End Users despite there not being any current Non-Agency End User authorizations. Such access and successive No-Fee

Terms are deemed to be part of the No-Fee Term. Flock, in its sole discretion, can determine not to provide additional No-Fee Terms or can impose a price per No-Fee Term upon 30 days' notice. Agency may terminate any No-Fee Term or access to future No-Fee Terms upon 30 days' notice.

6.6 Survival. The following Sections will survive termination: 2.4, 2.5, 3, 4, 5 (with respect to any accrued rights to payment), 6.5, 7.4, 8.1, 8.2, 8.3, 8.4, 9.1 and 10.5.

#### 7. REMEDY; WARRANTY AND DISCLAIMER

7.1 **Remedy.** Upon a malfunction or failure of Hardware or Embedded Software (a "Defect"), Agency must first make commercially reasonable efforts to address the problem by contacting Flock's technical support as described in Section 2.9 above. If such efforts do not correct the Defect, Flock shall, or shall instruct one of its contractors to, in its sole discretion, repair or replace the Hardware or Embedded Software suffering from the Defect. Flock reserves the right to refuse or delay replacement or its choice of remedy for a Defect until after it has inspected and tested the affected Unit; provided that such inspection and test shall occur within 72 hours after Agency notifies the Flock of defect. Flock agrees to replace cameras at a fee according to the then-current Reinstall Policy (https://www.flocksafety.com/reinstall-fee-schedule). Customer shall not be required to replace subsequently damaged or stolen units; however, Customer understands and agrees that functionality, including Footage, will be materially affected due to such subsequently damaged or stolen units and that Flock will have no liability to Customer regarding such affected functionality nor shall the Fees owed be impacted.

7.2 Exclusions. Flock will not provide the remedy described in Section 7.1 above if any of the following exclusions apply: (a) misuse of the Hardware or Embedded Software in any manner, including operation of the Hardware or Embedded Software in any way that does not strictly comply with any applicable specifications, documentation, or other restrictions on use provided by Flock; (b) damage, alteration, or modification of the Hardware or Embedded Software in any way; or (c) combination of the Hardware or Embedded Software with software, hardware or other technology that was not expressly authorized by Flock.

7.3 Warranty. Flock shall use reasonable efforts consistent with prevailing industry standards to maintain the Services in a manner which minimizes errors and interruptions in the Services and shall perform the Installation Services in a professional and workmanlike manner. Services may be temporarily unavailable for scheduled maintenance or for unscheduled emergency maintenance, either by Flock or by third-party providers, or because of other causes beyond Flock's reasonable control, but Flock shall use reasonable efforts to provide advance notice in writing or by e-mail of any scheduled service disruption.

7.4 Disclaimer. THE REMEDY DESCRIBED IN SECTION 7.1 ABOVE IS AGENCY'S SOLE REMEDY, AND FLOCK'S SOLE LIABILITY, WITH RESPECT TO DEFECTIVE HARDWARE AND/OR EMBEDDED SOFTWARE. THE FLOCK DOES NOT WARRANT THAT THE SERVICES WILL BE UNINTERRUPTED OR ERROR FREE; NOR DOES IT MAKE ANY WARRANTY AS TO THE RESULTS THAT MAY BE OBTAINED FROM USE OF THE SERVICES. EXCEPT AS EXPRESSLY SET FORTH IN THIS SECTION, THE SERVICES AND INSTALLATION SERVICES ARE PROVIDED "AS IS" AND FLOCK DISCLAIMS ALL WARRANTIES, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE AND NON-INFRINGEMENT. IN NO EVENT SHALL FLOCK'S LIABILITY FOR ANY AMOUNTS THAT, TOGETHER WITH AMOUNTS ASSOCIATED WITH ALL OTHER CLAIMS, EXCEED THE MAXIMUM AMOUNT OF INSURANCE COVERAGE MAINTAINED BY FLOCK (CERTIFICATE OF INSURANCE TO BE PROVIDED UPON REQUEST), IN EACH CASE, WHETHER OR NOT FLOCK HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. THIS DISCLAIMER OF SECTION 7.4 ONLY APPLIES TO THE EXTENT ALLOWED BY THE GOVERNING LAW OF THE STATE MENTIONED IN SECTION 10.6, OR IF NO STATE IS MENTIONED IN SECTION 10.6, BY THE LAW OF THE STATE OF GEORGIA.

7.5 Insurance. Flock and Agency will each maintain commercial general liability policies with policy limits reasonably commensurate with the magnitude of their business risk. Certificates of Insurance will be provided upon request.

#### 8. LIMITATION OF LIABILITY AND INDEMNITY

8.1 Limitation of Liability. NOTWITHSTANDING ANYTHING TO THE CONTRARY, FLOCK AND ITS SUPPLIERS (INCLUDING BUT NOT LIMITED TO ALL HARDWARE AND TECHNOLOGY SUPPLIERS). OFFICERS, AFFILIATES, REPRESENTATIVES, CONTRACTORS AND EMPLOYEES SHALL NOT BE RESPONSIBLE OR LIABLE WITH RESPECT TO ANY SUBJECT MATTER OF THIS AGREEMENT OR TERMS AND CONDITIONS RELATED THERETO UNDER ANY CONTRACT, NEGLIGENCE, STRICT LIABILITY, PRODUCT LIABILITY, OR OTHER THEORY: (A) FOR ERROR OR INTERRUPTION OF USE OR FOR LOSS OR INACCURACY, INCOMPLETENESS OR CORRUPTION OF DATA OR FOOTAGE OR COST OF PROCUREMENT OF SUBSTITUTE GOODS, SERVICES OR TECHNOLOGY OR LOSS OF BUSINESS; (B) FOR ANY INDIRECT, EXEMPLARY, INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES; (C) FOR ANY MATTER BEYOND FLOCK'S ACTUAL KNOWLEDGE OR REASONABLE CONTROL INCLUDING REPEAT CRIMINAL ACTIVITY OR INABILITY TO CAPTURE FOOTAGE OR IDENTIFY AND/OR CORRELATE A LICENSE PLATE WITH THE FBI DATABASE; (D) FOR ANY PUBLIC DISCLOSURE OF PROPRIETARY INFORMATION MADE IN GOOD FAITH; (E) FOR CRIME PREVENTION; OR (F) IN NO EVENT SHALL FLOCK'S LIABILITY FOR ANY AMOUNTS THAT. TOGETHER WITH AMOUNTS ASSOCIATED WITH ALL OTHER CLAIMS, EXCEED THE MAXIMUM AMOUNT OF INSURANCE COVERAGE MAINTAINED BY FLOCK (CERTIFICATE OF INSURANCE TO BE PROVIDED UPON REQUEST), IN EACH CASE, WHETHER OR NOT FLOCK HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. IN THE EVENT OF AN EMERGENCY, AGENCY SHOULD CONTACT 911 AND SHOULD NOT RELY ON THE SERVICES. Except for Flock's willful acts, Agency agrees to pay for Flock's attorneys' fees to defend Flock for any alleged or actual claims arising out of or in any way related to the No-Fee Term.

8.3 **Responsibility.** Each Party to this Agreement shall assume the responsibility and liability for the acts and omissions of its own employees, deputies, officers, or agents, in connection with the performance of their official duties under this Agreement. Each Party to this Agreement shall be liable (if at all) only for the torts of its own officers, agents, or employees that occur within the scope of their official duties. Agency will not pursue any claims or actions against Flock's suppliers.

8.4 Indemnity. [Intentionally Removed]

#### 9. RECORD RETENTION

9.1 Data Preservation. The Agency agrees to store Agency Data and Non-Agency End User Data in compliance with all applicable local, state and federal laws, regulations, policies and ordinances and their associated record retention schedules. As part of Agency's consideration for paid access and no-fee access to the Flock System, to the extent that Flock is required by local, state or federal law to store the Agency Data or the Non-Agency End User Data, Agency agrees to preserve and securely store this data on Flock's behalf so that Flock can delete the data from its servers and, should Flock be legally compelled by judicial or government order, Flock may retrieve the data from Agency upon demand.

#### **10. MISCELLANEOUS**

10.1 Severability. If any provision of this Agreement is found to be unenforceable or invalid, that provision will be limited or eliminated to the minimum extent necessary so that this Agreement will otherwise remain in full force and effect and enforceable.

10.2 Assignment. This Agreement is not assignable, transferable or sublicensable by Agency except with Flock's prior written consent. Flock may transfer and assign any of its rights and obligations, in whole or in part, under this Agreement without consent.

10.3 Entire Agreement. This Agreement, together with the Order Form(s), the then-current Reinstall Policy (https://www.flocksafety.com/reinstall-fee-schedule), and Deployment Plan(s), are the complete and exclusive statement of the mutual understanding of the parties and supersedes and cancels all previous written and oral agreements, communications and other understandings relating to the subject matter of this Agreement, and that all waivers and modifications must be in a writing signed by both parties, except as otherwise provided herein. None of Agency's purchase orders, authorizations or similar documents will alter the terms of this Agreement, and any such conflicting terms are expressly rejected.

10.4 **Relationship.** No agency, partnership, joint venture, or employment is created as a result of this Agreement and Agency does not have any authority of any kind to bind Flock in any respect whatsoever.

10.5 Costs and Attorneys' Fees. [Intentionally Removed]

10.6 Governing Law; Venue. This Agreement shall be governed by the laws of the State of Georgia without regard to its conflict of laws provisions. To the extent that the arbitration language below does not apply, the federal and state courts sitting in the State of Georgia will have proper and exclusive jurisdiction and venue with respect to any disputes arising from or related to the subject matter of this Agreement. The parties agree that the United Nations Convention for the International Sale of Goods is excluded in its entirety from this Agreement.

10.7 **Publicity.** Unless otherwise indicated on the Order Form, Flock has the right to reference and use Agency's name and trademarks and disclose the nature of the Services provided hereunder in each case in business and development and marketing efforts, including without limitation on Flock's website.

10.8 Export. Agency may not remove or export from the United States or allow the export or re-export of the Flock IP or anything related thereto, or any direct product thereof in violation of any restrictions, laws or regulations of the United States Department of Commerce, the United States Department of Treasury Office of Foreign Assets Control, or any other United States or foreign agency or authority. As defined in FAR section 2.101, the Services, the Hardware, the Embedded Software and Documentation are "commercial items" and according to DFAR section 252.2277014(a)(1) and (5) are deemed to be "commercial computer software" and "commercial computer software documentation." Consistent with DFAR section 227.7202 and FAR section 12.212, any use, modification, reproduction, release, performance, display, or disclosure of such commercial software or commercial software documentation by the U.S. Government will be governed solely by the terms of this Agreement and will be prohibited except to the extent expressly permitted by the terms of this Agreement.

10.9 **Headings.** The headings are merely for organization and should not be construed as adding meaning to the Agreement or interpreting the associated Sections.

10.10 Counterparts. This Agreement may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

10.11 Authority. Each of the below signers of this Agreement represent that they understand this Agreement and have the authority to sign on behalf of and bind the organizations and individuals they are representing.

10.12 Notices. All notices under this Agreement will be in writing and will be deemed to have been duly given when received, if personally delivered; when receipt is electronically confirmed, if transmitted by facsimile or e-mail; the day after it is sent, if sent for next day delivery by recognized overnight delivery service; and upon receipt, if sent by certified or registered mail, return receipt requested.
