- 1. The agri-entertainment business shall operate as described in the narrative and depicted on the site plan.
- 2. The agri-entertainment business shall satisfy all comments from the Environmental Health Department, Fire Marshal, Public Works and Utilities, and Georgia Department of Transportation prior to obtaining an agri-entertainment business license. Plans addressing comments, or for any further improvements or development of the property shall be submitted for review and appropriate permits obtained.
- 3. No variances are granted as part of this request.
- 4. Any expansion to the existing agri-entertainment business shall require additional approval from the County Commission.
- 5. Per, section 2.60.060. effective period of approved applications, all applications approved by the board, whether a request for variance from the terms of Title 17, a request for conditional use, a request for the enlargement, change or continuance of a nonconforming use or a request to appeal a decision by an administrative official in the enforcement of Title 17, shall be effective for a period of six months. If no action is taken by the applicant to implement the purpose of the application by obtaining the proper permit and/or license and proceeding with the building, occupancy or establishment of business within six months from the date of approval by the board, said approval shall become null and void.

Conditions:

- 1. Development is approved as generally shown on the concept plan and described in the revised project narrative dated June 2, 2023 modified as necessary for compliance with the conditions herein and development standards enforced at the time of site plan approval.
- 2. Any repair or replacement fencing along Lanier Islands Parkway shall be decorative metal with regular brick columns no less than every 50 feet. Replacement of fencing along all other property lines shall be constructed of standard wood fencing materials or vinyl-coated chain link with privacy slat inserts at a minimum but may also match the decorative metal fencing, at the owner's discretion.
- 3. The fence must be properly maintained by the owner (1997).
- 4. Fencing shall be located 10 feet from the property line (1997).
- 5. The setback from Beards Road shall be 55 feet from the centerline of the right-of-way (1997).
- 6. Vehicle parking areas shall be paved with either asphalt or concrete (2004).
- 7. Any outdoor lighting on the premises shall be non-spill type (2004).
- 8. The applicable bulk and development standards in the Suburban Shopping district (S-S) shall apply.
- 9. The following uses shall be prohibited: junk yard; salvage yard; pick and pull; storage of debris; or inoperable vehicles.

- 10. While inoperable vehicles as an ongoing storage activity is prohibited, it is anticipated that rental equipment might be in need of repair or decommissioning and may be stored on the site from time to time. Limited storage of those items is permitted, provided the equipment is stored adjacent to the eastern interior side property line and is screened by an opaque fence a minimum of six (6) feet in height.
- 11. Plans for any further improvements or development of the property shall be submitted for review and appropriate permits obtained.
- 12. All conditions of zoning shall be made a part of any plat created for the property.

- 1. Development of the subject parcel shall be limited to one (1) site-built single family residence developed with similar materials and colors as surrounding dwelling units established within the existing development. Final elevations shall be subject to the approval of the Planning Director.
- 2. The Applicant/Developer shall satisfy all comments from Environmental Health Department, Hall County Fire Marshal, Public Works and Utilities, and Georgia Department of Transportation prior to obtaining a certificate of occupancy.
- 3. The following statement regarding the potential impacts of agricultural operations in the area shall be made a part of any plat recorded on the property: "Owners, occupants, and users of property shown on this plat are hereby informed of the impacts associated with normal farming practices which may take place on adjacent and nearby property including, but not limited to, noise, odors, dust, the operation of machinery of any kind, the storage and disposal of manure, and the application of fertilizers, herbicides, and pesticides. Therefore, owners, occupants, and users of the property shown on this plat should be prepared to expect the effects of such practices."
- 4. All conditions of zoning shall be recorded on the final plat.
- 5. The only allowable uses are those allowed in R-I zoning.

Therefore, owners, occupants, and users of the property shown on this plat should be prepared to expect the effects of such practices."
