Conditions:

1. *The property shall be developed in accordance with the site plan dated December 18, 2024, and as described in the project narrative dated December 20, 2024, modified as necessary for compliance with conditions herein and development standards enforced at the time of site plan approval.*
2. *Access to the development shall be approved by the Georgia Department of Transportation. The developer shall be responsible for all costs associated with improvements necessary for access to the development.*
3. *The internal drive shall be paved with asphalt or concrete; graded aggregate base (GAB) may be used for the outdoor storage and parking areas around each building subject to final review and approval of the Hall County Engineering Department and Fire Marshal.*
4. *Any building proposed within the 300 foot limits of the Gateway Corridors Overlay District (GCOD) shall comply with GCOD architectural standards. Final review and approval of building elevations is subject to the Director of Planning and Zoning, or their designee.*
5. *Outdoor storage may be permitted outside of the 300 foot GCOD limits only if it is screened from view from Candler Road with a 6-foot tall opaque fence. Screening is subject to final review and approval by the Director of Planning and Zoning or their designee.*
6. *There shall be a 25 foot wide undisturbed buffer adjacent to the right-of-way of Candler Road. The existing mature landscape shall be supplemented with additional planted evergreens with an installation height of no less than 6 feet to provide sufficient screening of the development. Final review of the landscape plan shall be subject to the approval of the Director of Planning and Zoning, or their designee.*
7. *A 50 foot wide landscape buffer, undisturbed or planted, shall be required along all property lines abutting property zoned for agricultural or residential use. The existing mature landscape shall be supplemented with additional planted evergreens with an installation height of no less than 6 feet to provide sufficient screening of the development. Final review of the landscape plan shall be subject to the approval of the Director of Planning and Zoning, or their designee.*
8. *Retroactive building permits shall be obtained for all structures currently on-site that do not currently have a commercial building permit. Final determination is subject to the Hall County Building Official or their designee. No new buildings shall be permitted for the development until all retroactive permits have been obtained.*
9. *No business license shall be approved for the property until the site is brought into compliance with county permitting requirements.*
10. *No variances to GCOD standards and no additional variances or development exceptions are granted as part of this request that are not explicitly granted herein. The development shall comply with the Unified Development Code of Hall County, as well as any other agencies or reviewing departments, including, but not limited to the Fire Marshal and Hall County Engineering. Where there are discrepancies between the proposed standards and County regulations, the County regulations shall overrule unless otherwise approved.*
11. *All conditions of zoning shall be made a part of any plats or construction plans created for the property.*

12. *The retroactive building permit shall be obtained by the applicant within 60 to 90 days of approval of a land disturbance permit (LDP). The applicant shall utilize 3rd party inspectors to provide all necessary reports and documentation as required by Hall County permitting and inspection regulations, including any applicable penalties. No other building permits shall be approved prior to the issuance of a retroactive permit for the existing unpermitted building.*

*Mr. Propes addressed the Board regarding property tax exemptions and this property. He stated he received information today from the Tax Assessor's Office regarding property tax exemptions. OCGA 48-5-41 articulates what types of property may be exempt from ad valorem property taxes. Specifically, OCGA 48-5-41 (2.1)(A) and (B) (3).*

*(2.1) (A) All places of religious worship.*

*(B) All property owned by and operated exclusively as a church, an association or convention of churches, a convention mission agency, or as an integrated auxiliary of a church or convention or association of churches, when such entity is qualified as an exempt religious organization under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, and such property is used in a manner consistent with such exemption under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended.*

*(3) All property owned by religious groups and used only for single-family residences when no income is derived from the property.*

- 1. The property shall be developed in accordance with the site plan dated December 20, 2024, and as described in the project narrative dated December 20, 2024, modified as necessary for compliance with conditions herein and development standards enforced at the time of site plan approval.*
- 2. All proposed internal roads and driveways must meet all Hall County Traffic Engineering and Fire access requirements. However, internal roads are not required to meet criteria for public streets.*
- 3. All proposed and existing structures shall be subject to Hall County Fire Marshal and Building Inspection's standards.*
- 4. The proposed development shall maintain a 100 foot transitional perimeter buffer except where adjacent to public right-of way.*
- 5. Existing buildings within the 100 foot transitional buffer may be repaired, rebuilt, or expanded in accordance with setback requirements as specified in*



*the provided narrative. These structures may be rebuilt or enlarged at their current location, provided all new construction is located at least ten feet further from the external boundaries of the development than it currently is located. No other buildings or amenities (other than trails) shall encroach into this 100 foot buffer.*

- 6. No outdoor storage, loading or service areas shall be located within the 100 foot perimeter buffer.*
- 7. All construction within the development, including the expansion of existing structures, shall be limited to a total of 390,000 square feet and shall be restricted to: day-use facilities such as chapels and outreach centers, overnight accommodations, including staffing residences, pastoral retreats, cottages, lodges, designed to accommodate guests and ministry members, bunkhouses, bath houses, a single dining hall, and supporting amenities. The developer shall not exceed the number of units per use as outlined in the narrative, but may choose to construct fewer; in no case shall new facilities and expansion of existing structures exceed 390,000 square feet, excluding existing square footages as of January 1, 2025. Open air amenities such as trails, pavilions, and lawns shall not be included in this calculation.*
- 8. No variances or development exceptions are granted as part of this request that are not explicitly granted by Board approval. The development shall be compliant with the Unified Development Code of Hall County, as well as any other agencies or reviewing departments, including, but not limited to the Fire Marshal and Hall County Engineering. Where there are discrepancies between the proposed standards and County regulations, the County regulations shall overrule unless otherwise approved herein.*
- 9. All conditions of zoning shall be made a part of any plats or construction plans created for the development.*
