- 3. Hours of operation shall be limited to Monday through Friday 8:00 am to 7:00 pm and Saturday 8:00 am to 4:00 pm. No operations on Sunday.*

- 2. No variances or development exceptions are granted as part of this request that are not explicitly granted by board approval. The development shall be compliant with the Unified Development Code of Hall County, as well as any state regulations or other agencies or reviewing departments including Hall County Engineering for driveway placement and compliance.*
- 3. A variance is granted to eliminate the transitional buffer along the boundary abutting residentially-zoned property located at tax parcel 15021A000031B and 15021A000031.*
- 4. A 6 foot opaque fence shall be installed along the concrete loading dock abutting the residentially-zoned property located at tax parcel 15021A000031B and 15021A000031.*
- 5. No additional construction on the property shall be permitted on the building side adjacent to the 10 foot driveway easement.*
- 6. Hours of operation shall be limited to Monday through Friday 8:00 am to 7:00 pm and Saturday 8:00 am to 4:00 pm. No operations on Sunday.*
- 7. The following statement regarding the potential impacts of agricultural operations in the area shall be made a part of any plat recorded on the property: "Owners, occupants, and users of property shown on this plat are hereby informed of the impacts associated with normal farming practices*

which may take place on adjacent and nearby property including, but not limited to, noise, odors, dust, the operation of machinery of any kind, the storage and disposal of manure, and the application of fertilizers, herbicides, and pesticides. Therefore, owners, occupants, and users of the property shown on this plat should be prepared to expect the effects of such practices."

- 8. All conditions of zoning shall be made as part of any plats or construction plans created for the property.*
- 9. No more than 50% of the building shall be used as leased office space.*
