County Administrator

Mr. Propes did not have any items to report.

Mr. Gentry addressed the Board. He stated the following:

- *Planning Commission Update - Provided the Board on the proposed Planning Commission reinstatement timeline. Stated that once appointments are made, trainings will be held on planning & zoning, ethics, and administrative procedures. A mock Planning Commission meeting will also be held to reorient the Planning Commission. The goal is to have the Planning Commission to begin hearing applications sometime in July.*
- *Uniform Development Code (UDC) Update - Provided the Board a detailed timeline for updating the UDC. The plan includes launching a interactive website by May 15th for a 30-day public feedback period, followed by three public engagement meetings in June with final adoption targeted for August 27th. Commissioner Poole expressed concerns about the public input period being too short. Mr. Gentry advised that in the instance that a specific ordinance is not ready, more time could be taken to address those areas and looked at individually. Stated that this is not a complete re-write of the current UDC but to review ordinances that need attention.*

Commission Time

Commissioner Gregg Poole, District 3, spoke about the lack of accountability and internal communication within the Commission. He referenced how conditions were allegedly shared with all Commissioners except one from the relevant district. He also brought up a recent incident where he and another member of the Board were unaware of a resignation that the rest of the Board knew about. He described this as a 'real issue' of being 'constantly left out', which contributes to divisiveness.

Chairman David Gibbs agreed with Commissioner Poole. Stated that a lot of things that need to be worked on.
