Approval and authorization for the Chairman and District Commissioners to execute a resolution objecting to the annexation by The City of Flowery Branch of Tax Parcel Number 15044 000040 consisting of approximately 95.69 acres located at 0 Sasser Road, and authorization for the Chairman to execute any and all documents in relation to such objection, subject to review and approval by the County Attorney.

History:

On March 10, 2026, Hall County received notice from the City of Flowery Branch of the proposed annexation of a parcel into the City for development of a 198-unit single-family detached and attached mixed residential townhome community. The property is currently zoned PRD, and Flowery Branch proposes to rezone the property to Single-Family Attached Townhome (SF-TH).

Facts and Issues:

The property consists of approximately 95.69 acres located on Sasser Road. The City of Flowery Branch seeks to annex and rezone the property to the City's Single-Family Attached Townhome (SF-TH) district. The property is presently zoned for planned residential development, but is undeveloped, and the surrounding area consists primarily of single-family residential uses.

Options:

**RESOLUTION OBJECTING TO THE CITY OF FLOWERY BRANCH'S
ANNEXATION OF THE PROPERTY OWNED BY S.P. MCKIBBON, SR., LLP.,
KNOWN AS HALL COUNTY TAX PARCEL 15044 000040**

WHEREAS, Hall County has received a notice of filing by the City of Flowery Branch of a petition for annexation of property owned by S.P. McKibbon Sr., LLLP., located at 0 Sasser Road, Flowery Branch, Georgia 30542 and bearing Hall County Tax Parcel Number 15044 000040 (the "Subject Property"); and

WHEREAS, the annexation petition seeks to rezone the Subject Property from Hall County's designation of Planned Residential Development (PRD) to the City of Flowery Branch's designation of Single Family Attached Townhome (SF-TH); and

WHEREAS, the proposed annexation and rezoning of the Subject Property, constituting approximately 95.84± acres for the development of a 198-unit residential subdivision on the Subject Property, represents a substantially more intense and significantly different use of the property than allowed by Hall County's existing residential zoning of the property; and

WHEREAS, the proposed annexation, rezoning, and proposed use of the Subject Property as a 198-unit residential subdivision would cause a significant increase in the intensity of the allowable use of the Subject Property; and

WHEREAS, the proposed annexation, rezoning, and proposed use of the Subject Property as a 198-unit residential subdivision would cause a substantial deviation from the current low to moderate density of development in the immediate area; and

WHEREAS, the proposed annexation, rezoning, and proposed use of the Subject Property as a 198-unit residential subdivision would create a significant increase in demand on local infrastructure; and

WHEREAS, the Hall County Board of Commissioners has carefully reviewed the annexation and rezoning request, and the Board has determined that the annexation, rezoning, and proposed use of the Subject Property as a Single Family Attached Home subdivision is not in the best interest of the residents of Hall County; and

WHEREAS, the Official Code of Georgia Annotated provides a procedure for resolving annexation disputes under O.C.G.A. § 36-36-110 et seq.; and

WHEREAS, the Board of Commissioners wishes to avail itself of the remedies provided by the annexation dispute resolution process through its objection to this annexation and rezoning request;

NOW, THEREFORE, THE BOARD OF COMMISSIONERS OF HALL COUNTY DOES HEREBY OBJECT to the City of Flowery Branch's annexation and rezoning of Hall County Tax Parcel 15044 000040, as requested by the applicant, Tellus Holdings, LLC., and the property owner, S.P. McKibbon Sr., LLLP. This objection is based upon a material increase in burden on Hall County's infrastructure demands, an increase in density in the local area, and a significant deviation from the current use of the Subject Property directly related to the proposed change in zoning and land use.

Based upon the information presented in the application for annexation provided to Hall County, the County specifically objects to the proposed change in zoning and land use that would result from the annexation as follows:

The application for annexation of the Subject Property, approximately 95.84± acres, describes a rezoning from Hall County's Planned Residential Development (PRD) to the City of Flowery Branch's Single Family Attached Townhome (SF-TH) for the development of a 198-unit residential subdivision. Hall County attaches Flowery Branch's Notice of Intent to Annexation, the application for annexation and rezoning, and the supporting documents served upon Hall County. *See* Exhibit A. The Subject Property is bordered on the north by properties zoned as City of Flowery Branch, Institutional (INST) and City of Flowery Branch Agricultural (A); on the south by Hall County, Agricultural Residential 1 (AR-1); on the east by Hall County, Agricultural Residential 1 (AR-1); and on the west by Hall County, Agricultural Residential 1 (AR-1) and City of Flowery Branch, Highway Business (HB).

The proposed residential subdivision to be developed on the Subject Property would directly contrast the surrounding and existing uses permitted by Hall County. The County's existing PRD zoning of the property permits uses at a low density (2 units per acre), as shown in Section 6.1 of Hall County's Uniform Development Code, Appendix A of the Official Code of Hall County. *See* Exhibit B. The County's current recommended density for the Subject Property of two (2) units per acre would be increased by the proposed annexation and rezoning of the properties to the City of Flowery Branch's SF-TH district, which would allow a maximum of six (6) units per acre as shown in Section 6.5 and accompanying tables of Flowery Branch's Zoning Ordinance, Appendix C of the City's Code of Ordinances. *See* Exhibit C. Per the site plan provided by the applicant, Tellus Holdings, LLC., the proposed residential subdivision would feature a density average of 2.07 units per acre. The rise in density would result in substantially increased

traffic on local roads in the immediate vicinity of the Subject Property. The applicant has not proposed road improvements that would sufficiently ameliorate the increase in traffic volume and the related infrastructure costs associated with increased road congestion. Thus, the proposed change in zoning and land use contained in the application for annexation would create a material burden upon Hall County directly related to the proposed change in zoning and land use.

Finally, the proposed change in zoning and land use as described in the application for annexation of the Subject Property would result in a substantial increase in the intensity of the allowable uses of the property. An aerial photograph of the area immediately surrounding the proposed annexation shows that there are no high-density residential subdivisions near the Subject Property. *See Exhibit D.*

For the foregoing reasons, the members of the Board of Commissioners have executed this objection to the annexation petition of Tellus Holdings, LLC. and S.P. McKibbon Sr., LLLP., regarding Hall County Tax Parcel 15044 000040 this 6th day of April 2026.

ANALYSIS REQUIREMENTS REGARDING LAND USE APPLICATION

This statement is intended to comply with the application procedures established by the Zoning Ordinance of the City of Flowery Branch (the "Zoning Ordinance"), the City of Flowery Branch Rezoning Petition, and other City of Flowery Branch Ordinances and Standards. The Applicant incorporates all statements made in the Rezoning Petition for Public Hearing by the Applicant (the "Application") as its analysis requirements required by the City of Flowery Branch.

ANALYSIS REQUIREMENTS

- 1. Whether the proposal will permit a use that is suitable in view of the use and development of adjacent and nearby property.**

The Proposed Use is compatible with surrounding properties and represents a thoughtful transition between institutional/commercial uses to the north and large-lot residential (AR-1) properties to the east, south, and west.

The physical characteristics of the Subject Property make industrial or commercial development impracticable and inconsistent with the land itself. The site contains significant topographic variation, including pronounced ridgelines, valleys, and stream buffers. The proposed residential layout places development primarily along the natural ridges of the site while preserving substantial undisturbed open space, approximately 42.06 acres.

This development pattern is consistent with both the natural terrain and the surrounding uses. The proposal will positively affect the use and value of the surrounding institutional, commercial, and residential uses.

2. Whether the proposal will adversely affect the existing use or usability of adjacent or nearby property.

The Proposed Zoning and Proposed Use will not adversely affect the existing use or usability of adjacent or nearby property. The layout has been intentionally designed to preserve natural buffers along property boundaries and stream corridors. Residential lots back up to preserved open space and undisturbed areas, reducing visual and noise impacts on neighboring AR-1 properties. The development will be adequately landscaped and will comply with applicable stormwater, landscaping, noise, and lighting regulations. As such, the Proposed Zoning and Proposed Use will have no negative impact upon use or usability of adjacent or nearby property.

3. Whether the property to be affected by the proposal can be used in accordance with the existing regulations and has a reasonable economic use as currently zoned.

There is no reasonable use of the Subject Property under any other zoning classification than as requested by the Applicant and no resulting benefit to the public from designation to any other classification would accrue.

4. Whether the proposal will result in a use which will or could cause an excessive or burdensome use of existing streets, transportation facilities, utilities, or schools.

(A) Proposed Construction Phasing Schedule Projected Impact

Construction will occur over approximately 60 months. Upon issuance of Land Disturbance Permit, the Applicant anticipates the first section of the project to be developed within 12 months thereafter, and subsequent sections and houses to be constructed over the following 48 months based upon market demand.

The Applicant estimates there will be 2.86 occupants per unit. Assuming this to be the case, the Applicant expects the population of the new development to be as follows:

(B) Public Road System

Permanent access to the development will be provided from Sasser Road and via a private access easement from Falcon Parkway. The access connection from Falcon Parkway will remain private and will not be dedicated as public right-of-way. All internal public streets within the development are proposed to be dedicated to the City as public right-of-way, while individual driveways and other private access drives will be privately owned and maintained.

Traffic generated from the development will be in accordance with expected growth patterns and access to public thoroughfares will be at a location where sight distance is sufficient. All curb cuts shall be coordinated and approved by the Governing Jurisdiction and acceleration and deceleration lanes will be installed as required. All access drives within the development will be constructed to conform to applicable minimum standards. Parking will be provided onsite as required by the Governing Jurisdiction.

(C) County School System

The Table below estimates the number of school children expected to be generated by the project, based upon the ratio of the estimated number of school children in Hall County to the estimated number of households in Hall County, then multiplying the quotient by the number of residential units in the Proposed Use. This method produces a factor of 0.458 students per household.

The numbers above are a planning factor used to project total student population and plan the need for new school facilities. However, the actual number of students who live in the proposed development may be more or less than the factor above, because the method of calculation uses a total number of households countywide, with some households containing more than the average number of children and others comprised of zero children.

(D) City Water and Waste Water Systems

The community's water and sanitary sewer needs will be served by the City of Flowery Branch.

(E) Utilities

With regard to public utilities, sanitary sewer, water, natural gas, electricity, and cable are available to the Subject Property. The impact on public utilities is anticipated to be in keeping with projected plans and capacity is available to serve the proposed development.

(F) Environmental Impact

The project should also have a minimal impact on the environment. All applicable air quality standards will be met and drainage, soil erosion, and sedimentation controls will be utilized on the site after obtaining all required approvals from the Georgia Department of Natural Resources and Hall County.

The Concept Plan demonstrates that a substantial portion of the property will remain undisturbed open space (approximately 42.06 acres), with development concentrated on the more buildable ridge areas. This approach minimizes grading, preserves natural drainage patterns, and protects stream buffers.

The Applicant will submit plans detailing the development for approval by the Governing Jurisdiction and any other appropriate governmental agencies, based on conformity with subdivision and zoning requirements, as well as other applicable ordinances, statutes, and regulations.

5. Whether the proposal is in conformity with the policy and intent of the comprehensive plan including but not limited to the character area map and future land use plan map.

The Proposed Zoning and Proposed Use complies with the intent of the Comprehensive Plan and Future Development Map (the "Comprehensive Plan") by providing a complementary land use for nearby properties. The Subject Property is depicted in the Comprehensive Plan to be annexed into the City and located within the Industrial Employment Character Area. *See* Flowery Branch Comprehensive Plan, p. 38.

While the Subject Property is depicted within the Industrial Employment Character Area, the physical characteristics of the site and its adjacency to Suburban Residential areas support residential development as a more appropriate and context-sensitive use. The proposed development serves as a transition between commercial/institutional uses along Falcon Parkway and lower-density residential areas to the south and east.

The Subject Property adjoins other properties to be annexed into the City of Flowery Branch as Suburban Residential Character Area; thus, the Proposed Use would not be out of character for the area. *See* Flowery Branch Comprehensive Plan, p. 45.

6. Whether there are other existing or changing conditions affecting the use and development of the property which give supporting grounds for either approval or disapproval of the proposal.

The existing conditions affecting the use of the Subject Property give strong support for approval of the Proposed Zoning and Proposed Use. The Subject Property adjoins other properties zoned for a mixture

of institutional, commercial, and residential; thus, the Proposed Use would not be out of character for the area.

The Proposed Use is compatible with the surrounding properties because the surrounding properties are designated on the City's Comprehensive Plan for institutional, industrial, and suburban residential within the City. The adjacent properties to the north are zoned Institutional (INST) and Highway Business (HB) and are located within the City. The properties zoned INST are used as Storybrook Academy at Flowery Branch, Jason Law Enterprises, Hall County Fire Department and Martin Elementary School. The adjacent properties to the east are zoned AR-1 (County), to the south are zoned AR-1 (County), and to the west AR-1 (County). The Proposal to rezone the Subject Property to Proposed Zoning is therefore consistent with the adjacent and nearby uses that either already exist or are anticipated on the surrounding properties. This proposal will positively affect the use and value of the surrounding institutional, commercial, and residential uses.

7. **Existing value of the property under the existing zoning district classification, the extent to which the property value of the subject property is diminished by the existing zoning district, and the value of the property under the proposed zoning district; if such information is provided by the applicant or can be discerned. This consideration may include the length of time the property has been vacant or unused as currently zoned and efforts taken by the property owner(s) to use the property or sell the property under the existing zoning district classification.**

The Subject Property has remained vacant and undeveloped for many years despite the development of the surrounding properties for institutional, commercial, and residential uses. This is strong evidence that there is no reasonable use of the Subject Property under any other zoning classification than as requested by the Applicant and no resulting benefit to the public from designation to any other classification would accrue.

8. **Whether a proposed zoning map amendment or conditional use approval will be a deterrent to the value or improvement of development of adjacent property in accordance with existing regulations.**

The Proposed Zoning and Proposed Use will not adversely affect the existing use or usability of adjacent or nearby property. The development will be adequately landscaped and will comply with applicable stormwater, landscaping, noise, and lighting regulations. As such, the Proposed Zoning and Proposed Use will have no negative impact upon economic values in the surrounding area.

9. **The possible creation of an isolated zoning district unrelated to adjacent and nearby districts.**

The Proposed Zoning will not create an isolated zoning district. The property is bordered by institutional and commercial uses within the City and residential uses in unincorporated Hall County. The proposed residential development provides a logical and compatible land use transition between these districts.

10. Possible effects of the change in zoning district map, or change in use, on the character of a zoning district.

The Subject Property is not currently located within the City of Flowery Branch. The Subject Property is depicted in the Comprehensive Plan to be annexed into the City and located within the Industrial Employment Character Area. See Flowery Branch Comprehensive Plan, p. 38. The Subject Property adjoins other properties to be annexed into the City of Flowery Branch as Suburban Residential Character Area; thus, the Proposed Use would not be out of character for the area. See Flowery Branch Comprehensive Plan, p. 45. The Applicant intends to develop an enhanced product with upgraded architectural detailing, materials, and landscaping consistent with that direction. This commitment further supports compatibility with surrounding properties and the long-term character of the area.

11. The possible impact on the environment, including but not limited to, drainage, soil erosion and sedimentation, flooding, air quality and water quality.

The project should also have a minimal impact on the environment. All applicable air quality standards will be met and drainage, soil erosion, and sedimentation controls will be extensively utilized on the site after obtaining all required approvals from the Georgia Department of Natural Resources and Hall County.

The Concept Plan demonstrates that a substantial portion of the property will remain undisturbed open space (approximately 42.06 acres), with development concentrated on the more buildable ridge areas. This approach minimizes grading, preserves natural drainage patterns, and protects stream buffers.

Prior to any grading of the site, the developer will be required to submit a hydrology report and site development plan that detains any additional stormwater flow resulting from new impervious surface and will have to design and install stormwater infrastructure that (1) infiltrates the first 1-inch of rainfall into the ground, (2) detains stormwater so that it discharges at a rate no faster than the pre-development rate, and (3) satisfies State and local stormwater standards for water quality. The development will comply with those regulations. If downstream drainage issues directly connected to this property currently exist (prior to development), they should be improved by the stormwater infrastructure installations for this project.

The Applicant will submit plans detailing the development for approval by the Governing Jurisdiction and any other appropriate governmental agencies, based on conformity with subdivision and zoning requirements, as well as other applicable ordinances, statutes, and regulations.

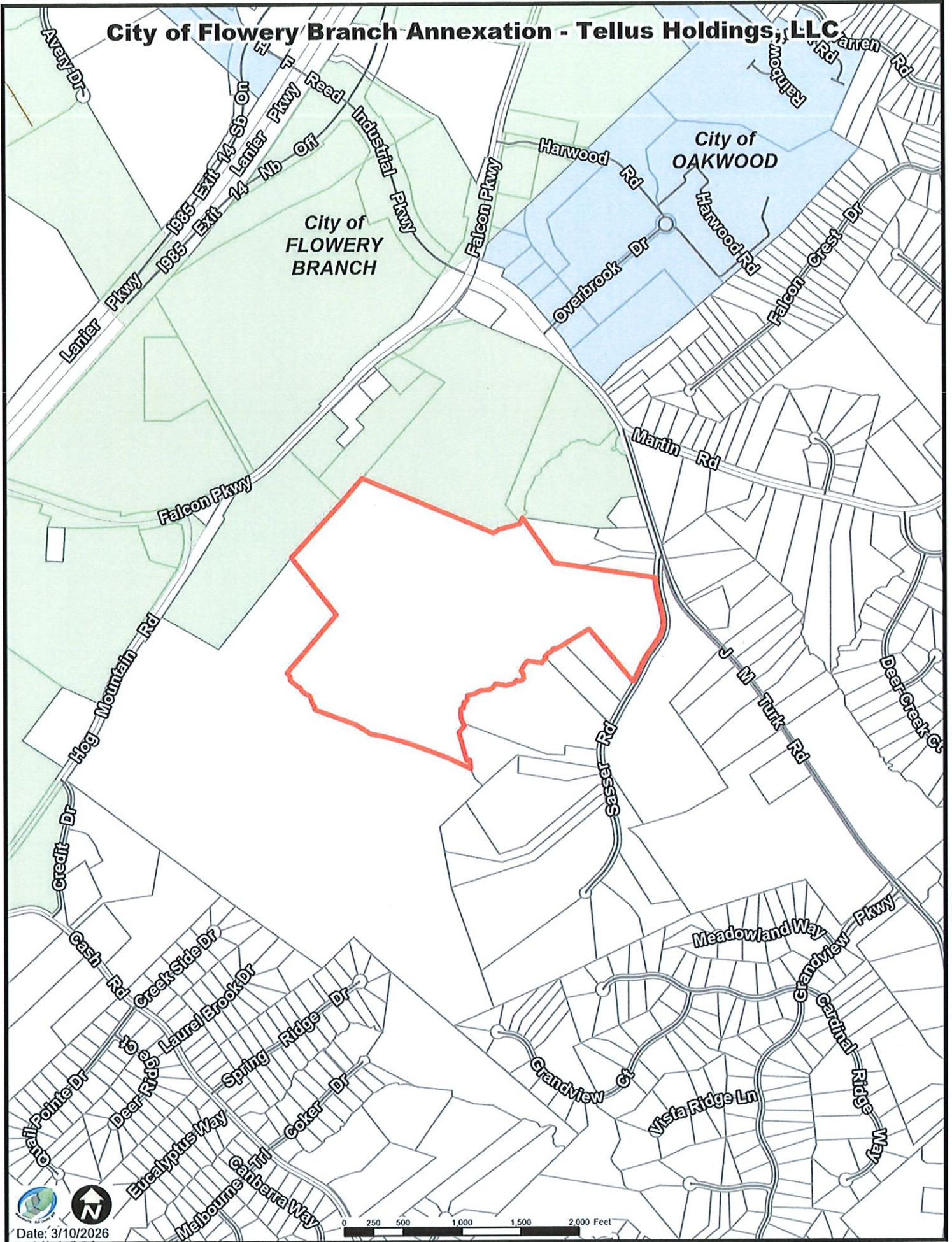
12. The relation that the proposed map amendment or conditional use bears to the purpose of the overall zoning scheme and the purposes of this Zoning Ordinance.

Sec. 6.1. - Planned Development Districts (PD)

6.1.1. Intent

- A. To permit for the development of property which:
 - 1. Allows for greater flexibility in development standards and site planning considerations;
 - 2. Is in the best interest of Hall County in terms of its long range development plans; and
 - 3. Encourages a mixture of uses which without proper design and planning might not be compatible with surrounding uses or zoning districts.
- B. Planned development districts are to be utilized as a "floating zone" and will be individually evaluated for designation. These districts are separate zoning districts and follow the same amendment procedures as other districts. Unless otherwise stated in this section, the development standards and the land uses which are presented with the application for amendment will become the standards for the subject property.

6.1.2. Requirements for Rezoning

- A. An area may be considered for rezoning to a planned development district if any one of the following conditions exist:
 - 1. More than one land use is proposed for development on a single parcel;
 - 2. Separate land uses which would not otherwise be permitted to locate within the same zoning district are proposed for development on one or more adjacent parcels under single or separate ownership;
 - 3. Exception or variation from the size, setback, frontage, density, uses or other standards which are required in the other conventional zoning districts are being proposed as part of a comprehensive development plan.
- B. All proposed planned development district applications must adhere to the following specific requirements:
 - 1. The site proposed for a planned development must contain an area of at least five acres. In no case may the minimum tract size be less than the minimum lot area requirements for the comparable conventional district as specified for each planned development classification in this section. The comparable conventional zoning districts listed in the regulations are R-1 for a PRD, O-I for a POD, S-S for a PCD and I-1 for a PID.
 - 2. The site must have frontage along a public street for a distance of at least 100 feet.
 - 3. A suitable plan must be prepared for the development, and this plan must include the following elements where applicable:
 - a.

A plan drawn to scale by a registered engineer, architect, land surveyor or landscape architect showing the exact dimensions of the parcel or parcels of land under consideration and including the following information:

- i. A conceptual site plan drawn to scale and indicating all property dimensions, platting and street systems, proposed building sites, sizes, types of use proposed for buildings, plans for protection of abutting properties, means of ingress and egress, access and circulation arrangements, off-street parking and loading facilities, proposed reservations or dedications for streets and other public facilities and, if requested, a contour map of the site.
 - ii. The name of the developers and of the development (if any).
 - iii. A north arrow and scale.
 - iv. If the proposal includes the subdivision of land for any purpose or for the provision of new public streets, a proposed lot and street layout must be submitted as part of the application. Any proposed variation from the standards set forth in the subdivision regulations must be listed and explained. If the plan is approved, a preliminary plat and final plat must be submitted as provided by the subdivision regulations of Article 9.
- b. A written report must also be submitted which explains the type, nature, size, intent and characteristics of the proposed development. This report must include, where applicable:
- i. A general description of the proposed development and its location.
 - ii. The proposed standards for development, including restrictions on the use of the property, density standards, yard (setback) requirements and any proposed restrictive covenants.
 - iii. An explanation of why the proposed development standards are necessary if the above proposed standards vary from existing standards in the zoning regulations.
 - iv. Plans for the provision of utilities, including water, sewer and drainage facilities.
 - v. Plans and methods for protection of adjacent properties.
 - vi. Data stating the total number of square feet proposed for each type of land use, including public facilities, within the proposed development.
 - vii. Additional relevant data as may be required by the County.
4. A proposed development schedule and listing of all proposed uses must be submitted as a part of an application for a planned development district.

6.1.3. Administrative Procedures

A.

Any request pertaining to the establishment of a planned development district will be administered and processed in accordance with the regulations set forth in Sec. 11.2.

- B. All data, plans and specifications presented as part of the planned development district application will, if approved, be the standards of development for that particular planned development, but only to the extent that they do not conflict with the provisions of this UDC. To the extent that they conflict with this UDC all data, plans, and specifications become the standards of development for that particular planned development only if they are set forth as a specific condition of zoning or approved as a zoning variance.
- C. To the extent that the approved standards are consistent with this UDC, set forth as specific conditions, or approved as a zoning variance, all further development on the property must conform to the standards adopted for the district regardless of any change in ownership. Any proposed changes to those standards must be considered in accordance with the procedures set forth in Sec. 11.2. Appeals based upon hardship or an alleged misinterpretation of the ordinance or this UDC by the building official will be processed in accordance with procedures set forth in Sec. 11.2. In no case may the approved land uses be appealed.
- D. The violation of any provision of the planned development standards as submitted and approved under the provisions of this UDC will constitute a violation of these regulations.

6.1.4. Application Procedures

- A. Any application for a planned development district must be submitted to the Board of Commissioners through the Director of Planning and Zoning or other designated staff member.
- B. **General Requirements**
 - 1. All applications for zoning of property to a planned development district must conform to all requirements of Sec. 11.2 except as may otherwise be required by this section. All applications that do not comply with the requirements of Sec. 11.2 will be returned to the applicant unfiled with notice of the deficiency or deficiencies.
 - 2. No application to rezone property to a planned development district may be accepted until after a pre-application meeting is held between the applicant, appropriate staff of the Office of Planning and Development, appropriate staff of the Office of Public Works and Utilities, and any other applicable local or state agencies. Once a pre-application meeting is requested by the applicant, staff must schedule the meeting within ten business days. Failure to meet this timeline by staff would negate the pre-application meeting requirement.

6.1.5. District Classifications

- A.

The following are classified as planned development districts subject to the provisions of this article and to the standards for each district:

1. PRD: Planned Residential Development.
2. POD: Planned Office Development.
3. PCD: Planned Commercial Development.
4. PID: Planned Industrial Development.

6.1.6. District Standards

A. Planned Residential Development (PRD)

1. **Intent.** A planned residential development is designed to allow for a more flexible placement, arrangement, and orientation of residential structures, the accompanying flexibility in the subdivision of land, and the grouping of open space and accessory facilities such as garages and parking. It may also provide for a mixture of housing types such as single-family, two-family, multi-family, townhomes, cottage court, and live-work according to a carefully designed plan. The proposed residential development should make maximum use of natural features and, through proper site planning measures, should conform to the existing character and development pattern of the surrounding area. Every effort should be made to preserve and protect any existing residential uses from adverse impacts which might result from a higher density development.

Application Requirements. All the general and special requirements in Secs. 6.1.2 and 6.1.3 for planned developments must be provided. The following special items must be addressed:

- a. The site plan must indicate the proposed size, location, number of units and number of bedrooms of all residential structures.
 - b. All streets and common open spaces not proposed for dedication to the county must have the proposed maintenance and ownership agreements explained in detail.
 - c. The architectural style and proposed siting of all multi-family structures or attached single-family structures must be indicated. Architectural standards for all planned residential developments are as indicated in Sec. 6.1.6.A.8.
 - d. The development controls for the development must be detailed, including lot coverage, setbacks, building heights, and lot sizes.
 - e. Planned developments of at least 5 acres in size may include commercial uses within the development, limited to neighborhood retail intended to serve the needs of the residents of the development unless otherwise specifically approved by the Board of Commissioners. Retail uses must be specified as part of the proposal and are limited to no more than 10,000 square feet of floor area for the entire development site.
3. **Dimensional Standards.** See Table 6.1.1 for district standards and Sec. 2.1 (Measurements and Exceptions) for additional requirements.
4. **Buffers.** A buffer at least 50 feet in width must be established along the perimeter of all property boundaries adjacent to residential and nonresidential districts to ensure that the planned residential development is appropriately screened. Buffers must meet the standards of Sec. 8.2.4.
5. **Landscaping.** In addition to the tree protection requirements of Sec. 8.3, the following standards apply in planned residential developments:
- a. At least two trees per lot must be provided. Trees may be located in the front, side, or rear yard.
 - i. These trees may not be counted towards the developments tree density unit requirement.
 - ii. Trees located within any utility easement, drainage easement, or septic drain field may not count towards the per lot tree requirement.
 - b. The developer is responsible for planting or preserving the individual lot trees prior to issuance of a certificate of occupancy.
6. **Access.** In addition to the requirements of Article 9 (Subdivisions) the following standards apply in all planned residential developments:
- a.

Any PRD with 150 or more lots must include at least two vehicular entrances with access to a city, state, or county maintained public right-of-way. The second entrance must be completed prior to the platting of 150 lots or more.

- b. Any PRD with 400 or more lots must include at least three vehicular entrances with access to a city, state, or county maintained public right-of-way.
 - i. The county may waive the requirement for immediate construction of a third entrance based on the development schedule and phasing plan.
 - c. In addition to the requirements of Sec. 8.4 and any applicable provisions of Article 9, sidewalks must be installed on both sides of any proposed street.
7. **Open Space.** Open space is required in all PRD districts as follows:
- a. Open space must comprise at least 30% of the gross lot area.
 - b. All other standards of Sec. 4.8.7 apply.
8. **Architectural Standards.** The following architectural standards apply to all PRD districts:
- a. **Building materials.** All facades of residential structures and any permitted nonresidential structures must be finished with brick, stone, stucco, wood siding, wood shake, or cementitious siding. Vinyl siding is not permitted.
 - i. The front facade must incorporate a variety in building material, texture or color.
 - b. **Garages.** Garages for single-family detached and two-family structures on lots less than one acre in size must meet one of the following standards.
 - i. **Flush.** Garage doors are oriented towards the street. Garage doors may be positioned flush with the front wall plane of the residence, extending no more than 55 percent of the width of the residence.
 - ii. **Semi-flush.** Garage doors are oriented towards the street. Garage doors may be positioned within 10 feet of flush with the front wall plane of the residence in either direction, extending no more than 55 percent of the width of the residence.
 - iii. **Recessed.** Garage doors are oriented towards the street. Garage doors must be positioned at least 10 feet behind the front wall plane of the residence, extending no more than 55 percent of the width of the residence.
 - iv. **Side-loaded.** Garage doors are oriented perpendicular to the front wall plane of the residence. Any wall of the garage must be located at least 3 feet behind the front wall plane of the residence.
 - v. **Carriage court.** Garage doors are oriented perpendicular to the front wall plane. All garage walls are located entirely in front of the front wall plane of the residence.
 - vi. **Detached.** The garage is placed entirely to the rear of the residence.

- c. **Townhouses.** For townhouses garage placement must meet the following standards. Townhouses fronting an arterial or collector street must be rear loaded. Townhouses fronting a minor street may be rear-loaded or front-loaded.
- i. **Rear-loaded.** The garage must be placed entirely to the rear of the townhouse and may be attached or detached. Garage doors must face a rear right-of-way or easement. For detached garages, the garage must be either located 4 feet from the rear right-of-way or easement, or be a minimum of 20 feet from the rear right-of-way or easement.
 - ii. **Front-loaded.** A minimum of 20 feet is required between the garage and the back of sidewalk.
9. **Footing Inspections.** At the time of the footing inspection, the contractor must provide the county building official with a certificate from a licensed surveyor certifying building setbacks for all corners of the structure being inspected.
10. **Cluster Mailbox Unit (CBU).** Pursuant to United States Postal Service Policy, all new subdivisions and new phases of existing subdivisions are required to provide CBU's for regular mail service delivery. A CBU is a structure or shelter housing multiple mailbox units to serve each residential dwelling of the development for the express purpose of regular mail delivery provided by the USPS. The following standards are for construction and maintenance of CBU's for all planned residential developments.
- a. The developer is responsible for confirming the logistics of regular mail delivery to CBU's with the USPS. As such, all CBU's are subject to final approval by the USPS.
 - b. **Maintenance.** The county will not assume any responsibility for the maintenance and repairs of CBU's and associated parking areas. The CBU's and associated parking areas are to be maintained by the homeowners' association, managing entity, or collectively by the property owners.
 - c. **Location.** CBU's must be located on their own lot or in an area dedicated for open space or on a public access easement obtained by the developer. The entrance to the proposed vehicular parking area must be located at least 200 feet from the main entrance and at least 60 feet from any street intersection.
 - d. **Parking.** The minimum parking ratios established on Table 6.1.2. must be met for all CBU's:

- e. **Property Management.** A person owning or having possession or control of any property within a PRD must meet the following property management standards in addition to any conditions of approval placed upon the development as detailed in Sec. 6.1.3:
- i. Any damaged, dead, diseased or decaying plant materials must be removed and replaced if visible from the public right-of-way.
 - ii. Premises occupied by a residential dwelling must be maintained free from grass, similar vegetation or uncultivated vegetation in excess of 12 inches in height.
 - iii. Fences facing a street or adjacent public right-of-way must be regularly maintained, repaired, and replaced if considered necessary by the building official.

B. Planned Office Development (POD)

1. A Planned Office Development is designed to contain orderly, well-designed office and institutional uses upon a site that results in minimum impact upon the surrounding area. The site plans and building designs should produce a development that can be constructed to achieve maximum utilization of space while maintaining a low-intensity office character protected from more intensive commercial and industrial development and protecting any nearby residential uses.
2. Planned Office Developments may also include a limited number of residential and commercial uses.

3. All the general and special requirements in Secs. 6.1.2 and 6.1.3 for planned developments must be provided. The following special items should also be addressed:
 - a. The site plan must indicate the proposed size, location, and number of stories in each office building.
 - b. The development controls for the district must be detailed, including lot coverage, setbacks, building heights, and lot sizes. If standards are not specifically proposed, then the applicable standards in the Office Institutional (O-I) districts in Sec. 5.1, including screening and buffer requirements, apply.
 - c. If residential uses are proposed in conjunction with the planned office development, then the applicable requirements of the planned residential development district or planned commercial development district must be provided.

C. Planned Commercial Development (PCD)

1. A Planned Commercial Development is designed to provide for the maximum attainable commercial usage of property while employing the best aspects of site planning and development controls to insure:
 - a. Protection of surrounding residential uses;
 - b. Safe access by motorists;
 - c. Minimum traffic congestion; and
 - d. A development which is consistent with long-range plans of the county.
2. A limited number of carefully planned residential uses may also be included in a Planned Commercial Development.
3. All the general and special requirements in Secs. 6.1.2 and 6.1.3 for planned developments must be provided. The following specific items must also be addressed:
 - a. A site plan indicating the proposed site preparation and grading, streets and parking areas, loading zones, storm drainage, water, gas and sewage systems, and all buffer areas.
 - b. The development controls for the district must be detailed, including lot coverage, setbacks, building heights, and lot sizes. If standards are not specifically proposed, then the applicable standards in the Suburban Shopping (S-S) district in Sec. 5.2, including screening and buffer requirements, apply.

D. Planned Industrial Development (PID)

1. A Planned Industrial Development is designed to consist of land which has been designated for a planned, organized and controlled industrial use or for multiple but compatible industrial uses in a planned industrial park. The standards must be designed

to encourage the formation and continuance of a compatible environment for the planned industrial uses and the surrounding land uses.

2. Carefully planned office and commercial uses may be incorporated as part of a Planned Industrial Development.
3. All of the general and special requirements for planned developments in Secs. 6.1.2 and 6.1.3 must be provided. The following specific items must also be addressed:
 - a. A site plan indicating the proposed site preparation and grading, streets and parking areas, loading zones, outdoor storage areas, rail facilities, storm drainage, water, gas and sewage systems and all buffer areas.
 - b. The development controls for the district must be detailed, including lot coverage, setbacks, building heights, and lot sizes. If standards are not specifically proposed, then the applicable standards in the Light Industrial (I-1) district in Sec. 5.5, including screening and buffer requirements, apply.
 - c. If office or commercial uses are proposed in conjunction with the Planned Industrial Development, then the applicable requirements in the POD or PCD district must be provided.

6.1.7. Other Standards

See Article 2 (Rules Common to All Districts) and Article 7 (Use Provisions) and Article 8 (Site Development) for additional standards which may be applicable.

Sec. 6.5. - SF-TH, Single-Family Attached Townhome District.

- (a) *Purpose and Description.* This zoning district is intended exclusively for the development and construction of single-family attached townhomes in accordance with the comprehensive plan. This district is also intended to implement the "urban density community" character area established in the comprehensive plan. The regulations that apply to the SF-TH district are designed to encourage the formation and continuance of a stable, healthy, and attractive living environment for its residents.
- (b) *Permitted and Conditional Uses.* Permitted and conditional uses shall be as provided in Table 6.1, "Permitted and Conditional Uses in Agricultural and Conventional Residential Zoning Districts."
- (c) *Dimensional Requirements.* Dimensional requirements shall be as provided in Table 6.2, "Dimensional Requirements in Agricultural and Conventional Residential Zoning Districts."
- (d) *Design Requirements.* See Articles 10, 12, and 40 of this Zoning Ordinance.

History:

On February 23, 2026, Hall County received notice from the City of Flowery Branch of the proposed annexation of two parcels into the City for development of a 75-unit single-family detached dwelling subdivision. The properties are currently zoned AR-1 and R-1, and Flowery Branch proposes to rezone the properties to Single-Family Attached Townhome (SF-TH).

Facts and Issues:

The properties consist of approximately 19.398 acres located on Hog Mountain Road. The City of Flowery Branch seeks to annex and rezone the properties to the City's Single-Family Attached Townhome (SF-TH) district. The properties are presently zoned for agricultural and residential uses, and the surrounding area consists primarily of single-family residential uses.

WHEREAS, Hall County has received a notice of filing with the City of Flowery Branch of a petition of annexation of the properties of CD, II Properties, LLC located at 4651 Hog Mountain Road, Flowery Branch, GA 30542 and 4665 Hog Mountain Road, Flowery Branch, GA 30542, and bearing Hall County Tax Parcel Numbers 15046 000008 and 15046 000008B, respectively, (the "Subject Properties"); and

WHEREAS, the annexation petition seeks to rezone the Subject Properties from Hall County's designation of Agricultural-Residential 1 (AR-1) and Residential 1 (R-1) to the City of Flowery Branch's designation of Single-Family Attached Townhome (SF-TH); and

WHEREAS, the proposed annexation and rezoning of the Subject Properties, constituting approximately 19.398± acres, for the development of a seventy-five (75) single-family residential lots on the Subject Properties, represents a substantially more intense and significantly different use of the properties than allowed by Hall County's existing agricultural and residential zoning of the properties; and

WHEREAS, the proposed annexation, rezoning, and proposed use of the Subject Properties as a single-family detached development would cause a substantial increase in the intensity of the allowable use of the Subject Properties; and

WHEREAS, the proposed annexation, rezoning, and proposed use of the Subject Properties as a single-family detached development would cause a substantial deviation from the current low to moderate density of development in the immediate area; and

WHEREAS, the proposed annexation, rezoning, and proposed use of the Subject Properties as a single-family detached subdivision would create a significant increase in the demand on local infrastructure; and

WHEREAS, the Hall County Board of Commissioners has carefully reviewed the annexation and rezoning request, and the Board has determined that annexation, rezoning, and the proposed use of the Subject Properties as a single-family residential community is not in the best interest of the residents of Hall County; and

WHEREAS, the Official Code of Georgia Annotated provides a procedure for resolving annexation disputes under O.C.G.A. § 36-36-110 et seq.; and

WHEREAS, the Board of Commissioners wishes to avail itself of the remedies provided by the annexation dispute resolution process through its objection to this annexation and rezoning request;

NOW, THEREFORE, THE BOARD OF COMMISSIONERS OF HALL COUNTY DOES HEREBY OBJECT to the City of Flowery Branch's annexation and rezoning of Hall County Tax Parcels 15046 000008 and 15046 000008B, as requested by the applicant, Highpoint Development, and the properties' owner, CD, II Properties, LLC. This objection is based upon a material increase in burden on Hall County's infrastructure demands, an increase in density in the local area, and a substantial deviation from the current use of the Subject Properties directly related to the proposed change in zoning and land use.

Based upon the information presented in the application for annexation provided to Hall County, the County specifically objects to the proposed change in zoning and land use that would result from the annexation as follows:

The application for annexation of the Subject Properties, approximately 19.398± acres, describes a rezoning from Hall County's Agricultural-Residential 1 (AR-1) and Residential 1 (R-1) districts to the City of Flowery Branch's Single-Family Townhome (SF-TH) district for the development of a seventy-five (75) single-family residential lots. Hall County attaches Flowery Branch's Notification of Intent to Annex and Rezone, the annexation application, and the supporting documents served upon Hall County. *See Exhibit A.* The Subject Properties are bordered on the north by Hall County's R-1 and Highway Business (H-B) districts; on the south by Hall County's R-1 and Planned Residential Development (PRD) zoning and by The City of Flowery Branch's H-B district; on the east by Hall County's AR-1, R-1, and PRD districts; and on the west by Hall County's R-1 and PRD districts and the City of Flowery Branch's H-B district.

The proposed single-family detached subdivision to be developed on the Subject Properties would directly contrast with the surrounding and existing uses permitted by Hall County. The County's existing AR-1 and R-1 zoning of the properties permits detached single-family dwelling units for agricultural or residential uses at a low density (approximately 1 to 1.2 units per acre), as shown in Sections 3.2 and 4.3 of Hall County's Uniform Development Code, Appendix A of the Official Code of Hall County. *See Exhibit B.* The County's current recommended density for the Subject Properties of 1 to 1.2 dwelling units per acre would be drastically increased by the proposed annexation and rezoning of the properties to the City of Flowery Branch's SF-TH district, which would allow a maximum of six (6) units per acre as shown in Section 6.5 and accompanying tables of Flowery Branch's Zoning Ordinance, Appendix C of the City's Code of

Ordinances. *See* Exhibit C. Per the site plan provided by the applicant, Highpoint Development, the proposed single-family residential community would feature a density average of 3.8 units per acre. Construction of the proposed development, therefore, would be out of character with the Subject Properties' immediate neighbors and would interfere with the existing landowners' quiet enjoyment of their properties through overcrowding and by upsetting their expectation of a lower density usage in the area. Further, the rise in density would result in substantially increased traffic on local roads in the immediate vicinity of the Subject Properties. The applicant has not proposed any road improvements that would sufficiently ameliorate the increase in traffic volume and the related infrastructure costs associated with increased road congestion. Thus, the proposed change in zoning and land use contained in the application for annexation would create a large material increase in burden upon Hall County directly related to the proposed change in zoning and land use.

Additionally, the proposed change in zoning and land use as described in the application for annexation of the Subject Properties would result in a substantial increase in the intensity of the allowable uses of the properties as well as a change to significantly different allowable uses. An aerial photograph of the area immediately surrounding the proposed annexation shows that there are no high-density residential subdivisions near the Subject Properties. *See* Exhibit D. A review of the City of Flowery Branch's zoning ordinance for SF-TH shows more permitted uses with a higher density than that allowed by Hall County's current zoning of the Subject Properties. These alternative uses provide for more intense uses of the Subject Properties than intended by Hall County and would allow for significantly different uses of the properties than currently allowed; moreover, there is nothing to prevent the Subject Properties from being converted to these other uses in the future following its annexation and rezoning.

For the foregoing reasons, the members of the Board of Commissioners have executed this objection to the annexation petition of Highpoint Development, and CD, II Properties, LLC, regarding Hall County Tax Parcels 15046 000008 and 15046 000008B this 6th day of April, 2026.

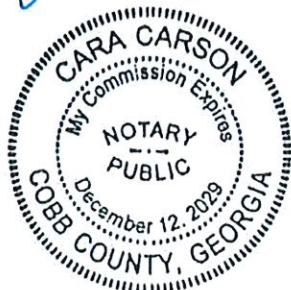

Summary

The accompanying application seeks annexation and zoning district change from AR-I in Hall County to SFTH in Flowery Branch for a 19.398-acre tract, consisting of Parcel #'s 15046 000008 & 15046 000008B. The property appears to have been vacant for a number of years. The location is on Hog Mountain Road in south Hall approximately 1300 LF north of Spout Springs Road. The intent is to develop up to 75 units of quality housing (single-family) along with an extensive amount of undeveloped natural area. At least 15% of the site will be maintained as open space. Although not specifically identified, the property is located adjacent to the "Retail Activity Center" Character Area of the 2041 Comprehensive Plan. We believe this property could serve as a transitional use from the retail area to south and the lower density subdivisions to the north and east.

Site Description

The property has approximately 640 LF of frontage along Hog Mountain Road, rectangular and approximately 1,500 LF deep. The site is undeveloped with several dilapidated out buildings and contains a mix of trees and vegetation. A jurisdictional stream (Lott Creek) is located near the rear of the property and appears to be a tributary of Mulberry Creek. Domestic water (24") is provided by the City of Gainesville and is located on the northwest side of Hog Mountain Road. Flowery Branch will provide sanitary Sewer through a new, on-site pump station and force main to nearby gravity lines located within the Stonebridge Village retail center. All other dry utilities are located within a reasonable distance for service extensions.

Adjacencies

The property is surrounded by Hall County residential zonings, AR-III, PRD and R-1 and a small HB property on the west side of Hog Mountain Road. Adjacent Flowery Branch zoning is HB.

Access

Access to the property is proposed from a driveway on Hog Mountain Road approximately 1,800 LF north of Spout Springs Road. The nearest cross street is Cash Road, located approximately 900 LF northeast of the property.

Proximity to Other Uses

- Nearest distance to undeveloped commercial property – parcel #15046 000151-zoned HB located adjacent to southwestern boundary.
- Nearest distance to developed commercial property – parcel #08096 000014 zoned H-B, directly across at 4650 Hog Mountain Road.

- Nearest distance to a single-family home – a single-family home at 4641 Hog Mountain Road is located within 40' of the northeastern boundary.
- Nearest distance to a subdivision – Hunters Landing S/D is located 0.6 miles away.

Comprehensive Plan Consistency

Since the subject property is currently located in unincorporated Hall County, the Flowery Branch Comprehensive Plan does not specifically identify the future land use for this property. With Retail/Commercial uses directly to the south of the subject property and lower density residential uses to the north, it would be reasonable to assume that the subject property could provide a transitional use and density between the uses identified. Although this specific property is not included in the Comprehensive Plan Future Development Map, it does lie adjacent to the “Activity Center – Retail” character area. It is our opinion that the slightly higher densities offered under the SFTH zoning district, and the specific use for attached single-family homes, would be applicable for this property.

Traffic Impact Study

A Traffic Impact Study has been requested by the City and included for review. The following recommendations were made:

- One entering lane and one exiting lane
- Stop sign controlled on the driveway approach with Hog Mountain Rd remaining free flow
- A right turn lane for entering traffic
- A left turn lane in for entering traffic accounting for the intersection in front of the Chic-fil-A along Spout Springs Rd

Development Strategy

The Concept Plan includes traditional front entry single family homes. The architectural style of the homes will be influenced by the mountain bungalow style to feel more rooted in the community and within the SFTH design intent. The single-family homes located along the Hog Mountain Road frontage will be facing interior to the development and we will have elevated facades on the rear of these homes to provide a grand appearance along Hog Mountain Rd. We will provide a desirable streetscape for the project’s entrance including a professionally landscaped monument sign. The single-family homes will all have front-loaded garages. The community will have amenities including walking trails, a creek bridge crossing, and a centralized amenity area including a community gathering pavilion, firepit communal area with chairs and a common area green space.

Architectural Materials & Site Improvements

Single-family homes will follow the requirements of Section 12.6.i at a minimum with a general design theme that would include:

- Two-car garages
- Front facades with a combination of masonry and hardi-plank siding materials
- Side & Rear facades with hardi-plank siding, glazing & trim
- Architectural weight shingles
- Sodded yards (4 sides)
- One tree per lot (minimum 2 ½” caliper)
- Variance Requested –
 - Minimum Road Radius Variance – Request for minimum at 48’ with stop signed intersections past the first horizontal curve
 - Removal of Street Deviation Variance – Street deviation distance to be eliminated w/ concessions

- Minimum Lot Size Variance – Minimum lot size to be reduced
 - Overall average lot size of 6,700sf or greater (code minimum is 6,700sf /lot)
 - Minimum lot width – 40ft or greater (code minimum is 40ft)
 - Minimum lot area – 5,500sf
 - Total of 25% of lots will be between 5,500sf and 6,000sf
 - The remaining 75% of lots will exceed 6,000sf
 - Total average of all lots will be 6,700sf or above

Entrance Monumentation

The entrance may include the items listed below

- Masonry walls
- Wood or PVC fencing
- Illuminated Signage in accordance with the Flowery Branch Sign Ordinance
- Ornamental Sculpture
- Landscaping & Irrigation

Amenities

The community amenities, at a minimum, will contain the following items:

- Centralized amenity area w/
 - Community gathering pavilion
 - Communal firepit with seating
 - Common area greenspace
 - Central mail kiosk provided subject to USPS review/approval
- Walking Trails
 - Will include fence along rear of Lots 30-33 within stream buffer
 - Signage stating “TRAIL HEAD – No Land Disturbing Activities Allowed”
- Creek Crossing

Signage

The Developer and/or Builder shall be allowed to post permanent directional signs and monuments within the Community to direct traffic to sales and recreation centers and to identify differing residential areas. All permanent internal signage must be outside of any Right of Way or Utility Easement with a Landscape and Signage easement recorded on the Final Plat.

Temporary Sales and Marketing signs not exceeding 32 square feet per sign face and 8 feet in height may be used along Hog Mountain Road.

Model Home Permits

Applicant requests that up to twelve (12) model home permits be issued prior to Final Plat recording provided that hard surface (crusher run) access is provided and fire protection (functioning hydrant) is located within 500 feet of any structure under construction. However, no certificate of occupancy permits (CO) will be issued prior to final plat recording.

Sales and Construction Trailers

Applicant is requesting permission to install one sales trailer and one construction trailer with associated parking areas in locations to be determined at the time of street paving and possible ahead of final plat approval.

Homeowner's Association

A Homeowner's Association will be created in order to administer the covenants, conditions and restrictions that will be placed on the property by the Developer. The HOA will manage the overall management of the property including maintenance, architectural controls and financial management.

HOA Language requested by the City to be included in HOA Formation Documents as stated below:

- The development shall be fee-simple homes for sale and the homeowner's association covenants must contain the following provisions:
 - No more than ten percent (10%) of the total homes may be leased
 - No more than two houses may be owned by one owner in the development and the owner or the owner's immediate family member must reside at one of the two homes
 - A homeowner may apply to the board of directors of the HOA for a "hardship" exception to exceed the 10% lease limit in the event the homeowner can demonstrate the need to lease their home due to extenuating circumstances. A lease permitted under the "hardship" exception shall not exceed one year, after which the owner must reapply for an exception. The granting of hardship exceptions shall be at the discretion of the HOA board of directors.

Annexation

Hall County has given verbal confirmation they would approve the annexation into Flowery Branch assuming the adjacent parcels are not attempting to annex at the same time.

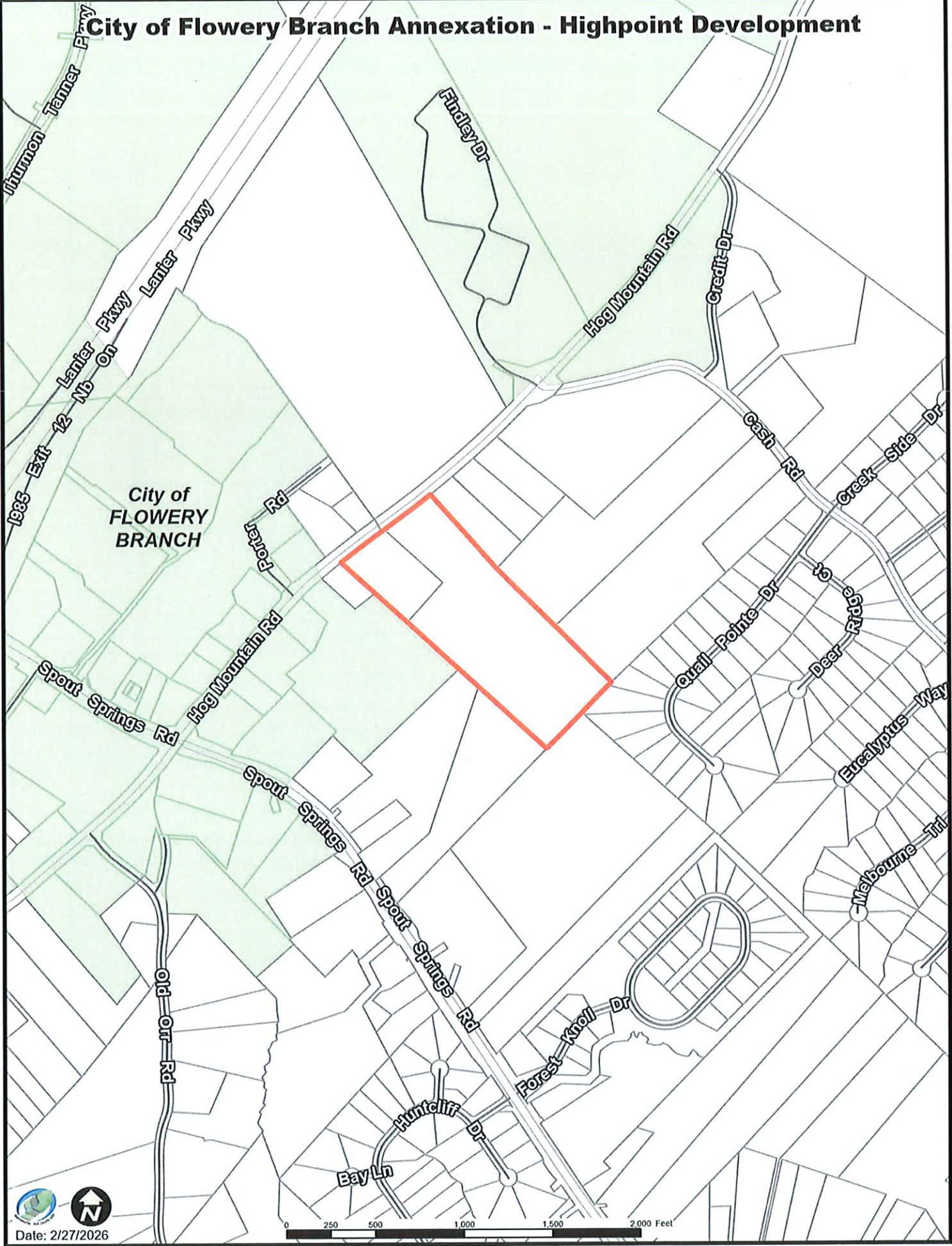
The development of the community shall be controlled by the Conceptual Master Plan (the "Plan") attached as exhibit "A". The plan is considered conceptual in nature, and as such may require minor modifications during the engineering and development process. Modifications to the locations and arrangement of lots, roads, amenities, and other improvements that do not conflict with specific standards and requirements of these conditions may be made by the Developer, so long as such modifications do not change the land use, increase the overall density of the project or reduce any established exterior buffers or setbacks.

Sec. 6.5. - SF-TH, Single-Family Attached Townhome District.

- (a) *Purpose and Description.* This zoning district is intended exclusively for the development and construction of single-family attached townhomes in accordance with the comprehensive plan. This district is also intended to implement the "urban density community" character area established in the comprehensive plan. The regulations that apply to the SF-TH district are designed to encourage the formation and continuance of a stable, healthy, and attractive living environment for its residents.
- (b) *Permitted and Conditional Uses.* Permitted and conditional uses shall be as provided in Table 6.1, "Permitted and Conditional Uses in Agricultural and Conventional Residential Zoning Districts."
- (c) *Dimensional Requirements.* Dimensional requirements shall be as provided in Table 6.2, "Dimensional Requirements in Agricultural and Conventional Residential Zoning Districts."
- (d) *Design Requirements.* See Articles 10, 12, and 40 of this Zoning Ordinance.
