No Smoking Policy and Agreement

Due to the increased risk of fire, increased costs for maintenance, and the possible health effects of secondary smoke, Ballard Village (Landlord) is adopting the following No-Smoking policy, which covers all or part of the property located at 10137 Lapeer Road, Davison, Michigan. The following terms, conditions and rules are hereby incorporated into the Rental Agreement.

1. PROPERTY SUBJECT TO NO-SMOKING POLICY

Resident acknowledges that Landlord's ability to police, monitor or enforce this Addendum is dependent in significant par on voluntary compliance by and Residents' guests or visitors. Residents with respiratory ailments, allergies or other conditions relating to smoke are put on notice that Landlord does not assume any higher duty of care to enforce this addendum than any other Landlord obligation under the rental agreement.

6. EFFECT OF BREACH

Resident understands and agrees with the conditions of this Addendum and that failure to adhere to any of the conditions of this Addendum will constitute both a material noncompliance with rental agreement and serious violation of the Rental Agreement. In addition, Resident will be responsible for all costs to remove smoke odor or residue upon any violation of this Addendum.
